Re: Freedom of Information Act Appeal - File Number 20210319

Dear Mr. Greenewald:

I am writing in response to your Freedom of Information Act (FOIA) appeal regarding the above referenced file.


In your FOIA request, you sought Secret Service records containing "all documents relating to the request by former President Donald Trump to have the U.S. Secret Service to offer protection for his four adult children, and two of their spouses, ... to include communication from the White House or President Trump; internal communications with the USSS regarding this request; along with all other related letters, e-mails, memos, reports, etc." In response, the agency's FOIA office searched for responsive records and provided eleven pages of redacted documents.

On appeal, you disputed the sufficiency of the FOIA office's search, particularly as it related to email attachments. We note that you did not appeal the withholdings on the eleven pages released to you by the agency's FOIA office. To address your appeal, the agency conducted an additional search, and thirty-eight pages of additional responsive documents were located. Thirty-one of these pages are being released with this letter and seven pages of this material are being withheld in full.

While the agency is releasing portions of these responsive records, certain information contained in these records is being withheld pursuant to applicable FOIA disclosure exemptions. In particular, information is being withheld from the records pursuant to FOIA exemptions (b)(6) and (b)(7)(C) as information contained in law enforcement records the disclosure of which could constitute an unwarranted invasion of personal privacy. Information is also being withheld under FOIA exemption (b)(7)(E) as information contained in law enforcement records that, if disclosed, could reveal techniques and procedures for law enforcement investigations and risk circumvention of the law. Finally, information is being withheld under FOIA exemption (b)(5) as information that would not be available by law to a party in litigation with the agency (e.g., information that would be protected from disclosure during discovery in a civil suit).

I am required to advise you that this decision is subject to judicial review in federal court. This review may occur where the complainant resides or has a principal place of business, where the agency records are situated, or in the District of Columbia.

Planning Assumptions: Former Trump Detail

Residence Assumptions...

1. (b) (7)(E) will reside primarily at their Trump Tower residence in New York City once they leave office
- OR
2. (b) (7)(E) will reside primarily in their residence in Mar-a-Lago, FL once they leave office

Other Assumptions...

- (b) (7)(E) will travel at a rate higher than other former Presidents and former First Ladies
- Protection will be continued for (b) (7)(E) until the age of 16 or beyond
- Protection for (b) (7)(E) will require deploying protective resources similar to other former Presidents (with the addition of two residences)

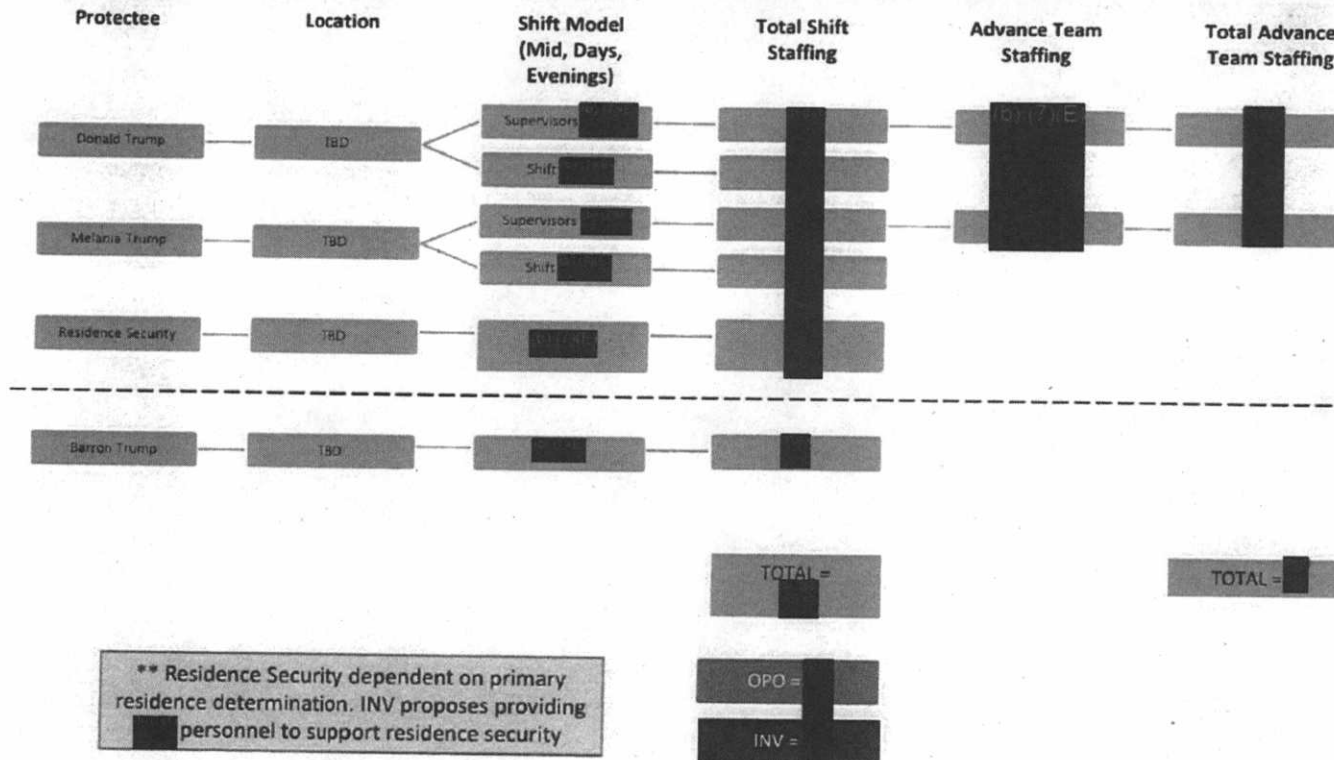

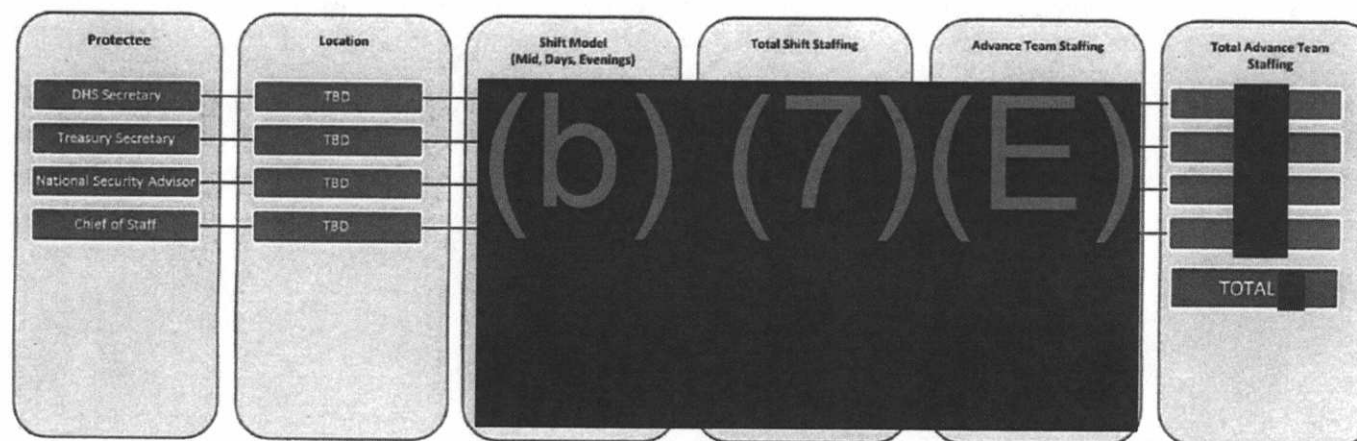
