This is the final response to your Freedom of Information Act (FOIA) request, originally received by the United States Secret Service (Secret Service) on January 21, 2021, for information pertaining to all documents relating to the request by former President Donald Trump to have the U.S. Secret Service to offer protection for his four adult children, and two of their spouses, to include communication from the White House or President Trump; internal communications within the USSS regarding this request; along with all other related letters, e-mails, memos, reports, etc.

After a detailed review of all potentially responsive records, 11 page(s) were released and 0 page(s) were withheld in their entirety. Exemptions under the FOIA Statute, Title 5 U.S.C. § 552 have been applied where deemed appropriate.

Enclosed are the documents responsive to your request, as well as a document that explains the exemptions in more detail. Withheld information is pursuant to the exemptions marked below.



We are not extending on 14 Trump Family members outside of what's covered by law under 3056 (FPOTUS, FFLOTUS, and Baron); instead we are only extending on 6 Trump family members (Don Jr, Ivanka/Jared, Eric/Laura, and Tiffany).

The USSS will be fully dropping coverage on the grandchildren effective this Friday morning.
