Dear Mr. Greenewald:

Reference is made to your letter received on September 22, 2017, by the United States Secret Service (Secret Service) appealing the determination of Special Agent in Charge Kim Campbell, Secret Service Freedom of Information and Privacy Acts Officer, regarding the above referenced file.

The records pertinent to your request have been reviewed. Based on this review, it has been determined that an additional 102 pages of responsive documents may be released to you. A copy of these pages are enclosed. Some information continues to be withheld, however, under the Freedom of Information Act.

The records in question contain information compiled for law enforcement purposes. Pursuant to Title 5, United States Code, sections 552 (b)(6) and (b)(7)(C), certain information is being withheld as information the disclosure of which could reasonably be expected to constitute an unwarranted invasion of privacy. Additionally, some records are being withheld under section (b)(7)(E) since the disclosure of this information could disclose techniques and procedures for law enforcement investigations or disclose guidelines for law enforcement investigations or prosecutions which could risk circumvention of the law.

Information is also being withheld pursuant to Title 5, United States Code section 552 (b)(5) as interagency material that would not be available to a party other than an agency in litigation with the Secret Service.

Under federal law we are required to advise you that any decision on appeal is subject to judicial review in the District Court where the complainant resides, has a principal place of business, or in which the agency records are situated, or in the District of Columbia
