Therefore, if you should desire at a later date to change the status or use of this individual, a request for approval to cover any proposed change should be submitted to this office.

5. This approval becomes invalid in the event the Subject's services are not utilized within six months of the date of this memorandum.



His Navy record stated that this drinking problem adversely affected his judgment, reliability, and personal behavior. This weakness had been discussed to no avail with Subject on several occasions. It should be noted that domestic inquiries developed no indication of over-indulgence since his departure from the military on October 1964.
