1. CONSULATE WILL BE REPORTING ON VIA STATE CHANNELS ON VISIT TO CONSULATE 27 FEB OF RICHARD CASE NAGELL, AKA JOE CRAMER, JOE CRANE, ROBERT C. NOLAN 201-746537. HE WAREAD INTERVIEWING CONSUL THAT UNLESS PROMISES MADE TO HIM BY US OFFICIALS WERE HONORED HE WOULD REVEAL TO THE PRESS ENTIRE STORY OF HIS ALLEGED CONTACTS WITH WOFIRM AND WOULD EXPOSE INDIVIDUALS WITH WHOM HE HAD DEALT IN THE ORGANIZATION.

2. UNLESS ADVISED TO CONTRARY [BASE] WILL, AS IT HAS IN THE PAST, LEAVE THIS MATTER STRICTLY TO CONSULATE. [BERN] PLEASE ADVISE LNER GO.

3. MOST RECENT STATE MESSAGE WAS US MISSION BERLIN 2567 OF 26 OCTOBER 68.
