1. AFTER TELLING US OF INTENT, AMWHIP I TELEPHONED (RAFAEL AGUILLERA BATISTA) AT EMBASSY 9 JULY 63. SAID HE WANTED GIVE HIM WATCH TO BE FORWARDED TO JOSE VENEGAS VALDESPINO. STATED NATURE HIS BUSINESS ROME AND NAMED LOCATION OF STORE. ADDED HAD BEEN IN BARC WITH VENEGAS. MADE APPOINTMENT WITH (AGUILLERA) 06
2. ALL ABOVE PICKED UP BY (DEVIGIL) ON (LAPOGO) AMWHIP USED NO NAME BUT (DEVIGIL) NOW CHCKING AND WILL UNDOUBTEDLY IDENTIFY ON BASIS OF STORE.
3. AMWHIP I NOT TOLD NOT TO USE PHONE IN ORDER PROTECT (LAPOGO)
4. REALIZE AMWHIP I KUBARK ASSET OF LONG STANDING PER REF. BUT RECOMMEND HE BE SURFACED AS OURS TO (DEVIGIL) ASAP FOR FOLL REASONS:
  - A. IF WE DELAY AND THEN IDENTIFY, DELAY WILL BE OBVIOUS ON BASIS DATE OUR RECEIPT ABOVE ITEY.
  - B. IF DO NOT IDENTIFY AND DURING AUGUST OR LATER VISITS HERE AMWHIP I PRODUCES USEFUL INFO ON WHICH (DEVIGIL) BEST EQUIPPED TO ACT, WE SHALL LACK BASIS FOR RELAYING INFO TO THEM.

C. (DEVIGIL) HAVE NO SIGNIFICANT NATIONAL INTEREST IN TARGET, WOULD PROBABLY ACCEPT OUR DECLARATION OF ASSET WITHOUT INSTITUTING SURVEILLANCE OR RELATED ACTION.

D. (AGUILLERA)<sup>06</sup> APPROACH TYPIFIES PROBLEM. WE HAVE PUSHED (DEVIGIL)<sup>01</sup> HARD TO LAY GROUNDWORK FOR HIS RECRUITMENT AS MEANS GETTING AT LAURICLE. NUMBER OF SIGNIFICANT PBRUMEN TARGETS SOME TOO SMALL TO PERMIT US HOPE AMWHIP 1 CAN DO USEFUL WORK AND CONTINUE ESCAPE (DEVIGIL)<sup>01</sup> ATTENTION. CAN WAIT UNTIL THEY SURFACE HIM TO US AND PRETEND RECRUIT AS QP THAT DATE BUT MANEUVER IS COMPLICATED AND GAIN IS SLIGHT.
