2. ANALYSIS OF REF AND PREVIOUS TRAFFIC ON ~~SECRET~~ UNsuccessful EFFORTS  
 CONTACT ~~SECRET~~ CUBAN TARGET SEEMS TO INDICATE THAT ~~SECRET~~ AND FILED ALBERTO  
 HERNANDEZ PEREZ NOT CONVINCED OF ~~SECRET~~ BONA FIDES. WITH ROQUE DALEON GARCIA UNDER  
 ASSET, ~~SECRET~~ CUBAN TARGET VERY LIKELY SUSPICIOUS THAT ~~SECRET~~ REALLY (SALVADORAN SECURITY) TYPE
