NOTE: At request of Department we are conducting investigation in captioned matter which includes allegation that Nino Diaz, anti-Castro leader, has formed new anti-Castro organization, the ELC, the purpose of which is to equip a force of some 200 to 300 men to infiltrate Cuba and bring about the overthrow of Castro. Raul Pelegrina is furnishing information to our San Juan office in this matter and has previously contacted CIA concerning it.

(U) (S) The CIA memo 1/19/67 reports information CIA received from [Pelegrina] which deals with the progress being made by the group in San Juan and indicating that the Consuls of Haiti, Costa Rica, and Paraguay in Puerto Rico are attending meetings of this group and are allegedly supporting it possibly with material support.

(U) CIA told [Pelegrina] to furnish this data to San Juan Office.

[Pelegrina] indicated he had been in touch with our San Juan Office. (U) (S)
