According to the above files, no member of the CCS ever met with Meier. A CIA employee was introduced to and had discussions with Meier prior to his departure for ~~Onto~~. There is no evidence or indications when or whether Meier was made witting of the CIA employee's CIA status. The basis of the CIA employee's statement to Mr. Ed Mullin of Intertel " that Mr. Meier had been witting of the CIA employee's CIA affiliation " (Tab F) cannot be established from CCS files.

2. Attached hereto are copies of 6 memoranda (Tabs A-F) pertaining to Mr. Meier. It is recommended that both the CIA employee who is now assigned to the ~~Scandinavian Desk of~~ EUR Division, and the CIA employee , who is again under contract to WH Division, be queried further in regard to Mr. Meier's knowledge of the CIA employee's CIA status.
