**MEMORANDUM FOR: Chairman, Sub-Committee on Cuban
Subversion in Latin America**

SUBJECT: Dissemination of Air Travel Information

1. For several months now CIA has been disseminating in Washington to all of the normal recipients of telegraphic disseminations, reports received by telegram from Mexico City containing the passenger lists of Cubana flights between Mexico City and Havana. This information is simultaneously made available to CIA stations in the countries concerned and to our Panama Station for dissemination to CINCSO.

2. The question has been raised within CIA as to whether the widespread dissemination of this information in Washington in TDCS form is really necessary. I would appreciate it if you would furnish copies of this memorandum to each member of the Committee with the request that they determine the need for these lists within their respective agencies and be prepared to discuss this problem at our next meeting.
