This is in response to your Freedom of Information Act (FOIA) request, dated 28 February 2019, for information pertaining to FOIA Case Log for calendar year 2018, FOIA Appeals Log for calendar year 2018, and Mandatory Declassification Review Log for calendar year 2018, which has been assigned tracking number 2019-02307-F.

Portions of the information requested are exempt from disclosure under the FOIA. We have indicated the proper exemptions, described below, in the attached document(s).

a. Exemption (b)(6) permits the withholding of all information about individuals in "personnel and medical files and similar files" when the disclosure of such information "would constitute a clearly unwarranted invasion of personal privacy."


b. Exemption (b)(7)(C) provides protection for personal information in law enforcement records the disclosure of which "could reasonably be expected to constitute an unwarranted invasion of personal privacy."
