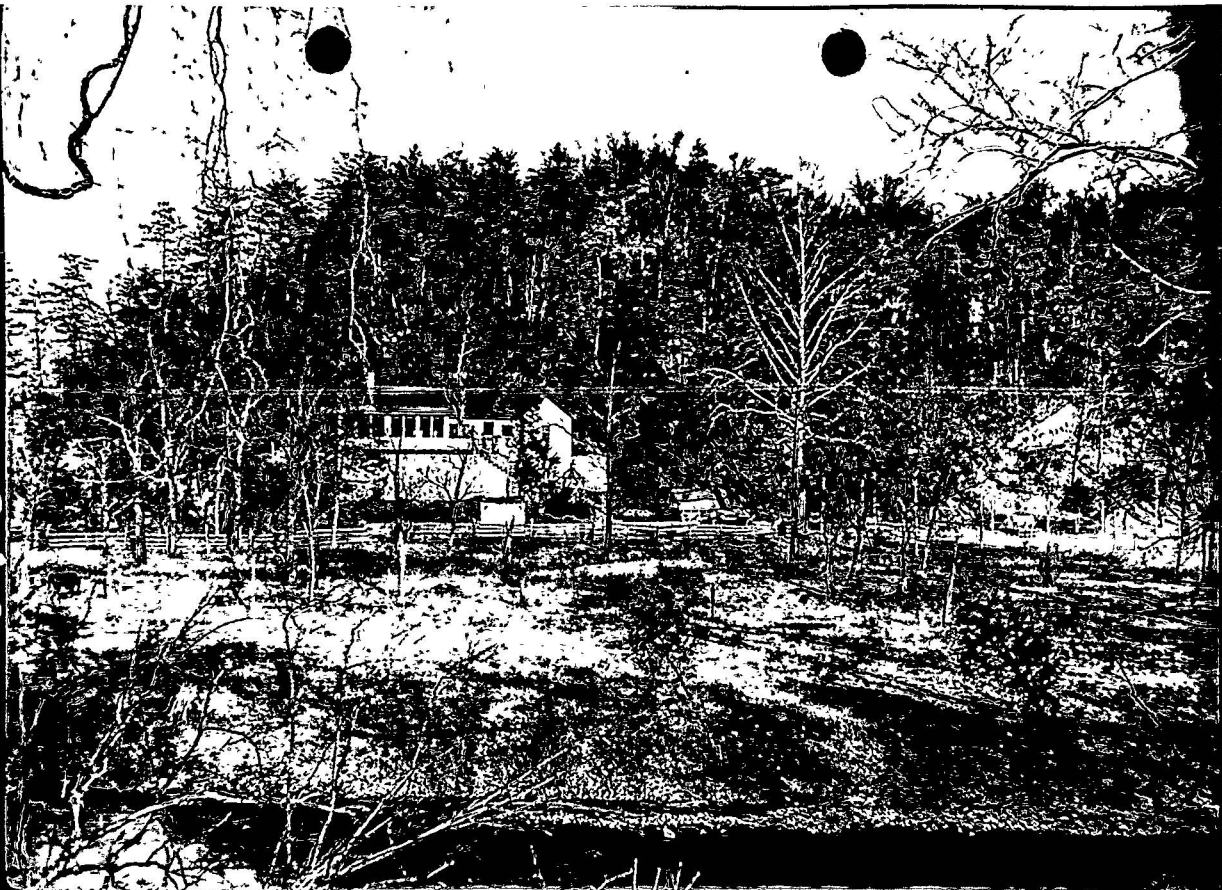


SCENE AT CAPON, INTERMONT, W. VA. SHOWING CHARLES LEE AIKIN CUTTING TREE.

identified himself as President of the Cather Motors, 214 East Piccadilly Street, Winchester, Virginia, permitted Special Agent VAN ETTEN, Mr. AIKIN and the writer to inspect his apartment, a one bedroom unit with a living-room, kitchen and bath. After an examination of this apartment it was determined that negative 545 had been made in the bedroom of this home. It was observed that the door depicted in negative 545 was a closet door and it was also noted that the hinge pin shown extended out of the hinge was in the same condition and further it was noted that the floor grain in this apartment is consistent with that depicted by negative 545. A photograph of this section of the room was made with the permission of Mrs. CATHER and copies of this photograph are being forwarded to the Bureau and to the New York Office as enclosures with this report. The negatives of this photograph are being retained in the files of the Washington Field Office.

Negatives 545 through 568 were exhibited to Mrs. CHARLES LEE AIKIN, 208 East Boscawen Street, Winchester, Virginia, and she advised that the rug appearing in the photograph made from negative 545 was exactly like the one formerly owned by her. She also stated that the dog in this photograph appeared identical with a dog named JANIE formerly owned by her and her husband. Mrs. AIKIN could not be located at the time Apartment 12, 138 North Washington Street, Winchester, Virginia, was inspected by her husband and consequently was unable to recall the scene shown in this photograph. She stated, however, that the shoes which can be seen in the closet of photograph 545 appear to be ones she had in 1937 and which are still in her possession. Mrs. AIKIN was unable to fix the date for this photograph but said it undoubtedly was taken by Mr. SHEPARD during Thanksgiving or Christmas holidays of 1937. She explained that the only time that Mr. SHEPARD and his wife, LOUISE, visited with them was during the school holidays.

Mrs. AIKIN identified the photographs made from negatives 546 through 553 and 563, 564, 567 and 568 and recognized the scenes and individuals depicted in these photographs. She was, however, unable to fix the date that these pictures had been made advising that she had not been present when they were made.

Mrs. AIKIN advised that she had met Mrs. TALLEY briefly when visiting with LOUISE SHEPARD in Washington, D. C. during the late 1930's. She knew that Mrs. TALLEY and Mrs. SHEPARD had been employed together in the D. C. Public Library System but had no additional information concerning Mrs. TALLEY. She said that to the best of her knowledge she had never visited Mrs. TALLEY's home at 3415 Volta Place, N.W., Washington, D. C.

Mr. CHARLES WELPLEY, Route 2, Vienna, Virginia, an architectural Engineer with the Army and Air Force Motion Picture Service, Department of National Defense, Room 400 Tower Building, 14th at K Streets, N.W., Washington, D. C., advised that he has been an intimate social acquaintance of ERNEST and LOUISE SHEPARD since 1922, having attended the Central High School in Washington, D. C., with LOUISE SHEPARD and then George Washington University with ERNEST SHEPARD. Mr. WELPLEY identified the photographs made from negatives 546 and 547 as scenes at ERNEST SHEPARD's Falls Church home. He could not,

however, identify the individuals in these scenes. He identified the photograph made from negative 550 as his daughter, JANET, who is presently residing at 2693 Shasta Road, Berkeley, California, and is a senior at the University of California at Berkeley. He also identified the photograph bearing negative number 551 as depicting himself, his daughter, JANET, and the coat of his sister, MABLE WOODBURY, and stated that both scenes depicted by photographs 550 and 551 were made in the apartment occupied by ERNEST SHEPARD, 3267 N Street, N.W. Mr. WELFLEY explained that during these late 1930's his sister, who presently resides in Apartment 602, 330 East 43rd Street, N.W., was a frequent visitor at his home in Washington, D. C. Mr. WELFLEY could not, however, fix the exact date that photographs 550 and 551 were made but said that to the best of his recollection they were taken during the late fall of 1937. Mr. WELFLEY based this statement on the fact that he had in his possession three positive enlargements made from negative 550 which bore the notation 37-550 on the reverse side of each enlargement. He advised that this notation had been placed on these prints by Mr. SHEPARD and that he understood that this notation indicated that the picture had been made in 1937 from Mr. SHEPARD's negative numbered 550. Mr. WELFLEY was requested to retain the enlargements bearing the notation 37-550 which are now in his possession.

He also identified negatives 552 and 553 as picturing LOUISE SHEPARD and Mrs. TALLEY. He could not, however, identify the scene or the date that this picture was made. He also identified photographs made from negatives 554 through 560 as scenes taken from the windows in Mr. SHEPARD's apartment at 3267 N Street, N.W. He advised that after Mr. SHEPARD moved from this apartment to his present home, 203 Lawton, Falls Church, Virginia, during the spring of 1938, he, Mr. WELFLEY, moved into this apartment which had been previously occupied by the SHEPARDs. He also identified photographs made from negatives 561 and 562 as scenes showing Mr. SHEPARD's apartment at 3267 N Street, N.W. He identified photograph bearing negative number 563 as EMILY KREUTTNER and LOUISE SHEPARD. He explained that Mrs. KREUTTNER is the sister of Mrs. SHEPARD. He also identified photographs made from negatives 564 through 568 but he could not fix the date that any of these photographs were made.

Miss CHARLOTTE CLARK, Librarian, Georgetown Public Library, Wisconsin at R Street, N.W., and residence Wyoming Apartments, 2022 Columbia Road, N.W., advised that she has been acquainted with Mrs. GLADYS TALLEY and Mrs. LOUISE SHEPARD since 1925 having met them when all were employed in the D. C. Public Library System. Since 1925 Miss CLARK said that she has maintained close contact with both Mrs. TALLEY and Mrs. SHEPARD. Photographs made from negatives 545 through 568 were exhibited to Miss CLARK but she was unable to fix the exact date that any of these negatives had been exposed. She identified photographs numbered 546 and 547 as scenes at Mr. SHEPARD's Falls Church, Virginia, home, and 548 as a picture showing Mr. OTHAL V. TALLEY, LOUISE SHEPARD and herself taken in Mr. SHEPARD's yard at his Falls Church home. She said that photograph 548 depicts her and Mrs. SHEPARD planting crocuses in the yard. She said that this photograph was evidently made during the late fall season as she had her winter coat on and after viewing other photographs

fixed the year as 1937, the year that Mrs. TALLEY resigned from the library and moved to Philadelphia. She identified photograph 549 as her dog, BARNEY, who died in 1945 when nine or ten years old. She also said that BARNEY also appears in the scene depicted in photograph numbered 553 which also shows LOUISE SHEPARD. At this point Miss CLARK recalled that on the Sunday that Mrs. TALLEY had come to Washington from Philadelphia to exhibit her home in an effort to rent it, which was in the late fall of 1937, Mrs. TALLEY had kept BARNEY with her at 3415 Volta Place, N.W. throughout the day. She recalled that she was painting the windowsills in her apartment on this day and consequently did not want BARNEY in the house as he would track up the wet paint. She could not recall when arrangements were made with Mrs. TALLEY to take BARNEY but pointed out that apparently on the day preceding the Sunday that Mrs. TALLEY exhibited her home she and the TALLEYS were with Mr. and Mrs. SHEPARD at Mr. SHEPARD's Falls Church home. She could not, however, specifically recall Mrs. TALLEY being present at Mr. SHEPARD's home but surmised that the arrangements were made on that day. Miss CLARK also recalled that on the Sunday night that Mrs. TALLEY completed exhibiting her home, she, Mrs. TALLEY, came to her home in tears saying that BARNEY had run away and could not be found. She said that at this time Mrs. TALLEY offered to stay and aid in the location of BARNEY, but Miss CLARK said that she knew that Mrs. TALLEY had planned to return to Philadelphia that evening and consequently she instructed Mrs. TALLEY to return to Philadelphia. She stated that shortly after Mrs. TALLEY told her of BARNEY's disappearance BARNEY came back to her apartment by himself.

Miss CLARK could not identify photographs numbered 554 through 560, but did identify photographs made from negatives 561 through 568 and identified the individuals appearing therein. She was, however, unable to fix the date that any of these photographs were made.

To substantiate her statement that Mrs. TALLEY had moved to Philadelphia in 1937, Miss CLARK said that it was her opinion that Mrs. TALLEY had continued to be employed in the Public Library System in Washington, D. C., until a short time before moving to Philadelphia.

EMPLOYMENT OF GLADYS FLANAGAN TALLEY
BY THE PUBLIC LIBRARY SYSTEM, WASHINGTON, D. C.

In an effort to determine the exact date that O. V. TALLEY was transferred to Philadelphia, the records of the Public Library System were examined to ascertain the date that Mrs. TALLEY terminated her employment with the Library inasmuch as this would tend to indicate the date that the TALLEYS were transferred or received notice of transfer.

Miss HELEN L. CAVANAGH, Administrative Assistant to HARRY N. PETERSON, Librarian, Public Library, Washington, D. C., 499 Pennsylvania Avenue, Washington, D. C., made available the file pertaining to the employment of Mrs. TALLEY. This file disclosed that Mrs. TALLEY as GLADYS FLANAGAN was appointed to the library on June 1, 1917, and continued to be employed by the library until Sep-

tember 12, 1931, when she resigned. These records indicated that Miss FLANAGAN was reappointed Children's Librarian in the Public Library System on January 16, 1932, and continued to be employed in this capacity until October 23, 1937, when she again resigned. These records reflected that in June, 1936, Miss FLANAGAN officially changed her name to Mrs. O. V. TALLEY.

Miss CAVANAGH explained that there were no leave records available to show whether or not Mrs. TALLEY had actually worked until October 23, 1937, or had ceased actual work prior to that date and remained in a leave status until October 23, 1937. No other pertinent data was noted in this file and did not contain any formal resignation or any reason for Mrs. TALLEY's resignation.

Miss CAVANAGH advised that if the personnel file of Mrs. TALLEY was needed for use in court it could be obtained by directing a subpoena to Librarian HARRY N. PETERSON, Public Library, 499 Pennsylvania Avenue, N.W., Washington, D. C.

Mr. CHARLES WELPLEY, Route 2, Vienna, Virginia, has advised that the reason that his sister, Mrs. MABLE WOODBURY, visited with him frequently during 1937 was because his sister was undergoing a difficult and trying period as her husband, A. A. WOODBURY, who resides with his sister in New York City, was drinking heavily at this time. He advised that if his sister were questioned discretely concerning this she may be able to recall the specific instant which brought her to Washington and thus might be able to positively place the date that photographs made from negatives 550 and 551 were exposed.

Will exhibit photographs made from negatives 563 through 573 and 616, 617 and 621 through 624 to Mr. and Mrs. JOSEPH KREUTTNER and ascertain the dates that these exposures were made.

Will ascertain if the KREUTTNERs have copies of positive prints made from these negatives and determine if any notations showing the date have been placed on such prints.

Will attempt to fix as definitely as possible the date that the KREUTTNERs arrived in Washington for the Christmas holidays of 1937 and the length of their stay. (It is to be noted that negatives 563 through 573 show the KREUTTNERs in the SHEPARD apartment at 3267 N Street, N.W., Washington, D. C., and negatives 574 through 615 show scenes at Capon, West Virginia, but negatives 616 and 617 and 621 through 624 are scenes in and outside the SHEPARDs' apartment in Washington, D. C. This would indicate that either the KREUTTNERs remained at the SHEPARD apartment in Washington while Mr. and Mrs. SHEPARD visited Capon or were at the SHEPARD apartment on two separate occasions during the Christmas holidays of 1937.)

Will determine the whereabouts of the KREUTTNERs during the period that the SHEPARDs were at Capon, West Virginia, during the Christmas holidays.

Will attempt to identify the owner of the suitcase as shown in photographs 564 and 565 which were made from negatives bearing the same number.

Will interview Mrs. MABLE WOODBURY, Apartment 602, 330 East 43rd Street, New York City, and exhibit to her photographs numbered 550 and 551 in an effort to identify the dates such exposures were made. (It will be noted that Mr. CHARLES WELPLEY, brother of Mrs. WOODBURY and shown in photograph 551, has identified the coat appearing in the right portion of this photograph as belonging to Mrs. WOODBURY.)

Will ascertain if Mrs. WOODBURY has any positive prints made from negatives 550 and 551 or any of the enlargements of photograph numbered 550 which were made by Mr. SHEPARD and some of which are in the possession of Mr. CHARLES WELPLEY.

Will ascertain if she can identify the marionette held by JANET WELFLEY in photograph numbered 550 and 551 or knows how and when JANET came into possession of this marionette.

Will reinterview Mrs. GLADYS FLANAGAN TALLEY and her husband, OTHAL V. TALLEY, 4615 Lindel and exhibit photographs made from negatives 545 through 568 and ascertain if they can recall the date that ERNEST SHEPARD made negative exposure 546 through 549, some of which show Mr. TALLEY, Mrs. SHEPARD and Miss CHARLOTTE CLARK at Mr. SHEPARD's home in Falls Church, Virginia.

Will ascertain if these negatives were made the day preceding the Sunday that Mrs. TALLEY exhibited the home at 3415 Volta Place, which has been fixed as December 5, 1937.

Will also determine if the dog identified as BARNEY and owned by Miss CHARLOTTE CLARK, which appears in photograph numbered 549, is identical with the dog shown in 553.

Will endeavor to verify through Mrs. TALLEY the statement set out in this report by Miss CLARK that BARNEY was at the TALLEY home, 3415 Volta Place, N.W., through December 5, 1937, the day Mrs. TALLEY exhibited the house.

Will also verify Miss CLARK's statement that BARNEY ran away from 3415 Volta Place, N.W., and returned to Miss CLARK's home, 2020 Columbia Road, N.W., Washington, D. C.

Will ascertain when Miss CLARK and Mrs. TALLEY made the arrangements whereby Mrs. TAKKEY cared for BARNEY at 3415 Volta Place, N.W., on December 5, 1937.

Will endeavor to determine if these arrangements were made the same day that negatives 547, 548 and 549 were exposed at Professor E. S. SHEPARD's home in Falls Church, Virginia.

Will determine if Mr. and Mrs. TALLEY returned to Philadelphia the evening of December 5, 1937, after having exhibited their Volta Place home on that date.

Will secure as best as the TALLEYS can recall a complete itinerary of their travel during the week end which included December 5, 1937, ascertaining the date they left Philadelphia, the date they arrived in Washington, D. C., and where they stayed in Washington

during this week end. (Miss CHARLOTTE CLARK has advised that it was not uncommon for Mr. and Mrs. TALLEY to spend nights when visiting Washington from Philadelphia with friends and no exclusively with Mrs. TALLEY's mother, KATHLEEN FLANAGAN, who maintained an apartment at 2100 18th Street, N. W.)

Will also endeavor to ascertain if the newspapers on which Mrs. TALLEY and Mrs. SHEPARD are sitting as depicted in photographs numbered 552 and 553 were current newspapers purchased the day she spent at the Volta Place house. (Efforts to identify such papers have been unsuccessful to date.)

Will determine how J. H. B. GILLIAT, Washington, D. C. Realtor, contacted her when he presented the HISSES as prospective tenants. Ascertain if Mrs. TALLEY was in Philadelphia or in Washington when contacted.

Will determine again if GILLIAT ever contacted her concerning any other prospective tenants who were interested in the rental of 3415 Volta Place during the fall of 1937.

Will also exhibit photographs showing the newspaper advertisements for the Volta Place House to Mrs. TALLEY in order to establish if the advertisement inserted in the Star October 17, 1937 indicates if this approximates the date that she and her mother first decided to rent their Volta Place Home.

Will ascertain if the advertisement appearing in the Washington, D. C. Sunday Post on December 5, 1937 was the only advertisement wherein she specifically listed the residence as 3415 Volta Place, N. W. and was the only Sunday that she exhibited the home.

Will determine who actually placed the advertisements appearing in the Star October 17, 26, 27 and 28, 1937 and the Washington Post December 5, 1937.

Will determine if she can recall whether or not any other advertisements in addition to those set out in this report were placed with Washington newspapers in an effort to rent their Volta Place home.

Will also determine when GLADYS TALLEY actually ceased working in the Public Library at Washington, D. C. noting that officially her resignation was effective October 23, 1937; but she may have actually ceased work prior to that date. (Purpose is to attempt to determine the date it was decided to rent the Volta Place house.)

Will exhibit negatives 529 through 617 and 621 through 624 to Mr. and Mrs. CHARLES LEE AIKIN, 208 West Boscawen Road to establish that photographs made from negatives numbered 531 through 545 were made during the Thanksgiving holidays, 1937.

Will also identify the unknown individuals appearing in these photographs and attempt to further identify the scenes depicted by these photographs which have been partially described by Mr. E. S. SHEPARD.

At Falls Church, Virginia

Will interview LOUISE SHEPARD, 203 Lawton and endeavor to ascertain more specifically the dates that negatives numbered 529 through 617 were exposed.

Will endeavor to secure from E. S. SHEPARD, 203 Lawton, positive evidence that he possessed a Superikomat, Bergheil and Graflex cameras in 1937.

At Washington, D. C.

Will ascertain the date that telephone service for OTHAL V. TALLEY, 3415 Volta Place, N.W., was discontinued in the fall of 1937.

*Will interview DANIEL W. O'DONOGHUE, Jr., Union Trust Building, 15th at H Streets, N.W., for information concerning the names of individuals who may be able to furnish direct information regarding the membership of PRISCILLA HISS in pro-Communist sponsored groups.

Will forward the photo album secured from E. S. SHEPARD to the FBI Laboratory for examination after exhibiting same to CHARLES LEE AIKIN, Winchester, Virginia.

C. until late November or early December, 1937 verified by: (1.) location of newspaper advertisement in Washington Post on Sunday, December 5, 1937 advising that property at 3415 Volta Place, N.W. was available for rental and would be open for inspection on that date; (2.) pictorial evidence secured from E. S. SHEPARD, Falls Church, Virginia which places Mrs. TALLEY in this home in December, 1937. Mrs. TALLEY has advised that negotiations for this property were not initiated by HISS until a few days after she exhibited the home on December 5, 1937. HISS has testified negotiations for the property began early in November, 1937 and a commitment for this property was secured from J. H. B. GILLIAT, Washington, D. C. real estate broker on or about November 18, 1937. PRISCILLA HISS has testified that \$400 was withdrawn from the HISS account at the Riggs National Bank, Washington, D. C. on November 19, 1937 to purchase furnishings for the Volta Place home and that this entire amount was expended in November and December, 1937 for this purpose. Investigation to substantiate pictorial evidence and statements by Mrs. GLADYS F. TALLEY set out.

STATEMENT OF GLADYS FLANAGAN TALLEY, RESIDENT OF
3415 VOLTA PLACE, N. W., WASHINGTON, D. C. IMMEDIATELY PRIOR TO OCCUPANCY BY ALGER AND PRISCILLA HISS

Referenced report of Special Agent FRANCIS J. DUANE, dated September 30, 1949 at Washington, D. C. contains a detailed interview with Mrs. GLADYS FLANAGAN TALLEY. In this report Mrs. TALLEY was identified as the daughter of KATHERINE FLANAGAN, now deceased, but who owned the property at 3415 Volta Place, N. W. from 1935 to 1943 and throughout the entire period this house was occupied by the HISSes. This report also explained that Mrs. TALLEY had conducted negotiations concerning the rental of this property in the Fall of 1937 on behalf of her mother who was ill and infirmed at that time. In this interview Mrs. TALLEY explained that she and her husband, OTHAL V. TALLEY, Sales Manager in the St. Louis Division of Allis-Chalmers Company, St. Louis, Missouri, had resided at 3415 Volta Place in 1937 until November 1 of that year when they moved to Philadelphia, Pennsylvania as Mr. TALLEY had been transferred to that city by the Allis-Chalmers Company. Mrs. TALLEY emphatically stated that when they moved to Philadelphia, Pennsylvania on November 1, 1937 she did not have any prospective tenants who were interested in the rental of 3415 Volta Place, N. W. She explained that she and her mother decided to rent the home at 3415 Volta Place, N. W. only after Mr. TALLEY had received notice of his transfer from Washington, D. C. to Philadelphia, Pennsylvania in October, 1937.

Mrs. TALLEY recalled that the first indication she had that the HISSes were interested in her home was a few days after she had placed an advertisement in the Washington Evening Star announcing that the home was available for rental and would be open for inspection on a particular Sunday in late November or early December, 1937. She stated that she and her husband had returned to Washington, D. C. from Philadelphia one weekend late in November or early in December for the express purpose of renting the home and that she and her husband remained at the home throughout this particular Sunday showing the home to prospective tenants. She added that the advertisement placed in the Star carried the address of this home. She also recalled that during this particular Sunday Mr. and Mrs. ERNEST S. SHEPARD, 203 Lawton, Falls Church, Virginia visited them at 3415 Volta Place, N. W. and that Mr. SHEPARD took pictures of her in the house.

Mrs. TALLEY said that a few days after this particular Sunday that she exhibited the home she received word from Mr. J. H. B. GILLIAT,

Washington, D. C. real estate Agent with whom she had placed her house for rent in October, 1937 that he had a prospective tenant for her home and he identified these tenants as ALGER and PRISCILLA HISS. She has advised that she had not received any inquiries from the HISSes prior to this time, was not acquainted with the HISSes prior to this time, and was unable to recall whether or not Mr. GILLIAT had referred any other tenants to her prior to his referral of the HISSes.

Mrs. TALLEY is positive about the approximate date that she received notice from Mr. GILLIAT that the HISSes were interested in the house as: (1.) she came from Philadelphia to Washington to show the house a certain weekend in late November or early December; (2.) she placed an advertisement in the Washington Evening Star which contained the address of this property; (3.) Mr. SHEPARD took pictures of her in the home at 3415 Volta Place on the Sunday that she exhibited her house.

Mrs. TALLEY also advised that when she placed her home with Mr. GILLIAT for rental she instructed him to secure a rental amounting to \$110 per month. She stated that she did not authorize Mr. GILLIAT to commit this property in any other way. She recalled that when GILLIAT presented the HISSes as tenants he, Mr. GILLIAT, told her that the HISSes would be willing to pay \$100 a month and that after considering this offer for a day she accepted the HISS offer.

TESTIMONY OF ALGER AND PRISCILLA HISS CONCERNING:

- (1.) WITHDRAWAL OF \$400 FROM THE HISS ACCOUNT AT THE RIGGS NATIONAL BANK, WASHINGTON, D. C. NOVEMBER 19, 1937;
- (2.) COMMITMENT SECURED BY ALGER HISS FOR RENTAL of 3415 VOLTA PLACE, N.W., WASHINGTON, D. C.

Referenced report of Special Agent R.F.X. O'KEEFE, dated August 18, 1949 at New York City advised that Mrs. PRISCILLA HISS (Page 2287 of the trial transcript) testified that the HISSes maintained two accounts at the Riggs National Bank, Washington, D. C. - a checking account and a savings account. She testified that on November 19, 1937 she withdrew \$400 from their joint account at the Riggs National Bank and that this money was desired for purchases in order to furnish the new home on Volta Place where they had more rooms which required additional furniture. She testified that the entire \$400 was expended in making various miscellaneous cash purchases for household furnishings.

Mrs. HISS also testified that she borrowed \$300 from the Riggs National Bank, Washington, D. C. on December 8, 1937 and that this amount was credited to her account at this bank on this same day. (It is to be noted that December 8, 1937 approximates the date that Mrs. TALLEY said that J. H. B. GILLIAT first advised her that the HISSes were interested in the rental of 3415 Volta Place, N. W.) In her testimony Mrs. HISS has indicated that she had exhausted the \$400 withdrawn from her account at the bank on November 19, 1937 between November 19, 1937 and December 29, 1937 when she moved into

the residence on Volta Place.

This same referenced report also advised that ALGER HISS in his testimony also stated that the \$400 withdrawn was to be used for the purpose of furniture, linen and miscellaneous household effects in anticipation of their move from 30th Street to Volta Place which residence was larger and roomier.

It is to be recalled that WHITTAKER CHAMBERS advised that he borrowed money from HISS in November, 1937 for the purpose of buying an automobile at the suggestion of BORIS BYKOV. At the trial CHAMBERS testified that the amount borrowed was \$400. CHAMBERS also stated that this loan by HISS practically eliminated HISS's savings account at the Riggs National Bank, Washington, D. C. A transcript of this account reflected that PRISCILLA HISS withdrew the sum of \$400 on November 19, 1937, leaving a balance of \$40.46.

On November 23, 1937 ESTHER CHAMBERS traded in their 1934 Ford car and paid \$486.75 in cash for a 1937 Ford. This car was subsequently registered in her name on December 1, 1937 and the address given was 2124 Mount Royal Terrace, Baltimore, Maryland.

COMMITMENT

Referenced report of Special Agent O'Keefe, dated August 18, 1949 at New York City reported that on direct testimony ALGER HISS in answer to the question "When did you begin negotiations as you recall for renting your home in Volta Place?" answered "During the course of the summer, 1937 Mrs. HISS and I discussed the fact that the 30th Street house was really too small. Throughout the fall of 1937 we looked for a larger house. Sometime early in November we selected the Volta Place house as the house we desired and commenced negotiations for it. About the 18th of November very closely before the date of the withdrawal we had a commitment from Mr. GILLIAT, a real estate broker with whom we had dealt for some years and from whom we had rented the 30th Street house and he was subletting this 30th Street house because my lease ran for some months thereafter. We had a commitment from him that he was confident that the price we were prepared to pay would be satisfactory to the owner of the Volta Place house." (It is pointed out that this portion of the testimony would seem to indicate that the \$400 was withdrawn from the HISS account at the Riggs National Bank on November 19, 1937 only after a commitment had been secured from Mr. GILLIAT.)

HISS further testified that the Volta Place house had been vacant for some months before they acquired it. He thought the lease was signed by him on the 2nd of December, 1937 and he received the key to the house at the time of the signing of the lease or shortly thereafter. (According to the statement of Mrs. TALLEY the house at 3415 Volta Place, N. W. was vacant from November 1, 1937 when she moved to Philadelphia until December 29, 1937 when the HISSes occupied this house. Actually the lease was signed on or

about December 8, 1937 which approximates the date Mrs. TALLEY recalls that GILLIAT contacted her advising that the HISSes were interested in her property. It is also noted that on this same date, December 8, 1937 Mrs. HISS borrowed \$300 from the Riggs National Bank, Washington, D. C. and on this same date the records maintained by J. H. B. GILLIAT disclosed that \$100 was received from the HISSes as the first months rental for the property at 3415 Volta Place (refer page 27 report of Special Agent LAMBERT G. ZANDER, dated August 25, 1949, at Washington, D. C.))

CORROBORATION OF STATEMENTS MADE BY MRS. GLADYS FLANAGAN TALLEY
RESPECTING THE RENTAL OF 3415 VOLTA PLACE, N. W. TO ALGER AND
PRISCILLA HISS

It is to be noted that the HISS testimony concerning the rental of the property at 3415 Volta Place, N. W. openly conflicts with the information furnished by Mrs. TALLEY, especially concerning the date when negotiations were initiated by HISS. The following investigation tends to substantiate the information furnished by Mrs. TALLEY respecting the date that the HISSes secured this property.

Newspaper Advertisements

The classified sections of the Washington Evening Star maintained at the Library of Congress, Washington, D. C. and covering the period from October 1, 1937 through and including December 15, 1937 were examined by Special Agent ALLEN P. BOLLINGER and the following advertisement appeared in this newspaper on October 17, 1937 under a column entitled Houses Unfurnished: "Georgetown - remodeled home on quiet street; walled garden; terrace; sun deck; open fireplaces; 3 bedrooms; automatic heat; WEST 1617J." Agent BOLLINGER also determined that the following advertisement appeared in the Washington Evening Star on October 26, 27 and 28, 1937: "Georgetown - remodeled house, 3 bedrooms, sun deck, walled garden, open fireplaces, 2 stairways, oil burner, insulated; on quiet street. West 1617-J; can be seen day or evening."

The 1937 Washington, D. C. Telephone Directory showed that the telephone number West 1617-J was listed to O. V. TALLEY, 3415 Volta Place, N. W.

No other advertisements for this home could be located in the Washington Evening Star during the period from October 29, 1937 to December 15, 1937.

The following advertisement was found on page 14, section 5, real estate and classified section of the Washington Post, Sunday edition, December 5, 1937. This advertisement appears under a column entitled houses unfurnished: "Georgetown, 3415 Volta Place, N. W.; remodeled house with attic; automatic heat; insulated; walled garden; terrace; sun deck; two stairways; open fireplaces; large living room; open for inspection Sunday from 10 am to 6 pm." No other reference to this home could be located in the Washington Post covering the period from October 1, 1937 to December 15, 1937.

An examination of the Washington Times and the Washington Herald covering the period from October 1, 1937 to December 15, 1937 uncovered no advertisements for the rental of 3415 Volta Place, N. W.

Mrs. ALVA WALKER, Secretary to Dr. LUTHER H. EVANS, Librarian of Congress, has advised that a subpoena to secure records from the Library of Congress should be directed to Dr. EVANS at the Library, Washington, D. C. and mention made of the items desired to be produced by subpoena. In this case it will be sufficient to subpoena the Washington Evening Star editions of October 15, 1937 to October 31, 1937, all of which are contained in one bound volume and the Washington Post editions in December, 1937 which are also contained in one bound volume.

Photographs of these advertisements have been made and copies are being forwarded to the Bureau and the New York Office as enclosures with this report for information purposes. The negatives of these photographs of the advertisements are being retained in the Washington Field Office.

It is to be noted that Mrs. GLADYS F. TALLEY has emphatically stated that she had not received any inquiries from HISS concerning her property as of November 1, 1937, the date she and Mr. TALLEY moved to Philadelphia. She also pointed out that her mother, KATHERINE FLANAGAN, moved to an apartment at 2100 18th Street, N. W. at the same time that she and her husband moved to Philadelphia.

Pictorial Evidence

It will be recalled that Mrs. TALLEY has advised that on the Sunday she exhibited her home (December 5, 1937) Mr. ERNEST S. SHEPARD, 203 Lawton, Falls Church, Virginia, took pictures of her in the home at 3415 Volta Place, N. W.

Mr. ERNEST S. SHEPARD, 203 Lawton, Falls Church, Virginia and Professor of English Literature and Executive Officer, Department of English, George Washington University, Washington, D. C., advised that he and his wife LOUISE had been intimate social acquaintances of OTHAL V. and GLADYS F. TALLEY throughout the time they resided at 3415 Volta Place, N. W. (1936 to November 1, 1937). He said that his wife had been employed for many years with Mrs. TALLEY in the public library system at Washington, D. C.

Mr. SHEPARD recalled that he and his wife LOUISE had spent several hours with Mrs. TALLEY at 3415 Volta Place, N. W. the Sunday that she returned to Washington, D. C. from her home in Philadelphia, Pennsylvania when she, Mrs. TALLEY, was attempting to rent her mother's home on Volta Place, N. W. Mr. SHEPARD recalled that Mrs. TALLEY had returned to Washington, D. C. from Philadelphia one weekend during the late fall of 1937, advertised the house for rent, and remained at the house during the Sunday of this particular weekend. He said that he and Mrs. SHEPARD visited with her at the house which he recalled had been completely stripped of its furnishings and he added that he believed the utilities had also been turned off. Mr. SHEPARD recalled that he had built a

fire in the fireplace on this particular Sunday and had taken pictures of his wife, Mrs. TALLEY, and a dog in front of the fireplace. He also recalled that it had been a clear but cold day.

Mr. SHEPARD made available the exposed photographic negatives showing his wife, Mrs. TALLEY and the dog by the fireplace in the home which Mr. SHEPARD identified as 3415 Volta Place, N. W. He added that these negatives were exposed on the Sunday that Mrs. TALLEY came to Washington, D. C. from Philadelphia in an effort to rent her home. It was noted that these negatives bore the numbers 552 and 553 which had been inked on the border of the negatives. Mr. SHEPARD explained that he is a photography enthusiast and takes seven to eight hundred pictures annually and consequently was forced to set up a numerical filing system for his negatives to aid in locating them when needed. He said that until recently he maintained this file by year and the negative number, explaining that he also placed the year and negative number on positive prints made up by him for his friends in order that his friends would have the negative number in the event they wanted him to print additional pictures.

Mr. SHEPARD explained that a positive print bearing the notation 37-550 would indicate that the exposure was made in 1937 and the print was made from negative 550 which was the 550th exposure made by him with his Superikomat camera. At the beginning of each year he explained that he would number his negatives with the numeral one and continue in sequence until he had exposed his last negative for that particular year. The following year he stated he would begin to number his negatives from the numeral one and continue in like fashion again. At the present time Mr. SHEPARD explained that he had modified his filing system and places the same number on all negatives exposed on a certain date and then encloses these negatives in an envelope showing the date and year of the exposures plus the number. He said that if he takes pictures on successive days, his present numbering system would show the same number of the negatives exposed for one day and that these negatives would be filed by date, year and negative number. The negatives exposed the following day would bear the number following that used on the previous day and then these negatives would be filed in an envelope bearing the date and year of exposure.

Mr. SHEPARD stated that in 1937 he resided in an apartment at 3267 N Street, N. W., Washington, D. C. and maintained all his photographic equipment for developing and printing of negatives in his apartment. He furnished negatives numbered 529 through 624 excepting negatives number 618, 619 and 620 which were not available. He pointed out that all these negatives were exposed by him in November and December of 1937 and that these negatives were developed, cut and positive copies made from them by him. He explained that these negatives were made on 120 roll film in his Superikomat camera, which he sold in 1941. He advised that in 1937 it was his practice to make two exposures on each section of the 120 roll film thus obtaining sixteen pictures from a roll of this type film rather than the eight normally obtainable when only one exposure is made on each section of the film in this roll. He explained that this type of film is attached to a spool and throughout

all stages of development the spool remains attached to the film. He said that after the negatives have been developed and dried he then determines from the end to which the spool is attached the sequence of the exposures and thus it was a simple matter for him to number his negatives in the proper chronological order in which they were exposed and added that he could easily secure the last negative number on the previous roll of film which had been used by him. He pointed out that he inked the numbers on the negatives after they had been dried and before they were cut and then filed the negatives according to the numbers appearing on them.

Mr. SHEPARD pointed out that some of his negatives in addition to containing the negative number contained the month and year in which they were exposed and also said that some contained the season of the year. He advised that it was his usual practice to date the first exposure made on a roll of film in addition to putting the negative number on it. He pointed out that if the film was exposed in two successive months he would show the date on the first negative exposed in one month and would also show the month and year on the first exposure made in the succeeding month. He especially pointed out that his numbering system is based on the time when the negative was exposed and not when it was developed. After the negatives were developed, numbered, and cut in that order Mr. SHEPARD stated he usually made up prints of the individuals appearing in the photographs and would place the year and negative number on the reverse side of the print so that additional prints could be made in the future if these individuals so desired.

Negatives numbered 529 through 624 were secured from Mr. SHEPARD with the exception of negatives 618, 619 and 620. Photographs of all the above described negatives have been made showing the negative numbers and copies of these photographs are being forwarded as enclosures to the Bureau and the New York Office. The negatives of these photographs are being retained by the Washington Field Office.

Descriptive data appearing on the reverse side of these photographs was furnished by Mr. SHEPARD. He was, however, unable at this time to furnish a more detailed description concerning the scenes and individuals appearing in these negatives nor was he able to fix the particular date that these negatives were exposed. These negatives were described by Mr. SHEPARD as follows:

SHEPARD also furnished a photograph album bearing the following label: September 1937-December, 1937, Superikomat, Bergheil, Graflex. He explained that the prints contained in this album were made with his Superikomat, Bergheil, and Graflex cameras. He pointed out that each print in this album has a penciled notation appearing alongside the photograph which indicates the year, the initial for the type of camera used, and the negative number. For example, picture numbered 37-H-6 indicates that Mr. SHEPARD used his Bergheil camera in 1937 to expose negative number 6. The initials GR or GX indicate that the Graflex was used and he explained that the prints which are not identified by any initial all signify that the Superikomat camera was used.

Mr. SHEPARD said that the majority of prints appearing in this album was taken with his Superikomat camera and consequently he felt that it was not necessary to further identify this camera but of course he continued to place the negative number alongside the print. Mr. SHEPARD also said that he has since disposed of his Superikomat, Bergheil and Graflex cameras.

This album also contains pictures showing the interior of 3415 Volta Place, N. W. in 1937 immediately prior to the time that the TALLEYS moved to Philadelphia, Pennsylvania on November 1, 1937. These pictures bear numbers 483 to 491 indicating that these pictures were made with the Superikomat camera. In addition the reverse side of these photographs bear the year and negative number. Mr. SHEPARD recalled that these photographs had been made one evening in October, 1937 after the TALLEYS had received notice of Mr. TALLEY's transfer and after the house had been refinished. The photographs showing the interior of 3415 Volta Place in October, 1937 will be explained in detail in a supplementary report.

This album also contains photographs numbered from 501 to 602. However, the album does not include all photographs in this series but does contain prints

made from the following negatives: 533 through 540, 542 through 545, 563, 567 through 575, 580, 583, 586 through 588, 590, 592, 596, 598, 601, 602, 617 through 619, 621 through 624. This album will be forwarded under separate cover to the New York Office.

It is to be noted that negative 545 bears the date November, 1937. Negative 546 bears the date December, 1937. Mr. SHEPARD explained that negative 545 was the first exposure made on a new roll of film and was also the last exposure made by him in November, 1937 with his Superikomat camera. He recalled that he had made this exposure in the apartment of CHARLES L. AIKIN, Winchester, Virginia, having returned to the AIKIN Winchester Apartment after spending the Thanksgiving holiday at AIKIN's lodge at Capon, West Virginia. Mr. SHEPARD identified the brief case and miscellaneous articles appearing in the background of this photograph as his.

He explained that negative 546 was the first exposure made by him in December, 1937 and consequently he dated this negative in accordance with his established procedure. He said that he would testify under oath that negative 546 and those other negatives that are numbered in progression after 546 were all taken in December, 1937. (This is especially important as it places the time that he made the exposures of Mrs. TALLEY and his wife at 3415 Volta Place, N.W. in December, 1937 which is also in open conflict with the HISS testimony that the HISSes began negotiations for the rental of Volta Place property early in November, 1937)

It is to be noted that Mr. SHEPARD has identified photographs made from negatives 546 through 549 as having been made at his home 203 Lawton, Falls Church, Virginia. He advised that he purchased this home in Falls Church in November of 1937 but did not take occupancy of this home until April, 1938. From the fall of 1937 to April, 1938 he advised he continued to reside in his apartment at 3267 N Street, N. W., Washington, D. C. and which apartment is depicted in the photographs made from negatives 550 and 551.

It is also to be noted that photographs made from negatives 554 through 560 and which according to Mr. SHEPARD were exposed after negatives 552 and 553 were exposed indicate from the condition of the trees and foliage that they were exposed in the late fall or early winter seasons.

Inasmuch as it is believed necessary to establish the dates of the sixteen exposures made immediately preceding and following the dates that negatives 552 and 553 were exposed in order to further fix the dates of the negatives showing Mrs. GLADYS FLANAGAN TALLEY in the living room at 3415 Volta Place, N. W. from sources independent of the newspaper advertisement announcing the rental of 3415 Volta Place, N. W. which appeared in the Sunday edition of the Washington Post, December 5, 1937 and the dated and numbered negatives made by Mr. SHEPARD, the following additional investigation was conducted at Winchester, Virginia by Special Agent J. B. VAN ETTEN and the writer.

Photographs made from negatives numbered 545 through 568 (only negatives available September 30, 1949) were exhibited to CHARLES LEE AIKIN, Director of Recreation, City Hall, Winchester, Virginia, and residence 208 West Boscawen, Winchester, Virginia, on September 30, 1949.

Mr. AIKIN identified photograph numbered 545 and advised that it appeared to be a picture showing his dog, JANIE, who died in 1939. He also identified the rug shown in this photograph as having been his many years ago. He advised that he did not know the location of this rug now. He was unable to identify the other articles appearing in this photograph but said that they probably belonged to ERNEST SHEPARD of Falls Church, Virginia, who he said in all probability took this photograph. He could not recall ever having received a copy of this photograph from Mr. SHEPARD but said the photograph was probably taken by SHEPARD during the Thanksgiving or Christmas holidays of 1937, at which time he, AIKIN, resided in the Coffman Apartments, 138 North Washington Street, Winchester, Virginia. Mr. AIKIN was unable to recall the exact location of the scene depicted in this photograph and he could not recall having witnessed Mr. SHEPARD taking this picture.

Mr. AIKIN said that in the late 1930's Mr. and Mrs. ERNEST SHEPARD usually visited with them during the Thanksgiving and Christmas holidays which were spent in his cottage at Cape Horn Lake, Intermont, West Virginia. He described Mr. SHEPARD as an ardent photograph enthusiast and one who "takes pictures of anything anywhere". Mr. AIKIN offered this reason for his inability to recall the exact date of this photograph or circumstances surrounding the actual taking of this photograph.

Mr. AIKIN was unable to advise when any of the other photographs made from negatives 546 through 568 had been taken.

Mrs. VIRGINIA P. MATHEWS, residence 211 West Leicester Street, Winchester, Virginia, Secretary to CHARLES F. COFFMAN, owner Winchester Milling Corporation with offices at 320 North Cameron Street, Winchester, Virginia, and also the owner of the Coffman Apartments, 138 North Washington Street, Winchester, Virginia, made available the rental records for the Coffman Apartments. These records showed that in September, 1937, AIKIN made a deposit on an apartment at 138 North Washington Street and resided in this apartment continuously from October, 1937, through March, 1938. Mrs. MATHEWS advised that the entries concerning the AIKIN rental were made by Miss PAULINE BAGEANT, former secretary to Mr. COFFMAN, who is now ill and resides in Mr. COFFMAN's home at 205 Fairmont Street, Winchester, Virginia. Mrs. MATHEWS explained that for the past two years she has maintained custody and control of these records and has made entries into these records over the past two years. These records, however, did not show the particular apartment occupied by Mr. AIKIN in 1937 and 1938.

Mr. AIKIN advised that he resided in Apartment 12 at 138 North Washington Street, Winchester, Virginia, and it was determined that this apartment is currently occupied by Mr. and Mrs. J. HOWARD CATHER. Mr. CATHER, who

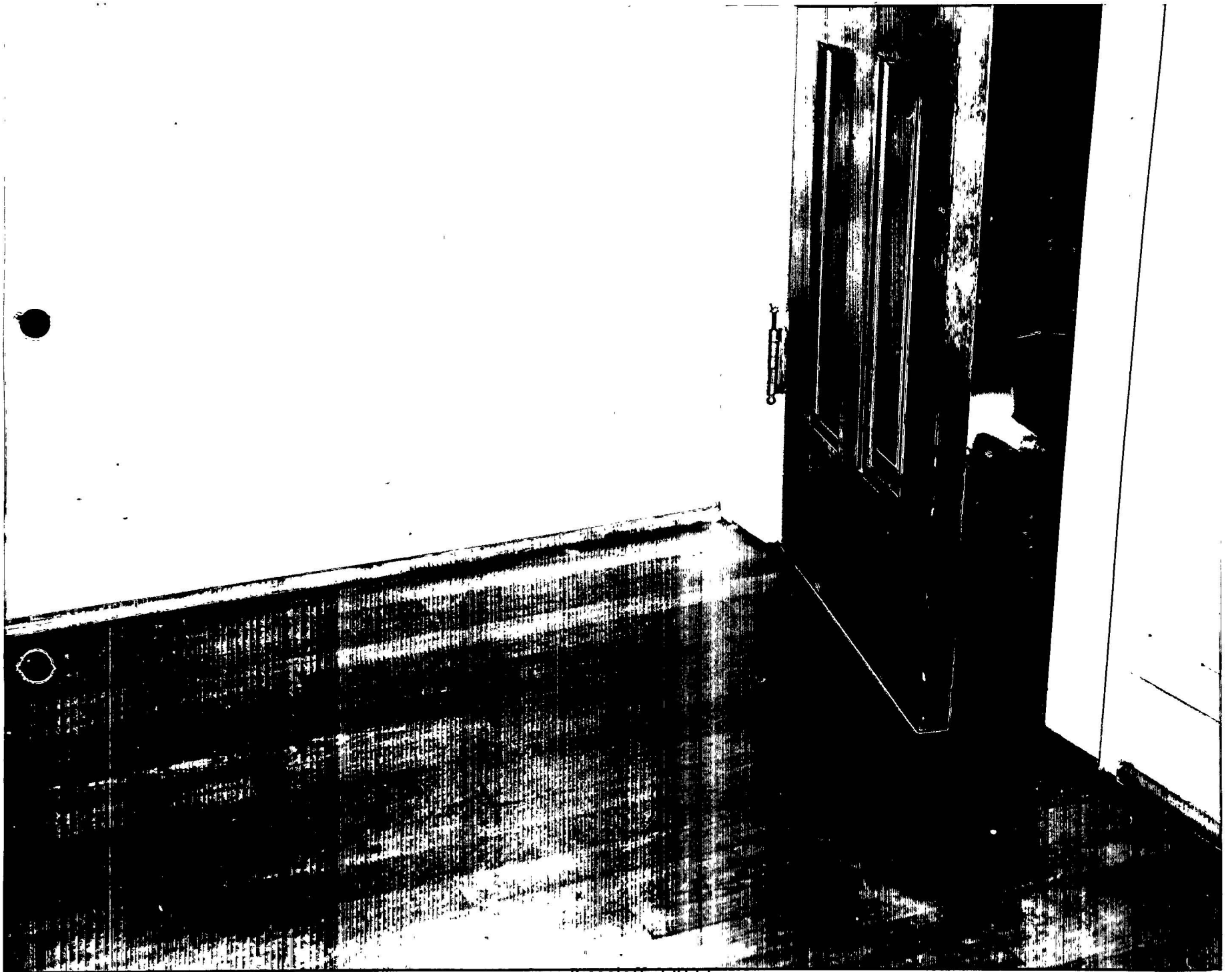
