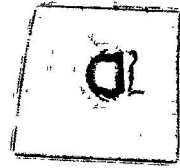

FOLEY, JR., in connection with Treasury Department documents which appear to be the original source of the information appearing on the four sheets of paper in the handwriting of HARRY DEXTER WHITE, which were produced by CHAMBERS at Baltimore, Maryland, on November 27, 1948:

SYNOPSIS OF FACTS: E. H. FOLEY, JR., Under-Secretary of Treasury, advises data appearing on the four yellow lined sheets of paper bearing handwriting of HARRY DEXTER WHITE and produced by CHAMBERS in Baltimore on November 17, 1948, did in fact originate in Treasury Department documents. FOLEY is of the opinion that it would have been improper for this information to be in hands of unauthorized person, that data would have been of help during pertinent period to unfriendly power. FOLEY added the following paragraph in writing with respect to introduction of documents in evidence:

"As will be seen at a casual glance, most of this material is highly confidential and in many instances involves our relations with friendly foreign powers. Even though a number of years may have elapsed since these happenings, we must insist that the approval of State (the immediate source of most, if not all, of the material) and ourselves be obtained before this information is divulged in a public proceeding."

These four yellow lined sheets of paper, according to the FBI Laboratory are in the handwriting of HARRY DEXTER WHITE. It will be recalled that referenced New York teletype requested the Washington Field Office to determine whether the information appearing on these yellow lined sheets of paper originated in Treasury Department documents. It is further recalled that during the pertinent period of these documents HARRY DEXTER WHITE was an official of the U.S. Treasury Department. §

The four yellow lined sheets of paper are reproduced herewith:

"1-10-38 Taylor tried to press the Security (indirectly through - Feis to Hull to Sec.) to hurriedly accept an offer from Hungary of settlement of her 2 million dollar debt to U. S. Govt. The payment offered was trivial. Sec. refused to be hurried and said did not want to establish a pattern on this int. debt settlements without consisting the whole problem. The fact that the Hungarian amount involved was trifling was no reason to accept the offer as it raised matters of principle, precedent, policy, etc. (What is behind Taylor's and possibly Feis' desire to press M (Morgenthau) into a debt settlement arrangement of that character at this time. Why didn't Taylor try to convince Sec. directly instead of surreptitiously via Feis).

"1-9-38 N. S. Naval Captain Ingersol will remain in London until English want to communicate anything to us with respect to Japan boycott or exchange controls. He is to act solely as an agent of communications and not discuss matters. English are not now interested in in economic boycotts of against Japan. Some incident may develop which will lead them to be desirous of our cooperation. We are likely to act alone only if unusually bad 'incident' occurs such as another Panay incident.

Japan according to Col. Strong, has increased greatly to storage facilities for oil. Tanks build underground with two layers of thick cement and air space between as protection against bombing.

Reported yesterday through private Jap banking connections (unknown but supposed to be important) that J. will not declare war on China for some time at least.

Sec. reading Red Star Over China and is quite interested."

* * * * *

"We have just discovered evidence of Japanese 'dumping' of textiles into U. S. and are requiring importers to put up 100% bond against imports. I expect evidence of dumping will increase.

"About 1 month ago the Pres. asked Sec. M. to secretly place as many obstacles in the path of imports from Japan as possible under existing regulations. We have made only a little progress to date on the matter. Our purchases from Japan are declining steadily mostly on items other than silk. Our imports average about two-thirds of last year's average. Part of the decline is due of course, to our reduction in purchases from all countries.

"Japan's dollar balances in U. S. are not declining much. They are about 50 million dollars.

"Purchases of Japanese goods by _____ are decreasing sharply while our exports to those countries are increasing.

"State Dept. believes British moves towards Italy and Germany will reduce substantially European fear of war in the near future.

"If Japan repeats another incident like the 'Panay' incident, treasury machinery is all ready to embargo Japanese imports into U.S. and freeze her dollar balances. This was done at the Pres. orders. It remains unknown outside of Treasury.

"We have just agreed to purchase 50 million more oz. of silver from China. Chinese will have left (almost all in London) about 100 million oz. of silver. Her dollar balance are almost all gone.

"Bullit just called to Sec. (copy not available) comments by Herriot, Blum Reynaud to him. Herriot says if he were premier he would quickly strengthen ties with U. S. S. R. & reassure Czech. that France will at once come to her military aid if Germany enters Czech. He also stated that if U. S. S. R. goes to aid of Czech, she would cut through Roumanias resistance 'like butter' and would also go through quickly Latvia and Estonia against their wishes. Herriot doesn't think there is any chance, however of his"

"becoming premier.

"Reynaud believed the solution of French economic situation is to permit a sharp drop in the franc. Also to form a 'National' cabinet that would include all elements. Blum claims he doesn't want to be premier at this time. Marchandair tried feebly to get Engl & U.S. to agree to support the franc. (Not the slightest chance). The prospects of continued depreciation of franc are very strong.

"I have heard nothing as to Capt. Ingersoll's mission in England beyond my earlier explanations. So far as the Treasury is concerned he is supposed to be there in case of another incident with Japan. In that event he would serve as secret liaison man between Eng. & U.S. unknown to anybody as to the nature of his mission. Chamberlain turned us down at the time of the Panay incident when we asked him whether he would cooperate with us in placing exchange restrictions against Japanese operations in case we decided to do so, but another Knatchbull incident may bring them around.

"State Dept. was eager to accept Hungary's debt offer & sold idea to Sec. M. & President. But Congress doesn't want to begin debt negotiations with Hungary.

"The Van Zeeland report was not taken seriously here."

"Bachman of the Swiss Nat. Bank said (2/15/38) that the Japanese have recently put out a feeler to some of his banks for a loan for industrial development in Manchucko. However, his bankers had not sufficient interest in such a proposition even to submit it to the National Bank for consideration and possible approval."

"Schacht impressed me - and some of my friends also - as finding some hope in the Van Zeeland report as a basis for a possible approach between German and the British and the French.

"Schacht said he positively did not know what had taken place at the meeting between Hitler and Schuschnigg."

* * * * *

On April 27, 1949, Special Agent LAMBERT G. ZANDER and the writer interviewed Secretary of the Treasury JOHN W. SNYDER and advised him of the nature of this problem. Secretary SNYDER observed that he was most interested in this matter and said that he would place this problem in the hands of one of his Under-Secretaries in order that it might have expeditious and constant attention. On the same date Under-Secretary of the Treasury E. H. FOLEY, JR., telephonically advised the writer that this matter had been placed with him by Secretary SNYDER. FOLEY requested that Special Agent ZANDER and the writer visit his office on April 28, 1949.

On April 28, 1949, Special Agent ZANDER and the writer interviewed Mr. FOLEY at his office at which time the nature of the problem was outlined to Mr. FOLEY. Mr. FOLEY was advised that the Bureau desired to know: (1) Whether or not the material on the four yellow lined sheets of paper originated with Treasury Department documents; (2) whether or not it would have been improper for this material to be in the hands of an unauthorized person; (3) whether or not this material would have been of value to an unfriendly power; (4) if this material did originate in Treasury Department documents, a listing of those documents; (5) the name of a person or persons competent to introduce such documents into evidence. Mr. FOLEY indicated that he would undertake to answer these questions and observed that while some of the material appearing on the four yellow lined sheets of paper could probably have been obtained from public sources such as newspapers and magazines, other parts of the material appeared to be highly confidential.

On May 27, 1949, Mr. FOLEY was reinterviewed by the writer after he had indicated telephonically that he had information in connection with this matter. At this time Mr. FOLEY advised that the information appearing on these four yellow lined sheets of paper did in fact originate in official Treasury Department sources and that this could be established from existing Treasury Department records. It is noted that Mr. FOLEY confined this part of his answer to "some of the information" and added that other parts of the information could have been obtained from public sources. On this date Mr. FOLEY advised that it would have been improper for this information to be in the possession of an unauthorized person and that the information would have been of material value to an unfriendly power in 1938. Mr. FOLEY at this time made the following observations: Information in the Treasury Department files from which the information on the yellow paper was extracted came to the Treasury Department mainly from official State Department sources and that it would have been entirely proper for a technician in the Treasury Department to have kept a technician in the State Department posted as to this material providing that each had a mutual and official interest. Mr. FOLEY also desired that it be set out that there was no claim presented by him that anyone presently or formerly employed in the Treasury Department made this information available to an unauthorized source. Mr. FOLEY furnished the writer a memorandum incorporating the information indicated above. This memorandum has been made part of the Washington Field Office file in this matter. Mr. FOLEY also advised that he was preparing a list of the original documents and would furnish it when completed.

On June 1, 1949, Mr. FOLEY furnished Special Agent ZANDER and the writer with a listing of the Treasury Department documents which appeared to be the original source of the information set out on the papers produced by CHAMBERS which papers bear the handwriting of HARRY DEXTER WHITE. At this same time Mr. FOLEY advised that the person most familiar with these documents and their relationship to the notes in question is Miss JANE CULLEN in the office of the Administrative Assistant to the Secretary of the Treasury and if a subpoena ducus tecum is issued it should be issued upon her.

At this time Mr. FOLEY furnished a written memorandum setting out a brief description of the Treasury Department documents. This memorandum contains the following paragraph:

"As will be seen at a casual glance, most of this material is highly confidential and in many instances involves our relations with friendly foreign powers. Even though a number of years may have elapsed since these happenings, we must insist that the approval of State (the immediate source of most, if not all, of the material) and ourselves be obtained before this information is divulged in a public proceeding."

It is noted that Mr. FOLEY made special mention of the paragraph noted above and advised that the Secretary of the Treasury would be most distressed if these documents were introduced in a public proceeding without prior consultation with Mr. FOLEY or the Secretary of the Treasury.

The list of documents furnished by Mr. FOLEY is set out below. It is noted that the subheadings refer roughly to the subject matter of the papers produced by CHAMBERS.

"DOCUMENTS IN TREASURY DEPARTMENT FILES

"HUNGARIAN DEBT NEGOTIATIONS:

"Date

"Subject Matter

"8-24-37 Letter to Assistant Secretary of Treasury Taylor from F. Livesey, Adviser on International Economic Affairs, Department of State, transmitting, at the suggestion of Secretary Hull, suggestions made by Eugene Havas, semi-official adviser to the Hungarian authorities on financial matters, that his government make some proposals for debt payments. Livesey also enclosed a draft of a press release to be used in case proposal was accepted.

"12-13-37 Memorandum to Mr. Livesey from Mr. Taylor transmitting a draft of the proposed press release to be made by the Treasury regarding the Hungarian payment.

"12-16-37 Clipping from the Washington Post regarding small payment on war debt made by Hungary.

- "1-10-38 Memorandum to Secretary Morgenthau from Herbert Feis, Department of State, advising that he had not been able to discuss with Secretary Hull the question of a joint appointment at the White House or present the question of whether conversations should be started regarding a possible debt refunding agreement with Hungary. Attached a statement, which he stated had been hurriedly prepared, regarding the apparent results of certain of the main formulas of settlement if they were to be applied to our main debtors.
- "2-8-38 Copy of letter to Secretary Morgenthau from Secretary Hull enclosing an Aide Memoire, dated February 7, 1938, presented by the Minister of Hungary submitting for consideration a possible basis of a new debt arrangement to replace completely the Debt Agreement of 1924 and accruals thereunder. Secretary Hull indicated that the proposal had been accepted with the understanding it would receive careful consideration with a view to eventual submission to the American Congress. Secretary Hull asked for the Treasury's comments or suggestions on the proposal.
- "2-8-38 Copy of memorandum prepared by Mr. Livesey, State Department, outlining the history of the Hungarian debt.
- "2-15-38 Memorandum prepared by D. W. Bell, Treasury Department, regarding conference with the President on proposal of the Hungarian Government to settle its indebtedness to the United States. Following were present: Secretary Hull, Secretary Morgenthau, Assistant Secretary of the Treasury Taylor, and Mr. Bell. The President approved the letter presented by Secretaries Hull and Morgenthau requesting that the Secretary of the Treasury be authorized to negotiate on the basis on the terms outlined in principle (the words 'in principle' were added to the letter by the President) and prepare a formal agreement for submission to Congress. (Original of this letter showing the President's approval is in the Treasury files and is dated February 16, 1938) At the end of the conference the President indicated he would arrange for the Vice President, Senator Harrison, and Congressman Doughton to meet with him on February 17, 1938, to discuss the matter. He asked Secretary Hull and Secretary Morgenthau to be present also. Photostats of the letter approved by the President were sent to the White House and State Department on February 18, 1938, for their files.
- "2-18-38 Memorandum written for the files by D. W. Bell indicating that Secretary Morgenthau had advised him that at the conference held at the White House on February 17, 1938, the three gentlemen from Congress 'felt that the Government should not accept the Hungarian proposal. They apparently felt that this was not a good time to bring up debt settlements.'

- "2-19-38 Clipping from Washington Post with reference to conference held at the White House on Hungarian proposal. No comments were made by those present and the President confirmed at press conference that international debts had been discussed.
- "2-23-38 Letter to Secretary Morgenthau from Herbert Feis, State Department, enclosing a memorandum of their telephone conversation on February 21, 1938, regarding latest developments on Hungarian debt proposal. Secretary of Treasury concurred in recommendation made by Hungarian Minister, and approved by the President and Secretary Hull, that he publish the Aide Memoire with a short statement bringing out circumstances and purposes of the offer.
- "2-25-38 Copy of memorandum from Mr. Welles to the Secretary attaching an analysis of the comparison made of Hungarian proposal with terms of settlement to Austria on a similar relief loan. Stated that in considering the Hungarian proposal, neither the Administration or Congress would be called upon to consider anything 'new' in the way of concession on intergovernmental debts.
- "3-4-38 Copy of confidential memorandum to Secretary Morgenthau from Secretary of State enclosing copy of memorandum of conversation held on February 28, 1938, between the British Ambassador and the Under Secretary of State with reference to Hungary's proposal. Question of Congressional attitude was discussed. (Original of this memorandum is also in the files.)
- "3-7-38 Letter to Secretary Morgenthau from Herbert Feis, State Department, enclosing summary of editorial comments on the Hungarian debt offer and a memorandum on the Austrian debt offer for suggested background for considering the Hungarian loan.
- "3-18-38(?) Copy of undated memorandum to Assistant Secretary Taylor from Herbert Feis, State Department, approving changes made in draft of President's message on the Hungarian debt by the Treasury.
- "3-18-38 Copy of letter to the President signed by the Secretary of the Treasury enclosing proposed message to the Congress--prepared by State and Treasury Departments--relating to the Hungarian proposal.
- "3-25-38 Letter to Secretary Morgenthau from Secretary Hull advising he had made the changes in the draft of the message suggested by the President.

- "3-28-38 Copy of press release on President's message to Congress regarding the proposal.
- "4-29-38 Copy of memorandum to Mr. Feis from Assistant Secretary Taylor regarding meeting of Secretary Morgenthau, D. W. Bell, and Taylor with Congressmen Doughton, Vinson, and Cooper of the Ways and Means Committee. Congressmen stated it would be inadvisable to hold hearings until after the President, Secretaries of State and Treasury held a meeting with leaders in Senate and House to thoroughly discuss the situation.

"BRITISH-JAPANESE NEGOTIATIONS:

- "1-19-38 Strictly confidential letter to Secretary Morgenthau from Walton Butterworth, U.S. Embassy in London, regarding Captain Ingersoll's mission in London. Advised that Ingersoll had sailed for the United States. Butterworth referred to the conversation Ingersoll had with Morgenthau at the White House and Ingersoll's meeting with Mr. Eden. Also stated that while the Chancellor of the Exchequer no doubt was aware of Ingersoll's presence in London, he made no move to take action.
- "12-8-38 Letter to Secretary Morgenthau from Under Secretary of State enclosing for his confidential information a copy of an aide memoire left by the British Charge d'Affaires with reference to the fact that for sometime there had been off the record and unofficial exchange of views between this Government and the British with regard to retaliatory measures of a commercial or financial character that might be taken in view of the discrimination shown by the Japanese Government against the U. S. and British. The Aide Memoire stated the British Government was still not quite ready to furnish considered views in regard to punitive measures of retaliation or pressure on Japan.

"RED STAR OVER CHINA"

- "1-3-38 Book entitled "Red Star Over China" by Edgar Snow was received in the Treasury Library on January 3, 1938. It was charged to Harry White, Solomon Adler, and others during January of 1938.

"JAPANESE EXPORTS, IMPORTS, ETC.:

- "12-14-37 Memorandum to Secretary Morgenthau from A. Lochhead, a member of the Secretary's staff, reporting that as of 12-11-37 Japan had net current assets in New York of \$55,000,000.
- "12-14-37 Transcript of meeting held by Secretary Morgenthau with Mr. Ukawa, Secretary to the Japanese Financial Commission in New York, and Mr. Lochhead to explain to Mr. Ukawa the necessary steps that must be followed in connection with the sale of gold to the United States. After Mr. Ukawa left, the Secretary called in Mr. Oliphant and Mr. White and asked White and Lochhead to find out for his confidential information how much more in addition to the \$55,000,000 net assets belonging to the Government of Japan do Japanese citizens, plants, etc., have in the United States.
- "12-15-37 Copy of letter to Secretary Morgenthau from H. Ukawa with reference to conference held on 12-14-37.
- "12-15-37 Letter to Secretary Morgenthau from Herbert Feis, State Department, enclosing for his confidential information a copy of the telegram from H. M. Cochran in Paris. Cochran reports on his conversation with central banking contacts on trade matters. He refers to statements made by Bank of Japan's European representative, Yanagita, to the effect that the end of the Japanese-Chinese affair was rapidly drawing near. Yanagita also expressed the hope that very soon a move might be made to improve relations between Japan and the U.S. Cochran also refers to conversations with Reichsbank's President Schacht and the Bank of Italy's Governor Azzolini on trade matters. (Paraphrase of telegram is dated December 14, 1937, 11 a.m., and is numbered 1727.)
- "1-5-38 Letter to Secretary Morgenthau from Secretary Hull enclosing copy of statement prepared by State on 'Japan's Foreign Exchange Resources'. Refers to Japanese bank balances in United States and England, decline in Japanese exports, and the fact that Japan's dollar balances are likely to be depleted early in 1938 unless further gold shipments can be made due to the fact that American and British banks are unwilling to extend credits sought by Japanese buyers.

"1-26-38 Letter to Mr. Ukawa from Mr. Taylor thanking him for the copy of the summary of the speech of the Minister of Finance at the session of the Imperial Diet. Copy of letter from Ukawa and summary of the speech are attached.

"Undated Statement regarding Japanese trade indicating: (1) Japanese exports are falling sharply; (2) Japan's foreign exchange assets were not reduced because the decrease in imports was greater than the decrease in exports; and (3) Japan's loss of exports in January, compared with the same month in the previous year, was for the great part, in her trade with the United States and Asiatic countries. Statement is not dated but was probably prepared in February or March of 1938.

"Suspicion of dumping of textiles

"11-12-37 Report by Ivan B. White, American Vice Consul, Yokohama, Japan, on 'The Administration of Japan's Trade Association System in rendering assistance to cotton textile exports'. Outlines program inaugurated in November, 1937, for the purpose of reducing domestic consumption and of stimulating the export of cotton textiles. Plan had not been completed at that time but would provide a rebate on all cotton goods exported.

"1-22-38 Confidential memorandum to the Secretary of the Treasury from Secretary of State (File No. FE 600.9415/23) referring to the report made by Ivan B. White on 11-12-37 and attaching a copy of confidential telegram, dated 1-15-38, from the American Consul in Yokohama reporting that the grants referred to in 11-12-37 report would begin in a month.

"2-1-38 Copy of strictly confidential letter to the Secretary of State from C. R. Cameron, American Consul General, Tokyo, Japan. (File No. 868.11) regarding statements to be attached to invoices covering exports of cotton with reference to rebate paid.

"2-4-38 Confidential report from Vice Consuls Ivan B. White and Beppo R. Johansen in Yokohama on 'The Administration of Japan's Cotton Goods Export Subsidy'. Report indicates there is a definite possibility that a general subsidy program for Japanese exports may be adopted and that such a program would either be of a concealed or a disguised nature. Also reported that exports to the U. S. under the amended program continue as a matter of fact to be subsidized.

- "2-5-38 Copy of letter to U. S. Appraiser of Merchandise in New York from Commissioner of Customs advising, in answer to his inquiry, that a notice of suspicion of dumping should be issued with respect to importations from Japan of cotton or cotton articles.
- "2-15-38 Letter (copy) to the Secretary of State from C. R. Cameron, Tokyo, with further reference to the rebate on cotton goods and lack of frankness on the part of the Japanese Government in their dealings with the American consuls in connection with the rebate. Referred to the secrecy of operations with reference to the rebate.
- "3-2-38 Memorandum to the Secretary of the Treasury from Secretary of State (File No. FE) attaching copy of an aide memoire presented by representative of Japanese Embassy asking that action be taken to revoke notice of suspicion of dumping in regard to imports of cotton goods from Japan. (Reply to this letter was made on 3-21-38)
- "3-31-38 Copy of report by Vice Consuls Ivan B. White and Beppo R. Johansen, Yokohama, on 'The Administration of Japan's Cotton Goods Export Subsidy'. Report indicates that payments of rebates on cotton goods shipments to the U. S. have been cancelled. Indicates this action was probably taken to counteract or forestall action by American Customs officials. (File No. 610-23/620)

There is a file of weekly reports made to Secretary Morgenthau by Mr. Haas, Director of Research and Statistics, on the status of current U. S. trade with Japan and China. The report dated 1-22-38 indicated that the imports of raw silk were approximately \$1,000,000 more in the first two weeks of January 1938 than in the first two weeks of December 1937, but that other imports continued to decline.

"British Negotiations:

- "3-4-38: Letter to Secretary Morgenthau from Under Secretary of State. Enclosed a copy of a memorandum of a conversation between the British Ambassador and the Under Secretary on 3-3-38. Conversation was with reference to British negotiations with Japan, Germany, and Italy. The Ambassador stated that the British Ambassador in Rome had advised the British Foreign Office on February 21 or 22, it was his belief that unless the British Government moved quickly, the Italian Government might throw itself completely into the arms of Germany for fear of the results of German expansionist moves in Austria

and in Europe's eastern area. He further reported that, in that event, any possibility of reaching an agreement between England and Italy would be minimized. The Under Secretary advised the Ambassador 'that it had been assumed in many quarters that the understanding between Italy and Germany had been very much closer during the past two months than it had been prior to that time.'

"Chinese Negotiations:

- "12-2-37 Letter to the Ambassador of China from the Secretary of the Treasury confirming agreement to purchase 50,000,000 ounces of silver from China and advising that the Federal Reserve Bank of New York would cable bids through the Central Bank of China for amounts of 10,000,000 ounces each on 12-15-37, 12-31-37, 1-15-38, 1-31-38, and 2-15-38.
- "12-13-37 Copy of letter to Herbert Feis, State Department, from Assistant Secretary of the Treasury Taylor returning memorandum of 12-6-37 prepared by State concerning certain aspects of the arrangement between the Federal Reserve Bank of New York and the Bank of China in the event of the recognition of a state of war between China and Japan.
- "2-12-38 Copy of telegram from H. H. Kung asking that Secretary Morgenthau be advised China deeply appreciates his arranging recent silver purchase and asking that present arrangements be continued after expiration of this month.
- "2-25-38 Copy of transcript of notes on meeting held in Secretary Morgenthau's office with Ambassador of China, Mr. Taylor, and Mr. Lochhead during which the Secretary advised the Ambassador he had spoken with the President about his problem and that beginning the first of March we will be very glad to renew the offer to buy another 50,000,000 ounces of silver.
- "2-17-38 Copy of message from J. Lossing Buck in China to the Secretary of the Treasury reporting on his interview with Kung. Buck reported that Kung outlined China's international and political situation and stated that the Chinese Government had been led to believe that foreign intervention would be forthcoming but it was now doubtful. Buck also stated that 'Kung feels that at the time of Panay incident Japanese were so frightened that America could have taken stronger action in a way which might have caused Japan to cease hostilities. He appreciates the present strong stand of the U. S. on customs issue and expresses hope situation will be utilized to curb Japan, as he feels Japan will listen to American representations.'

- "2-19-38 Statement of liabilities and assets of Bank of China and other banks. Indicates that there are approximately 150,000,000 ounces of silver available for sale in London.
- "3-17-38 Statement prepared for the Secretary on China's foreign exchange situation. Refers to fact her dollar, sterling and other foreign balances are virtually all gone and also that China has 150 million ounces of silver in London.
- "3-30-38 Memorandum regarding the call the Chinese Ambassador made on Mr. Lochhead and Mr. Taylor. The Ambassador advised that China had approximately 100 million ounces of silver for sale and would like to arrange for its sale to protect their exchange.

- - - - -

"French Government:

- "1-12-38 Copy of Confidential Message No. 57 from the American Embassy in Paris for the Secretary regarding the Chautemps Government and the possibility that it would resign. Blum asked for our views on establishment in France of exchange control.
- "1-13-38 Copy of memorandum from Mr. Taylor to Secretary Morgenthau regarding reply to be sent to Bullitt for Blum. Indicated Treasury contemplated making no statement on the situation of the franc.
- "2-2-38 Letter to Secretary Morgenthau from Herbert Feis, State Department, enclosing a section of a confidential telegram (No. 176) from Ambassador Bullitt reporting on a conversation with the French Minister of Finance, Marchandéau, regarding the fact the flight of the franc had been stopped and also the status of the French Government at that time.
- "2-18-38 Paraphrase of confidential telegram (No. 268) received from the American Embassy in Paris from Mr. Cochran regarding his conversation with Mr. Monick, French Financial Attaché in London. Monick stated he had talked with Sir John Simon and had interested the British in the idea of opening tripartite conversations. Cochran also reported that later he talked with Monick and Marchandéau together regarding their desire to have conversations with the United States and British on exchange control. Copy of this message was sent to Mr. Butterworth, American Embassy in London. (Message No. 77, dated 2-19-38)

- "2-24-38 Paraphrase of telegram received from Mr. Cochran, American Embassy, Paris (No. 294) advising he had delivered Secretary Morgenthau's message to Mr. Marchandeu, which was to the effect that we are ready to listen but that, in view of the international political atmosphere; it is essential that any consultations and conversations which may take place under the Tripartite should be confidential and of a technical nature. Cochran also reported on pressure on the franc. (time of this message was noon)
- "2-24-38 Paraphrase of telegram received from Bullitt, American Embassy, Paris at 5:00 p.m. Bullitt reported on his conversation with Marchandeu and his understanding that perhaps the British and United States might not wish to stabilize just now. Bullitt also reported on his conversation with Blum, who stated that in view of recent events it would be impossible for him to form a government. The following is quoted from Bullitt's report of his conversation with Herriot on the day before: 'Herriot expressed to me his objections to becoming Prime Minister of France. The entire policy which he had advocated and supported was in ruins now, he maintained. Herriot said that he felt his policy was the only one which could bring safety to France. However, he also recognized that the present time it would involve danger of immediate war, since, should he form a government, he would issue orders for the French General Staff to engage immediately in military conversations with the General Staff of the USSR, in an effort to do everything possible to strengthen relations between these two countries. Herriot said that he would also urge the Soviets to support Czechoslovakia in case an attack on the latter should be made by Germany; he added that he believed Czechoslovakia would receive the support of the Soviets. In the event that Rumania should refuse to allow Russian troops to cross their territory in order to support the Czechs, Herriot thought that the Russians would cut through Rumanian territory 'as through butter'. Furthermore, Herriot believed that, in spite of the offensives of the Latvian and Lithuanian Governments, the Soviets would march through these countries against Germany.' Bullitt also reported on his conversation with Paul Reynaud and his views on devaluation of the franc."

This memorandum from Mr. FOLEY is retained in the Washington Field Office file.

Mr. EDWARD THORD-GRAY, soldier of fortune and aeronautical consultant, Gray Court, Meadow Wood Drive, Belle Haven, advised that he first met Colonel DEAN IVAN LAMB at his office at #2 West 45th Street, New York through a mutual acquaintance. He stated that at that time he was flying for one CHARLES BABB and was also associated with the Sunstedt Aircraft. Because of their mutual interest in flying, THORD-GRAY and LAMB became fast friends and the latter was permitted to share THORD-GRAY's office for the purpose of keeping his papers and receiving telephone calls. He stated that LAMB was also associated with the Sunstedt Aircraft in a promotion capacity. However, he had other interests on the side. This firm failed when HUGO SUNSTEDT failed to obtain financial backing for his proposed venture.

The failure of this firm occurred in either 1934 or 1935, and shortly thereafter LAMB arranged for THORD-GRAY to take employment with Ace Aviation which was located at 45 West 45th Street. After a few months with this firm, he and LAMB formed the Lagra Corporation for the purpose of converting used United States planes into bombers for China and the Central American republics. He stated that LAMB had an interest in this venture but did not invest any money. He was principally used as a contact man with a representative of the Chinese government with whom he was friendly. This venture also failed when the corporation failed to receive any orders from the Chinese government or the Latin American republics. THORD-GRAY explained that the Lagra Corporation was merely a name given to a speculative scheme of his and that no acts of incorporation were executed. He stated that he and LAMB were engaged in many deals but at no time were any contracts ever drawn up. He pointed out that everything was handled on a "gentlemen's agreement" basis. He stated that he and LAMB shared their good fortune and when either one was in need of financial assistance, the other would always respond if he were solvent.

After the failure of the Lagra Corporation which was in approximately 1936, THORD-GRAY obtained employment with the ~~American Roto-Plane~~ which was also located at 45 West 45th Street, New York. After two months with this firm, he resigned and was unemployed for a period of time. However, he still maintained office space at this address inasmuch as the Catadyne Corporation, a water-purifying firm, had a lease on the office and permitted him to use a desk rent-free. He stated that LAMB continued to hang around this address, even though he had no official connection with American Roto-Plane or the Catadyne Corporation.

After a brief period of unemployment, THORD-GRAY accepted a position as pilot and companion to Sir JOHN BRANTON which kept him, for the most part, in the Bahama Islands. This position lasted from 1937 to 1938 and in 1939 he took a position as instructor of aeronautics at the Eastern Aviation Institute at Stamford, Connecticut. In 1940 he went to England to work with the British overseas airways; later joining the Royal Canadian Air Force and eventually transferring to the U. S. Navy in May of 1942.

THORD-GRAY stated that after 1938 he saw very little of LAMB. They occasionally met in New York City but had no deals or business connections. During his close association with LAMB, THORD-GRAY stated that the following individuals were mutual acquaintances who frequented the office that they shared:

THORD-GRAY stated that during his brief period of unemployment in 1937 he became very interested in the activities of the Communist Party in view of the fact that it was fashionable in his set for individuals to be "pinkish". He stated that this attitude in his acquaintances disgusted him and he undertook a campaign to ferret out these "pinks" and report them to the proper authorities. He stated that he was violently anti-Communist and claimed that LAMB shared his views. He stated that LAMB never indicated any pro-Communist tendencies and always expressed himself as being just the opposite.

Questioned concerning the Nye Munitions Committee, THORD-GRAY stated that he had heard LAMB mention this committee but did not know his connection with it. He stated that this may have occurred during the early part of his acquaintance with LAMB.

THORD-GRAY stated that while he was associated with the Sunstedt Aircraft, he had, along with LAMB, a few contacts with FREDERICK DUQUESNE, convicted Nazi espionage agent. He stated that he had no dealings with DUQUESNE but merely observed his every move in order to report the same to the Office of Naval Intelligence. He pointed out that LAMB had no connection with DUQUESNE except as an acquaintance.

Throughout the interview, it was observed that THORD-GRAY was continually bragging about his exploits and achievements. He appeared to be proud of the

fact that he and LAMB almost precipitated a revolution in Guatemala in an effort to help a mutual friend who was a member of the Guatemalan government. He indicated that he would not hesitate for a moment to undertake any venture that would "make a dollar", provided that he did not get caught. He stated that practically all his dealings had been done in a very irregular manner in that he has never required anyone dealing with him to sign a contract or to maintain files. For this reason, he claimed he was unable to remember specific dates and at best could only approximate the year in which a certain event happened. He also stated that he maintained no records.

At the present time he was engaged in promoting the design of a jet-propelled plane which is designed to travel at the rate of 1300 miles per hour.

Throughout the interview, THORD-GRAY appeared cooperative; however, his failure to remember dates and his failure to produce any records made the information he offered appear not too helpful in aiding Colonel LAMB to recall the events which took place during the years 1934 through 1939. He did not indicate any knowledge of a connection between LAMB and ALGER HISS.

By letter of March 7, 1949, the FBI Laboratory advised that the handwriting appearing on the aforementioned form was not sufficiently comparable by itself for a definite conclusion to be reached as to whether specimens Q-1 through Q-4 and the form were or were not written by one individual. However, it was concluded that the writing on this form was written by the same person who wrote specimens K-340, K-341, K-342, and K-547. In this connection, it is observed that specimens Q-1 through Q-4 are handwritten specimens purportedly those of ALGER HISS turned over by WHITTAKER CHAMBERS and referred to as "the Baltimore papers". Specimens K-340 through K-342 are "the Case letters" and K-547 is a handwritten letter dated September 6, 1936 addressed to Mr. PAUL L. BANFIELD of the Landon School, it bearing the signature of ALGER HISS.

The Power of Attorney form was notarized by Mr. LYNN DeLASHMUTT, who is employed by the Riggs National Bank in its branch office at Wisconsin and Warren Streets, N. W., Washington, D. C. Mr. DeLASHMUTT resides at 7114 Hamden Lane, Bethesda, Maryland.

On March 15, 1949, Special Agent WILLIAM J. STATEN obtained from the Selective Service System, Local Draft Board #1, Washington, D. C., the file of ALGER HISS which contained a Selective Service Questionnaire notarized by JAMES M. MASON on November 5, 1940, and a Selective Service Questionnaire Supplement notarized by L. JOSEPH RODLER on May 11, 1942. These documents were transmitted to the FBI Laboratory on March 15, 1949, which advised by report dated March 16, 1949, that the handwriting appearing on the Selective Service Supplementary Questionnaire dated May 11, 1942 was determined to have been written by the same individual who wrote the handwriting appearing on specimens Q-1 through Q-4, previously described. The signature appearing on the Selective Service Questionnaires which bear the Laboratory number K-71 and K-732, respectively, in order of their dates, were compared with the signature of ALGER HISS appearing on specimen K-40, but a definite conclusion could not be reached. Specimen K-40 is a letter addressed to Mr. WALTER G. SCHILKER and bearing the signature of ALGER HISS.

Investigation reflects that L. JOSEPH RODLER, who notarized the Selective Service Supplementary Questionnaire dated May 11, 1942, resides at 1334 Taylor Street, N. E., Washington, D. C. He is employed by the Washington Loan and Trust Company as a teller, 620 - 17th Street, N. W., Washington, D. C. Upon interview by Special Agent STATEN on March 17, 1949, he advised that he could not identify ALGER HISS from a photograph and he did not recall notarizing instant document. However, Mr. RODLER stated that he can identify the signature appearing on the document as his own. He can produce a certificate authorizing him to act as a Notary Public during May, 1942.

By letter dated March 15, 1949, the Baltimore Office transmitted to the Washington Field Office a photograph which appeared in the Baltimore Afro-American, August 31, 1949, which bore the caption, "The HISS Hearing". An article appearing in this newspaper indicated that this individual had testified before the House Committee on Un-American Activities. This photograph is that of MARTHA POPE, as identified by Special Agents JOHN E. HOWARD and the writer.

By letter of April 21, 1949, the New York Division requested that it be ascertained from Mr. PAUL L. BANFIELD, Headmaster of the Landon School where TIMOTHY HOBSON attended from September, 1936 through June, 1940, if TIMOTHY were a day student or boarded at the institution.

On April 26, 1949, Mr. BANFIELD was interviewed by the writer, at which time he advised that TIMOTHY HOBSON was a day student. He said that it was possible that TIMOTHY may have stayed at the school for several weeks at some time and a search of the records reflected an entry as follows:

"February, 1937 - six days board - \$12.00"

Mr. BANFIELD was unable to determine if this entry meant that the HOBSON boy stayed at the school during January, 1937 or February, 1937.

The aforementioned was furnished to the Bureau and New York Office by teletype of April 26, 1949.

psychoanalysts have formed a group within the American Psychiatric Association and call themselves ~~the~~ Group for the Advancement of Psychiatry (GAP). Informant T1 advised that this group commonly referred to as GAP has finally succeeded in controlling a large percentage of the offices in the American Psychiatric Association, in spite of the fact that they control only about ten per cent of the total vote.

Confidential Informant T1 exhibited a ~~X~~ "Newsletter", No. 3, dated April, 1949, published by the Committee for the Preservation of Medical Standards in Psychiatry containing an article headed "The Party Line". The pertinent portions of this article are as follows;

"What about the following quotation from The New York Times attributed to an active member of our present Public Education Committee under a London date line of August 17, 1948?

(It sounds incredible, but see if you recognize the theme song.)

'The use of mental and social scientists at top policy-making levels of the United States Department as well as in the Foreign Ministries of other governments throughout the world was urged here today as a vital step in preventing war.'

In an interview after his speech, the doctor pointed to the 'bugaboo of communism', which he said, was now spreading a state of 'neurotic anxiety' throughout the United States. Fanned largely by 'big business and by the vote getters', this 'neurosis', he added, has become confused in public minds with the 'legitimate feat' of Russia and, under such conditions, he asserted, not only the people of the United States but also its leaders and policy makers are in danger of losing a rational, objective approach to world problems."

Confidential Informant T1 informed that the author of this article quoted from the August 17, 1948, issue of the New York Times is Dr. CARL BINGER and the remarks were allegedly made while BINGER was in England.

The May, 1949, "Newsletter" published by the Committee for the Preservation of Medical Standards in Psychiatry contains an article under the heading, "A Typographical Error" and is as follows:

"In our April Newsletter we cited a statement from the New York Times, and the doctor who was quoted by the New York Times has

complained to us that the Press misquoted him by using the words 'legitimate feat' in place of 'legitimate fear'. We are glad to make this correction for the doctor, of this typographical error which was not ours, but we fail to see how this minor correction alters our original comment on his statement."

Confidential Informant T1 stated that he thought this information might be of assistance to the Government prosecutors when it comes time to cross examine BINGER if he does take the stand. T1 went on to state that in his opinion, the following questions would all be excellent questions to ask BINGER while he was on the stand because the answers thereto would tend to degrade BINGER in the eyes of the jury:

- 1) Is he a psychoanalyst?
- 2) Is he a Freudian psychiatrist?
- 3) Does he believe in God?
- 4) What does he believe the elements of perjury are?
- 5) What are the essential characteristics of an oath?
- 6) What does he think of the oath?
- 7) Does he believe in moral principles?
- 8) What justification does morality have?
- 9) Does morality have the same standing in the United States as it does in Russia?

Confidential Informant T1 also stated that in the event that BINGER does testify that from his observation in the courtroom of WHITTAKER CHAMBERS he is certain that this man is insane, then a thoroughly reliable psychiatrist could be put on the stand by the Government's prosecutor who could testify that it would be impossible for any psychiatrist to merely observe a man on the witness stand and thereafter render a decision as to whether or not that individual is insane. Furthermore, in the event that the defense attorney strives to bring out the fact that WHITTAKER CHAMBERS may be insane by reason of heredity, a competent psychiatrist could testify that the percentage of transmission of heredity diseases is only about seventeen percent and the figure as to insanity is lower than other diseases.

Confidential Informant T1 advises that in his opinion BINGER is further vulnerable by the fact that in connection with his office as a member of the Public Education Committee of the American Psychiatric Association, BINGER caused to be published an article, the pertinent portions of which are as follows:

"Although controversies among members on matters of scientific opinion are bound to arise, such controversies should not be ventilated in public and certainly not through the medium of the press"

The records of the Washington Gas Light Company show that the gas meter was removed on May 9, 1938 and reinstalled on February 10, 1945.

These facts seem to support the opinion that the Catletts did not obtain the Woodstock machine until after the "Baltimore documents" were prepared.

Reference is made to your cable dated May 25, 1949 and your letter dated June 1, 1949 in regard to John Theodore Herrmann.

Mrs. Florence Tate, mother-in-law of Herrmann, advised on June 7, 1949 that Herrmann has been troubled for a long time with varicose veins. While he was in the United States Coast Guard, he submitted to an operation at the Naval Hospital at Charleston, South Carolina, which operation was on the varicose veins and hernia. Since that time, the hernia has not bothered him, but he still complains of the varicose veins troubling him.

Mrs. Tate stated that he has not been hospitalized, however, since he left the Coast Guard, and she did not believe that, since that time, he has received medical treatment for varicose veins. Mrs. Tate stated that about two weeks ago, she received a letter from Herrmann's wife in Mexico, which letter was undated and indicated that Herrmann was being troubled with varicose veins in his ankles, which had ulcerated, causing him a great deal of pain. Mrs. Tate stated that she no longer had the envelope in which the letter came but she exhibited the letter and it was noted that pertinent portion of the letter reads as follows:

"John is having a bad time of it here. Now the veins in the right ankle have broken open and ulcerated in three places. It causes him a lot of pain. He has a couple of good friends here who are doctors -- one of them is the leading surgeon of Mexico and they are trying to fix him up. They are giving him treatments twice a day and at the end of eighteen days they will decide whether or not he will have to go to the hospital. It is pretty much of a mess. We are trying to make plans to renew our tourist cards in Guatemala so we won't have to go to Laredo, but it is a complicated trip if you don't go by American Airlines which we can't possibly afford -- And I don't know if John will be able to make it. Well we have more than a month and a half to take care of it in."

It was noted that this letter was undated and the return address was Wells Fargo, Mexico, D.F.
