IC 606: An anonymous complaint was received on January 27, 2009, alleging a hostile work environment created by inappropriate behavior on the part of the Securities and Exchange Commission (SEC) Inspector General (IG) and the Deputy IG. The IC inquiry was not an investigation, rather, a request for assistance to obtain additional information from the Department of Homeland Security (DHS) Office of Inspector General (OIG), so that the IC could determine the correct course of action. Based on results of interviews provided by DHS OIG, the IC determined that the complaint lacked factual basis and directed case closure.

IC 611: In April 2009, A. Roy Lavik, Inspector General (IG) for the Commodity Futures Trading Commission (CFTC) self-reported a complaint received against him regarding the alleged improper influence in the course of the procurement action to select an accounting firm to conduct the Financial Statement Audits (FSAs). The IC assigned the Office of Inspector General (OIG) for the Equal Employment Opportunity Commission (EEOC) to conduct the administrative investigation. In June 2010, the OIG-EEOC provided the Report of Investigation to the IC which determined that there was insufficient evidence to support the allegation that the IG, CFTC, exerted improper influence in connection with FSA. The IC accepted and adopted the findings and conclusion of the EEOC IG report. This matter was reported to Congressional committees with jurisdiction by letter dated July 15, 2010.

IC640: In June 2010, the IC asked the assistance of the Office of Inspector General for the Treasury Inspector General for Tax Administration, Department of Treasury, to lead an administrative investigation into the alleged abuse of authority by the Inspector General (IG). Assistant IG for Investigations, Deputy Assistant IG for Investigations and a former Deputy Assistant IG for Investigations of the US Postal Service. This administrative investigation is pending. The IC will submit a summary report to the Congressional committees with jurisdiction when the administrative investigation is completed.

This letter provides the annual report to Congress and the President required by section 11(d) (9) of the Inspector General Reform Act of 2008 ("IG Reform Act").

The IG Reform Act directs the Integrity Committee ("IC") to address transparency and reporting issues relating to complaints about Inspectors General and their designated employees. To further these purposes, the IC submits the following information concerning the allegations it recevied and addressed during Fiscal Year 2011.

A total of 51 allegations were submitted to the IC by named and anonymous complainants. Of the 51 allegations, 23 were referred to an appropriate agency for review and any potential action since the allegations did not meet the IC's threshhold to review the substance of the allegation.

Of the remaining 28 allegations, the IC required the subjects in nine of the complaints to provide a response to the IC for the IC to determine whether there were sufficient grounds to proceed to an administrative investigation or to resolve the complaint based on the information the IC had obtained. Five of these nine remaining allegations are in pending status.

The other 19 cases met the IC's threshold for review because the allegation was made about an IG or other covered IG employee. However, the allegations did not require further action by the IC since the allegations did not concern administrative misconduct (including gross mismanagement, a gross waste of funds, or abuse of authority in the exercise of official duties or while acting under color of office) or conduct so serious that it could undermine the independence or integrity reasonably exepcted of an IG or OIG senior staff member. These 19 cases were closed and referred to the appropriate IG's offfice for further action, if any.

There were no allegations referred to the Department of Justice for a criminal investigation.

In June 2010, the IC asked the Office of Inspector General (OIG) for the Department of Treasury's Inspector General for Tax Administration (TIGTA), to lead an administrative invetigation into allegations that various individuals of the U.S. Postal Service OIG had abused their authority, including the Inspector General (IG), Assistant IG for Investigations, Deputy Assistant IG for Investigations, and a former Deputy Assistant IG for Investigations. In February 2011, the OIG-TIGTA provided the Report of Investigation to the IC, which did not substantiate the allegations that abused their positions in violation of 5 U.S.C.,

2301, Merit System Principals, 5 U.S.C., Prohibited Personnel Practices, and 5 C.F.R. 2635, Standards of Conduct for Employees of the Executive Branch. After reviewing the report and all other available information, the IC accepted and adopted the findings and conclusion of the OIG-TIGTA report. This matter was reported to Congressional committees with jurisdiction by letter dated May 13, 2011.

In May 2011, the IC asked the Office of Inspector General for the Department of Justice, to lead an administrative investigation into allegations that the Inspector General and Assistant Inspector General for Management at the Federal Communications Commission may have impeded the audit of a federal program. The investigation is still pending, and the IC will submit a summary report to the . . . Congressional committees with jurisdiction when the administrative investigation is completed.

Enclosure 1: FY2013 Summary of Investigations

In FY2013, the IC closed three administrative investigations which commenced in FY2012. As required by section 11(d)(9)(F) of the IG Reform Act, a summary of the findings of each investigation is provided.

IC712: United States Agency for International Development/ Assistant Inspector General for Audits (AIGA) and Acting IG:

The IC reviewed a complaint in May 2012 concerning the AIGA. United States Agency for International Development (USAID). The complaint alleged, since April 2011, the AIGA ordered USAID OIG auditors to remove negative findings from performance audits concerning third party contractors implementing government programs in other countries and that the Acting IG. failed to stop the AIGA's alleged improper actions. Although the complaint did not identify specific audits, it implied the USAID Office Director in Iraq could provide additional information. The IC requested a response from the AIGA and Acting IG. The response by the AIGA discussed one audit involving a contract in Haiti, but did not address the complaint's reference to Iraq. The response by the Acting IG generally denied either he or the AIGA engaged in misconduct. The IC reviewed the responses and, on August 13, 2012, determined it was necessary to initiate an administrative investigation.

On September 19, 2012, the National Labor Relations Board (NLRB) OIG initiated an investigation of these allegations. The NLRB OIG completed its investigation and did not substantiate the allegations. The NLRB OIG provided the Report of Investigation to the IC on January 25, 2013. The IC reviewed the report, and accepted and adopted the findings and conclusions of the NLRB OIG. The results of the investigation were reported to the Congressional oversight committees of both CIGIE and USAID by letter dated May 22, 2013.

IC719: Department of Interior/ Acting IG:

On November 2, 2012, the Department of Health and Human Services (IHS) OIG investigated allegations of administrative misconduct concerning the Acting IG. Department of Interior (DOI). The investigation was conducted to determine whether: (1) the Acting IG, failed to ensure an independent, impartial, and complete investigation into the allegations concerning the recommendations of the independent peer review experts concerning an offshore drilling moratorium imposed after the deepwater drilling incident in the Gulf of Mexico: (2) the Acting IG had an actual or apparent conflict of interest in participating in the DOI OIG review of the 30-Day Report concerning the issuance of the report containing the drilling moratorium; and (3) the Acting IG violated the Information Quality Act.

The HHS OIG completed its investigation and did not substantiate the allegations. HHS OIG provided its Report of Investigation to the IC on June 28, 2013. The IC reviewed the report, and accepted and adopted the findings and conclusions of the HHS OIG. The results of the investigation were reported to Congressional oversight committees of both CIGIE and DOI by letter dated October 22, 2013.

IC725: National Reconnaissance Office/IG:

On August 29, 2012, the IC received a complaint alleging a conflict of interest by the IG, National Reconnaissance Office (NRO). The complaint alleged the IG may have had a conflict of interest concerning NRO's polygraph office. Specifically, it was alleged a conflict existed because the IG

lobbied NRO polygraph officials in 2011 to employ the girlfriend of the son of one of the IG's employees and was also conducting a review of allegations of NRO Polygraph officials engaged in misconduct in the administration of polygraphs. Because the NRO OIG has oversight responsibilities for the NRO polygraph office, it was alleged the IG's lobbying efforts posed a conflict of interest. On September 6, 2012, the IC reviewed the complaints and requested the Department of Energy (DOE) OIG begin an administrative investigation.

The DOE OIG completed its investigation and did not substantiate the allegations. DOE OIG provided the Report of Investigation to the IC on December 7, 2012. The IC reviewed the report, and accepted and adopted the findings and conclusions of the DOE OIG. The results of the investigation were reported to Congressional oversight committees of both CIGIE and NRO by letter dated March 18, 2013.

FY2013 On-going Investigations:

There are currently two on-going investigations before the IC. One investigation involves twelve complaints received in FY2013 pending an on-going IC administrative investigation. The other investigation involves one complaint received in FY2012 which is also pending an on-going IC administrative investigation. The Integrity Committee does not provide substantive information on pending investigations.

Enclosure 1: FY2014 Summary of Investigations

In FY2014, the IC concluded one administrative investigation which commenced in FY2013. As required by section 11(d)(9)(F) of the IG Reform Act, a summary of the findings of this investigation is provided. The IC is also providing information about the conclusion of a significant recently concluded administrative investigation, even though the investigation was concluded in FY2015 and would be reportable next year.

IC720: National Archives and Records Administration/Inspector General (IG). Counsel to the IG, and Assistant Inspector General for Investigations (ΔIGI):

Numerous allegations were initially made in June 2012 against the IG, Counsel to the IG, and AIGI. The allegations concerned various statements the IG may have made concerning the race and/or ethnicity of individuals at NARA, comments about dating NARA employees and/or contractors or that were sexual in nature to various NARA employees and/or contractors, comments about the weight or personal appearance of NARA employees and/or contractors, threatening comments about the NARA General Counsel, as well as a failure to follow appropriate investigative and audit standards and taking retaliatory actions against OIG employees.

In July 2013, the Federal Deposit Insurance Corporation (FDIC) OIG accepted the investigation, concluding their work in May 2014. The IC met on May 21, 2014 to consider the matter.

The FDIC OIG substantiated certain allegations that the IG made the statements attributed to him about a marriage between individuals of different races, engaged in discussions about dating various NARA employees and/or contractors, and made comments about the weight or personal appearance of NARA employees and/or contractors. The remaining allegations against the IG were unsubstantiated or the FDIC OIG indicated that it was not able to substantiate the allegation since the only two individuals who participated in the encounter had differing recollections, and there were no other witnesses able to provide evidence.

The IC accepted and adopted the findings of the FDIC OIG as its own findings and conclusions concerning the conduct of the IG. Counsel to the IG, and the AIGI. The IC concluded that these comments by the IG, both separately and taken as a whole, constituted administrative misconduct and undermined the integrity reasonably expected of an IG. The IC determined that neither the AIGI nor Counsel to the IG had committed administrative misconduct.

FY2014 On-going Investigations:

There are currently two on-going investigations before the IC. One investigation originated from a complaint in October 2013, while the second investigation originated from two complaints in February and April 2014. The Integrity Committee does not provide substantive information on pending investigations.

FY2015 Completed investigations:

The IC completed an additional, significant, investigation at the end of October 2014.

IC740: Department of Homeland Security (DHS)/ Acting IG:

Numerous allegations against the Acting Inspector General (A/IG) of DHS were submitted to the IC beginning in May 2012. The complaints included allegations that the A/IG failed to disclose spousal employment with a DHS office leading to an impairment of a DHS OIG audit of that office, allowed the Acting Chief of Staff to use official time to work on the doctoral dissertation of the A/IG and was encouraged to set aside official DHS OIG duties to perform the work on the dissertation, had telephone records destroyed that were responsive to a Freedom of Information Act (FOIA) request, awarded contracts to unqualified applicants, and allowed DHS officials to direct the content and timing of DHS OIG audit reports.

The IC reviewed a total of 18 complaints about the A/IG. Two of the complaints were closed administratively since they failed to meet the IC's threshold for consideration. The remaining 16 complaints were investigated by the Department of Transportation (DOT) OIG between June 2013 and October 2014. The DOT OIG submitted its final ROI on October 17, 2014 and the IC met on October 30, 2014 to consider the matter.

The DOT OIG substantiated four allegations: (1) The A/IG failed to disclose spousal employment in DHS's Program Accountability and Risk Management Office, which appeared to impair the independence of a DHS OIG audit that cost the government \$659.943.32 and resulted in the rescission of the audit report; (2) The A/IG could not account for all of his time during a June 2011 trip to the DHS OIG Miami field office, and there is evidence that the October 2011 trip to Miami was a pretext to have personal travel expenses paid for by the government; (3) The A/IG allowed the Acting Chief of Staff to use official time to work on the A/IG's doctoral dissertation, and was encouraged to set aside official DHS-OIG work to do so; and (4) The A/IG allowed the DHS OIG Information Technology (IT) Branch Chief to use official time to perform work related to the A/IG's teaching responsibilities at Capitol College. While the IC also substantiated that finding, it concluded the A/IG's inability to account for all of his time that day did not constitute administrative misconduct, and was not a basis for the IC's findings.

IC753: National Labor Relations Board (NLRB)/ Inspector General (IG):

In October 2013, a complainant alleged the IG compromised his impartiality and independence by communicating with the Office of Government Ethics (OGE) and relaying its advice about whether a dispute between the NLRB's Acting General Counsel (A/GC) and the NLRB's Designated Agency

Ethics Office (DAEO) created a conflict of interest such that the DAEO should not review the A/GC's travel reimbursements and financial disclosure forms.

The Smithsonian (SI) OIG accepted the investigation in April 2014. During the course of investigation the SI OIG also looked into an additional allegation stemming from the original complaint, that the IG showed a lack of impartiality and independence in how the IG reported a conflict of interest investigation concerning the Λ/GC . The complainant alleged that the IG did not present the criminal findings to federal prosecutors and included a section on mitigating circumstances in the report that showed partiality towards the Λ/GC .

The SI OIG concluded their work on May 14, 2015. The IC met on June 24, 2015 to consider the matter and additional information obtained from the subject of investigation.

The SI OIG determined that, while the Inspector General Act authorizes an IG to keep the head of the establishment fully and currently informed of serious problems and deficiencies relating to an agency program or operation, the NLRB IG's method of this notification caused an appearance of partiality. Regarding the additional complaint alleging the failure to present criminal findings to prosecutors and further partiality, the SI OIG found the IG's investigation was appropriately referred to federal prosecutors and that the findings and the inclusion of mitigating circumstances were appropriate.

The IC accepted and adopted the findings of the SI OIG as its own findings and conclusions regarding the IG's conduct. The IC determined that, although well intentioned, the IG involving himself in the communications between OGE and A/GC amount to administrative misconduct because it created the appearance of partiality that could undermine the independence of the OIG. The IC noted this conduct and appearance of partiality at the NLRB OIG to the Chairman at NLRB for any action deemed appropriate.

IC769/772: Department of Defense (DoD)/ Deputy Inspector General for Investigations (DIGI):

An anonymous complainant alleged in March 2014 that the DIGI inappropriately directed the use of Defense Criminal Investigative Services (DCIS) resources by directing a DCIS agent to conduct law enforcement queries and sensitive financial checks of a potential suspect pursuant to information provided by a family member, an official at a bank in Alabama.

In April 2014, the IC accepted a separate complaint that alleged the DIGI ran or owned a private investigations business incorporated in Virginia.

In September 2014, the Railroad Retirement Board (RRB) OIG accepted the investigation, and concluded their work on January 16, 2015. The IC met on January 23, 2015 to consider the matter.

The RRB OIG did not substantiate the allegations. The IC accepted and adopted the findings of the RRB OIG as its own findings and conclusions regarding the conduct of the DIGL and closed the matter.
