Steve McQueen will star in this film which is written by Alan R. Trustman. *Calif. 1967*

b7c We have had friendly relations with [redacted] in the past and have no derogatory information regarding [redacted] is not identifiable in Bufiles. McQueen indicated he planned to participate in the March on Washington in 1963. [redacted]

This screen play has been reviewed in the Crime Research Section. It involves a bank robbery in Boston conceived and directed by Thomas Crown, who employs five others to commit the robbery and then secretes the remaining proceeds in a Swiss bank. The investigation by the Boston FBI Office, headed by Edward Rock, makes no progress until the bank's insurer assigns a beautiful young girl investigator, Vicky, to work with the FBI. Vicky completely dominates the investigation and entirely through her efforts identifies the subjects and furnishes this information to the FBI. Sex is both explicit and implied throughout the story and is especially apparent in the romantic relationship between Vicky and Crown. For your information, captioned motion picture is being produced by The Mirisch Corporation, Los Angeles, California, and is based on an original screenplay by Alan R. Trustman. Reportedly, the picture will have actor Steve McQueen in a starring role. Representatives of the producer have been in contact with us in an effort to secure permission to photograph the Boston Office in connection with this picture. A draft of the screenplay has been received at the Bureau and reviewed.

The story involves a bank robbery in Boston conceived and directed by Thomas Crown, who employs five others to commit the robbery and then secretes the remaining proceeds in a Swiss bank. The investigation by the Boston FBI Office, headed by Edward Rock, makes no progress until the bank's insurer assigns a beautiful young girl investigator to work with the FBI. She completely dominates the investigation and, entirely through her efforts, identifies the subjects and furnishes this information to the FBI. Sex is both explicit and implied throughout the story and is especially apparent in the romantic relationship between the girl and Crown. Rock is fully aware of the methods being used by the girl to extract admissions from Crown. The story ends when the girl and the FBI are outwitted by Crown, who flies to Brazil, leaving a final invitation for the girl to join him in that country.

For information of the Bureau, on 6/9/77, the "Sacramento Bee" newspaper received the enclosed letter and information was developed that captioned subject was currently under indictment for threatening to kill the President and a check with U.S. Secret Service, Sacramento, confirmed this.

On 6/9/77, contact with AUSA DONALD HELLER, Sacramento, determined that [REDACTED] had been sentenced that day for violation of Title 18, Section 871, Threats to Kill the President, to an indeterminate sentence under the Youth Corrections Act. b7c

Based on this information, AUSA HELLER advised he would consider no further prosecution of captioned subject.

On 6/19/77, the originals of the enclosed letter and envelope were turned over to U.S. Secret Service Agent [REDACTED] to be made a part of their case. JUN 15 1977

On 3/24/69, [redacted] telephonically contacted the Los Angeles Division from Fort Saskatchewan, Alberta, Canada, telephone [redacted] and advised he formerly was with the Royal Canadian Mounted Police and had been associated with the FBI National Academy, Washington, D. C. [redacted] said the purpose of his call was to determine if this office could relay a message to the actor STEVE MCQUEEN for him. [redacted] said MCQUEEN was scheduled to travel to Canada to hunt with him on 3/25/69, but that he had injured himself in a hunting mishap and would be unable to join MCQUEEN. [redacted] said he did not have MCQUEEN's telephone number. He asked that MCQUEEN be furnished his telephone number so that MCQUEEN could call him in Fort Saskatchewan.

On 3/25/69, [redacted] Solar Productions, Cinema Center Films, Studio City, California, advised that MCQUEEN owns this company. He said MCQUEEN is currently on location at the Disney Ranch, San Fernando Valley, California, in connection with the motion picture "The Reivers" which this company is producing and in which MCQUEEN is acting. The information furnished by [redacted] was made available to [redacted] who said he would pass the information on to MR. MCQUEEN. [redacted] thanked the FBI for its assistance in this matter.

[redacted] noted, however, that MCQUEEN is fully occupied with the making of this motion picture and that MCQUEEN has no plans to go hunting in Canada. He noted that [redacted] name is not familiar to him although he is not acquainted with all of MCQUEEN's associates. He suggested that [redacted] story about the hunting date with MCQUEEN was so much in error that it sounded irrational.

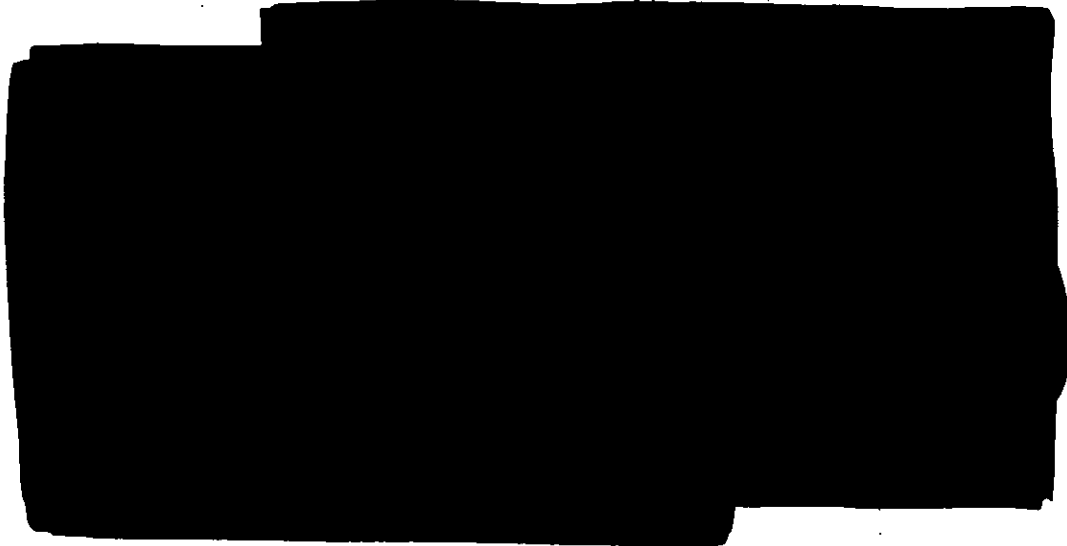

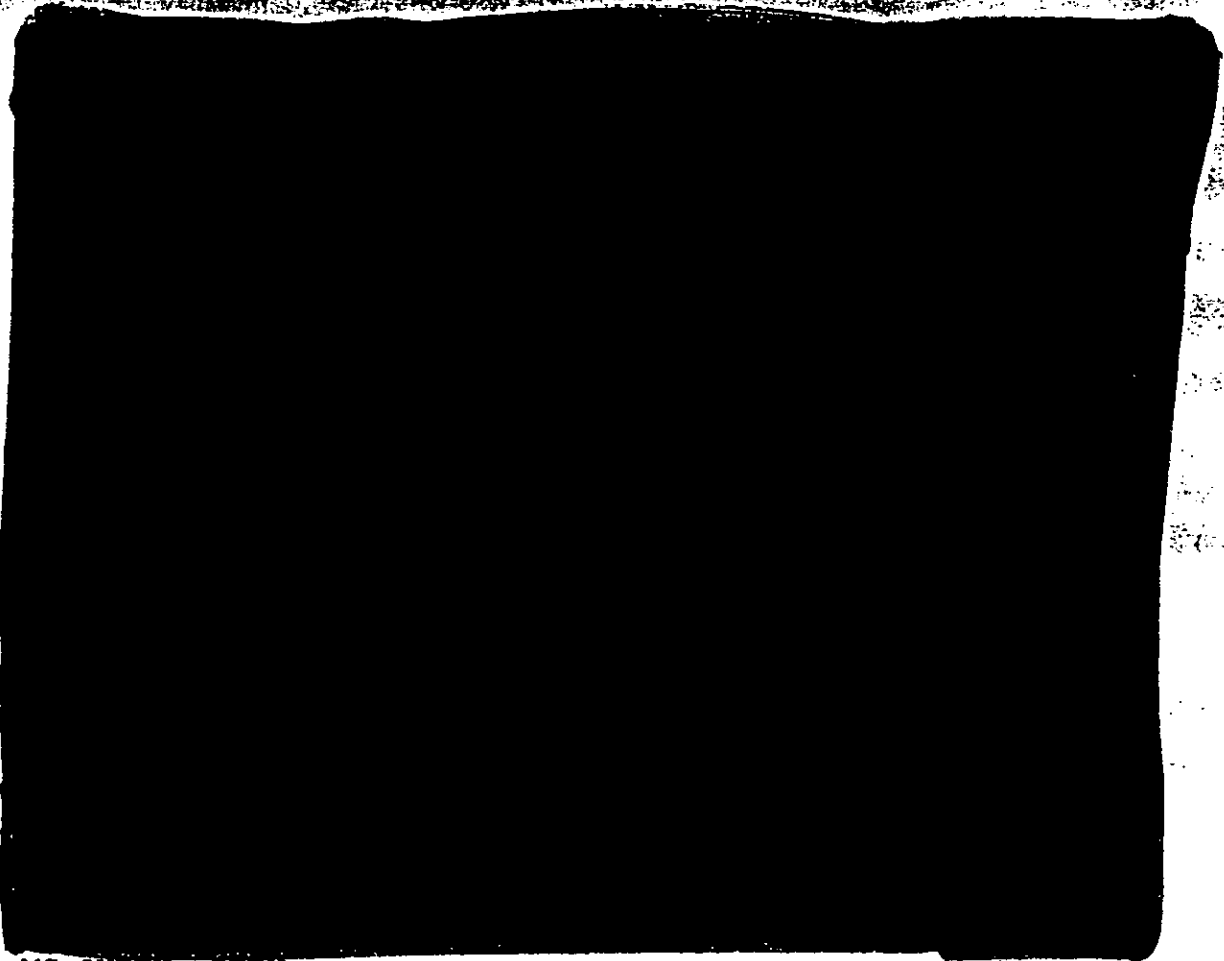
