The exposure of this deal has revealed that 9 major aspects of ~~your~~ <sup>the</sup> foreign policy you have constructed over 6 years have been gravely damaged. -- after years of work the keystone of our counter-terrorism policy was set: No deals with terrorists. Now we have fallen into the trap. We have voluntarily made ourselves the victims of the terrorists extortion racket. We have spawned a hostage-taking industry. Every principle that you praised in Ben Netanyahu's book has been dealt a terrible blow by what we have done.

-- We have assaulted our own MidEast policy. The Arabs counted on us to play a strong and responsible role to contain and eventually bring the Gulf war

-- We appear to have violated our own laws. Certainly we have corrupted ourselves in the eyes of the law. At this moment there are Israelis and others on trial in US criminal courts for doing what the USG is now revealed to itself to be doing.

-- Our credibility is shot. We have taken refuge in tricky technicalities of language to avoid confrontations. The reality that we have lied to the American people and <sup>misused</sup> our friends abroad, we are revealed to have been dealing with some of the sleaziest international characters around. They have played us for suckers. There is a Watergate-like atmosphere around here as the WH staff has gotten morose, secretive, self-deluding, and vindictive.
