"PROCLAMATION NO 1.

TO THE PEOPLE OF CUBA WHEREAS THE AGGRESSIVE AND ILLEGAL ACTS OF THE CASTRO REGIME AGAINST HIMANITY HAVE VIOLATED INTERNATIONAL LAW AND THE FUNDAMENTAL PRINCIPLES OF FREEDOM AND INDEPENDENCE OF NATIONS: AND WHEREAS THE UNITED STATES OF AMERICA, IN ORDER TO HONOR ITS OBLIGATIONS AND TO SECURE ITSELF AND THE OTHER FREE NATIONS OF THE WORLD AGAINST THE THREATS GENERATED BY THESE AGGRESSIVE ACTIONS OF THE CASTRO REGIME, HAS BEEN REQUIRED TO ENTER INTO ARMED CONFLICT WITH THE FORCES OF THE CASTRO REGIME IN CHBA: AND WHEREAS THE PEOPLE OF THE INITED STATES HAVE NEVER DURING THE CASTRO DICTATORSHIP LOST THEIR FEELING OF WARM FRIENDSHIP FOR THE PEOPLE OF CHBA AND WHEREAS THE ARMED FORCES OF THE UNITED STATES WILL PROTECT THE PEOPLE OF CHBA IN

LAW AND ORDER AND PROVIDE FOR THE MAXIMUM SAFETY AND WELFARE BOTH OF THE UNITED STATES ARMED FORCES IN CUBA AND OF THE PEOPLE OF CHBA, MILITARY GOVERNMENT IS TEMPORARILY NECESSARY IN CUBA.

NOW, THEREFORE, I (INSERT NAME CUTF CHBA) U.S. ARMY, COMMANDING THE UNITED STATES ARMED FORCES IN CUBA, DO HEREBY PROCLAIM AS FOLLOWS:

ALL POWERS OF GOVERNMENT, EXECUTIVE, LEGISLATIVE AND JINDICIAL AND ALL JURISDICTION IN THE OCCUPIED TERRITORY AND OVER ITS INMABITANTS. AND FINAL ADMINISTRATIVE RESPONSIBILITY, ARE VESTED IN ME AS COMMANDER AND MILITARY GOVERNOR: AND THE MILITARY GOVERNMENT OF CHBA. IS ESTABLISHED TO EXERCISE THESE POWER UNDER MY DIRECTION.

ALL PERSONS IN THE OCCUPIED TERRITORY WILL OBEY PROMPTLY ALL ORDERS GIVEN BY ME OR UNDER MY ANTHORITY AND MUST REFRAIN FROM ALL ACTS HOSTILE TO THE FORCES UNDER MY COMMAND OR HELPPHY TO OUR ENEMTES, FROM ALL ACTS OF VIOLENCE, AND FROM ANY ACT CALCULATED TO DISTURB PUBLIC ORDER IN ANY WAY. ALL PERSONS IN THE OCCUPIED TERRITORY WILL OBEY IMMEDIATELY AND WITHOUT QUESTION ALL ENACTMENTS AND ORDERS OF THE MILITARY GOVERNMENT COURTS WILL BE ESTABLISHED FOR THE PUNISHMENT OF OFFENDERS. RESISTANCE OF THE INITED STATES ARMED FORCES WILL BE FORECEFULLY STAMPED OUT. SERIOUS OFFENDERS WILL BE DEALT WITH SEVERELY.

YOUR EXISTING PERSONAL AND PROPERTH RIGHTS WILL BE FULLY RESPECTED AND YOUR EXISTING LAWS WILL REMAIN IN FORCE AND EFFECT EXCEPT INSOFAR AS IT MAY BE NECESSARY FOR ME, IN THE DISCHARGE OF MY DUTTIES AS COMMANDER OF THE UNITED STATES ARMED FORCES IN GUBA AND AS MILITARY GOVERNOR, TO CHANGE OR SUPERSEDE THEM BY PROCLAMATION OR ORDER ISSUED BY ME UNDER MY DIRECTION. ALL CUBAN CIVIL AND CRIMINAL COURTS AND ALL UNIVERSITIES, SCHOOLS AND EDUCATIONAL ESTABLISHMENTS WILL BE CLOSED UNTIL FURTHER ORDER OF THE MILITARY GOVERNMENT.

WHEN THE AGGRESSIVE CASTRO REGIME HAS BEEN COMPLETELY DESTROYED, AND ARRANGEMENTS MADE TO PROVIDE A DEMOCRATIC GOVERNMENT RESPONSIVE TO THE DESIRES AND NEEDS OF THE PEOPLE OF CUBA, UNITED STATES ARMED FORCES WILL DEPART AND THE TRADITIONAL FRIENDSHIP OF THE UNITED STATES AND THE GOVERNMENT OF CUBA WILL ONCE MORE BE ASSURED."
