During past few days Ronan (Ireland) transmitted to Dublin for comment revised draft text incorporating suggestions received from UK, Canada, US, Dutch. Only changes are in OP paragraphs, where parts of former 2, 3, and 4 have been combined into new paragraphs 2 and 3. Revised OP paragraphs follow

"2) Calls on all states and in particular on the states at present possessing nuclear weapons to use their best endeavors to secure the conclusion of an international agreement containing provisions under which the said states would undertake to refrain from relinquishing control of nuclear weapons to states not possessing such weapons and provisions under which states not possessing nuclear weapons would undertake not to acquire control of or to make such weapons; possession

3) Urges all states to cooperate to this end and to facilitate the measures of inspection and control required to ensure that each of them is fulfilling its undertakings."

Ronan said has requested instructions on substitution "recalls" for "reaffirms" in OP paragraph 1. If Irish accept this suggestion, OP paragraph 1 should be deleted,
