1. SUMMARY: THE OSCE ASSISTANCE GROUP HAS FORWARDED TO DELEGATIONS A REPORT ON ITS ACTIVITIES WITH A VIEW TO THE MAY 9 MEETINGS IN MOSCOW OF HEADS OF STATE AND GOVERNMENT. THE HEAD OF THE ASSISTANCE GROUP, AMBASSADOR MESZAROS, REPORTS THAT MILITARY ACTIVITIES CONTINUE TO TAKE PLACE DESPITE THE MORATORIUM. THIS INCLUDED SHELLING AND BOMBARDMENT BY FEDERAL FORCES. MESZAROS ALSO REPORTS RUMORS THAT DUDAYEV'S FORCES ARE PREPARING MILITARY ACTION TO COINCIDE WITH VICTORY DAY CELEBRATIONS 9 MAY. END SUMMARY.

THESE INCLUDE SHELLING AND AERIAL BOMBARDMENT BY FEDERAL FORCES OF TOWNS HELD BY THE DUDAYEV SIDE AND HEAVY ARTILLERY AND SMALL ARMS FIRE AUDIBLE IN GROZNY. AN ATTEMPT WAS MADE 30 APRIL TO ASSASSINATE UMAR AVTURKHANOV, HEAD OF THE COMMITTEE OF NATIONAL ACCORD. RUMORS ABOUND THAT DUDAYEV'S FORCES ARE PREPARING MILITARY ACTION TO COINCIDE WITH VICTORY DAY CELEBRATIONS 9 MAY.

THE FIRST INVOLVES SHELLING AND AERIAL BOMBARDMENT OF AREAS HELD BY THE DUDAYEV SIDE. WE HAVE OBSERVED SHELLING AND AERIAL BOMBARDMENT OF BAMUT, OREKLOVO, SERZHEN-YURT, AVTURI AND IN THE VICINITY OF VEDENO. ON 5 MAY WE SAW AT CLOSE RANGE 4 FIXED WING GROUND ATTACK AIRCRAFT BOMBING NEAR SERZHEN-YURT. DUDAYEV FORCES SHOT DOWN ONE OF THEM, WHOSE WRECKAGE WE WERE ABLE TO INSPECT THE NEXT DAY ON THE ROAD BETWEEN BENEY AND TSA-VEDENO.

4. THE SECOND CATEGORY, AT NIGHT, INVOLVES SMALL ARMS FIRE WHICH IS FOLLOWED BY HEAVY ARTILLERY, ILLUMINATION SHELLS AND HEAVY MACHINE GUNS. FEDERAL AND LOCAL AUTHORITIES CLAIM THAT IN GROZNY MUCH OF THE SMALL ARMS FIRE IS DIRECTED AT THE BUILDING WHICH HOUSES THEM BOTH, BUT THERE ARE INCIDENTS ALSO IN DISTRICT REGIONAL COMMANDS AND THE AIRPORT. FEDERAL MILITARY COMMANDERS TOLD US ON MAY 3 THAT THERE WERE TO THAT DATE 33 INCIDENTS PROVOKED BY DUDAYEV'S FORCES SINCE THE MORATORIUM BEGAN. OUTSIDE GROZNY, FEDERAL FORCES HAVE SET UP STRONGPOINTS OUTSIDE TOWNS AND VILLAGES AND AT ROAD JUNCTIONS; AND HAVE TOLD US THAT FIRING TAKES PLACE AT NIGHT AT THESE POINTS AS WELL. 5. EVIDENCE IS COMPELLING THAT FEDERAL HELICOPTER GUNSHIPS ATTACKED THE VILLAGE OF SHALAZHI, IN WESTERN CHECHNYA, ON MAY 1, WITH THE LOSS OF LIVES AND A NUMBER OF WOUNDED. SHALAZHI WAS A BULWARK OF OPPOSITION TO DUDAYEV DURING HIS TIME IN POWER IN GROZNY AND WELCOMED THE NEW AVTURKHANOV/HAJIYEV GOVERNMENT. THE VILLAGERS WERE THUS AT A LOSS TO KNOW WHY THEY WERE ATTACKED. SHALAZHI IS 2 OR 3 KILOMETERS FROM YANDI ALSO KNOWN AS OREKHOVO. A SEPARATIST STRONGHOLD. IN ANOTHER INCIDENT, ON MAY 5 A FEDERAL ARMORED PERSONNEL CARRIER ATTACKED A CIVILIAN AUTOMOBILE IN THE KALMIN DISTRICT OF GROZNY, KILLING THREE. A GOVERNMENT "EMERGENCY RESPONSE COMMITTEE" HAS BEEN ESTABLISHED COMPOSED OF FEDERAL AND LOCAL AUTHORITIES TO DEAL WITH SUCH INCIDENTS AND REFER THE CASE TO THE FEDERAL MILITARY PROSECUTOR (AS IN THE SAMASHKI AND GUDERMES INCIDENTS) IF THE FACTS WARRANT IT.

6. THE DUDAYEV SIDE HAS THREATENED MASSIVE MILITARY ACTION IN GROZNY ON 9 MAY, THE HOLIDAY COMMEMORATING VICTORY IN EUROPE. FEDERAL FORCES ARE ENGAGED IN HIGH-PROFILE MILITARY MOVEMENTS TO

COUNTER THESE THREATS AND AN OFFICIAL CURFEW WAS ESTABLISHED FROM 9PM TO 6AM. IT WAS ALSO NOTED THAT FEDERAL SECURITY SERVICE CHIEF STEPASHIN VISITED GROZNY RECENTLY. SENIOR AVTURKHANOV/HAJIYEV OFFICIALS HAVE TOLD US THEY HAVE RECEIVED DEATH THREATS RECENTLY. AN ASSASSINATION ATTEMPT WAS MADE 30 APRIL ON UMAR AVTURKHANOV, CHAIRMAN OF THE COMMITTEE OF NATIONAL ACCORD. HIS CAR WAS AMBUSHED AS IT TRAVELED FROM HIS HOME IN ZNAMENSKOYE TO GROZNY. AVTURKHANOV WAS NOT HOWEVER, IN THE CAR AT THE TIME, HE HAD LENT THE VEHICLE TO HIS BROTHER, THE ACTING HEAD OF CUSTOMS. THREE BODYGUARDS WERE WOUNDED IN THE INCIDENT.

7. AVTURKHANOV INTENDS TO PRESIDE AT A WREATHLAYING CEREMONY IN GROZNY ON 9 MAY TO COMMEMORATE THE ALLIED VICTORY IN EUROPE DURING THE SECOND WORLD WAR. RUMORS ABOUND IN GROZNY THAT THE CEREMONY WILL BE THE TARGET OF AN ATTACK BY DUDAYEV FORCES.

8. FEDERAL COMMANDER TROSHCHEV DID NOT ATTEND TALKS SCHEDULED TO TAKE PLACE IN NOVYYE ATAGI 4 MAY WITH DUDAYEV COMMANDER MASKHADOV.

9. THE ASSISTANCE GROUP IS CONTINUING ITS EFFORTS TO FACILITATE TALKS BETWEEN THE CONCERNED PARTIES. WE HAVE NOW MET WITH REPRESENTATIVES OF ALL SIDES. ALL HAVE ENCOURAGED THE GROUPS

IN ANTICIPATION OF ACTIONS MAY 9, THERE ARE CLAIMS THAT FEDERAL FORCES HAVE STEPPED UP THE CAMPAIGN TO DETAIN YOUNG MEN ON THE GROUNDS THAT THEIR AGE GROUP PROVIDES THE BULK OF THE DUDAYEV FIGHTERS. SOME OF THESE HAVE TURNED UP IN FILTRATION CAMPS. THERE SEEM TO BE TWO SUCH CAMPS IN GROZNY. THE ASSISTANCE GROUP HAS BEEN APPROACHED SEVERAL TIMES TO HELP TO FIND MISSING PERSNS. FAMILY MEMBERS HAVE ALLEGED BEATING AND INHUMAN TREATMENT OF DETAINEES. I HAVE REQUESTED ACCESS TO FILTRATION CAMPS FROM GENERAL SHUMOV, SENIOR REPRESENTATIVE OF THE FEDERAL MINISTRY OF INTERNAL AFFAIRS IN CHECHNYA. HE AGREED TO MY REQUEST AND I INTEND TO VISIT CAMPS IN THE NEAR FUTURE.

11. MEMBERS OF THE GROUP 7 MAY VISITED SAMASHKI, SITE OF A 28 APRIL ATTACK BY FEDERAL FORCES. PHYSICAL EVIDENCE INDICATED THAT SOME HOUSES ON THE OUTSKIRT OF TOWN WERE DAMAGED AS A RESULT OF BOMBARDMENT. HOWEVER, INSIDE THE TOWN WELL OVER A HUNDRED HOUSES BORE NO EVIDENCE OF DAMAGE ORIGINATING EXTERNALLY. RATHER, THEY WERE BURNED BY FIRES SET FROM WITHIN. TRACES OF HAND GRENADES EXPLODING INDOORS COULD ALSO BE OBSERVED IN MANY HOUSES. THE EVIDENCE IS CONSONANT WITH ALLEGATIONS MADE BY LOCAL RESIDENTS LIMITED OFFICIAL USE

THERE IS A DISPUTE OVER THE BUILDING THE LOCAL AUTHORITY HAS PROMISED THE HOSPITAL, THERE IS NO MEDICINE AND THERE IS NO EQUIPMENT. THE STAFF OF 400 IS ATTEMPTING TO PROVIDE URGENT ASSISTANCE BY MAKING MOBILE ROUNDS OF THE CITY.
