SUMMARY:

BUSHMAN requested LMTAS Legal to establish proprietary information agreements with [redacted] BUSHMAN seeks to receive "scientific data and video recording of experiments" from [redacted] According to BUSHMAN, the data and video pertain to successful exploitation of gravity/anti-gravity physics.

Inquiry disclosed [redacted] to BUSHMAN. How [redacted] became aware of these individuals is not yet known. According to BUSHMAN, [redacted] had arranged for the two of them to meet [redacted] in Prague, ferry him by some unknown mode of transportation to Holland, interview [redacted] and receive his data and video.

and ferry [redacted] back to Prague. At the direction of the company, this endeavor was not pursued. [redacted] did subsequently leave a "package" with the LMCO office in Prague; however, he was requested to and did return and retrieve the package.

NARRATIVE:

1) On October 8, 1999, [redacted] Weapon Systems Design, contacted [redacted] Associate General Counsel. [redacted] wished to discuss BUSHMAN's desire to obtain historical and scientific data and videos concerning "unusual laws" of physics from two individuals [redacted] located in the Czech Republic. [redacted] were concerned about the source of the data and video, the rights or authority of the holders to release the data and video, and the legitimacy of the two individuals holding the data and video.

2) On October 11, 1999, [redacted] reported that the information possessed is supposedly related to LMTAS's inquiries of Physicist [redacted] California State University at Fullerton, and what is known as the "Woodward Effect."

3) Research disclosed the "Woodward Effect" is a *theory* advanced [redacted] which apparently is an extrapolation from what is known as the *Mach's Propulsion Theory*. These theories appear related to the published*, but now apparently debunked and withdrawn observations of [redacted] Tampere University of Technology, Finland. Supposedly, [redacted] reported a coincidental observation and an "anti-gravity" effect during superconductor research and tests. [redacted] published a finding that reported the "anti-gravity" effect could be duplicated and measured; however, the report was withdrawn without comment or explanation and the findings were supposedly denounced by the University. (*)*Applied Physics Journal*, England's Institute of Applied Physics, Oct 1996.

4) Research also disclosed a [redacted] [redacted] Holland, Phone [redacted] wrote articles for the Fusion Information Center, New Energy News, The Institute for New Energy, 3084 E. 3300 South, Salt Lake City, UT, 84109-2154. Further, a [redacted] was discovered to be associated in some manner with the Kapteyn Institute, Department of Astronomy, Landleven 12, 9747 AD Groningen, Holland.

6) On October 13, 1999, [redacted] advised he discovered that [redacted] had put [redacted] into contact with BUSHMAN. Supposedly, the data held by [redacted] concerned translations of some form of ancient "sand script" and scientific experiments and data pertaining to anti-gravity generators.

7) On October 18, 1999, BUSHMAN reported that the information and data being sought is held by [redacted] and that there was no real interest in [redacted] BUSHMAN explained that [redacted] had arranged for the two of them to travel to Prague and meet [redacted] The three would then travel to Holland where they would hold discussions and receive [redacted] data and video tapes concerning gravity generators. BUSHMAN explained gravity generator's have an

"anti-gravity" effect much like the positive or negative fields of a magnet: when two positive fields of a magnet are brought into proximity with one another, each positive magnetic field resists or repulses the other. BUSHMAN said he was unaware of how [redacted] became acquainted with [redacted] but he believed [redacted] was a genuine doctoral scientist supposedly associated somehow with Prague University. [redacted] supposedly has conducted experiments and reports making five seemingly plausible new understandings or laws of physics and gravity. BUSHMAN said he simply wished to obtain [redacted] data and evidence to conduct an analysis of [redacted] representations to determine whether or not they were genuine and valid.

BUSHMAN said that although it was tempting to simply accept [redacted] data without regard to restrictions and laws that might be in place regarding the release and removal of the information from with the countries of origin where the data originated, without regard that others may claim right(s) and ownership of the data, and without regard to company policy and US laws concerning receiving potential proprietary information, he would wait until the appropriate agreements were in place before receiving the data. BUSHMAN noted that [redacted] had already left some data with LMCO's office in Prague, but that [redacted] had been directed to retrieve the data because no proprietary data agreements existed between [redacted] and LMCO.

8) Research disclosed BUSHMAN made the appropriate formal requests to the LMTAS Legal Office to arrange for Proprietary Data Agreements between LMTAS and [redacted] and [redacted]. In addition, it was discovered that BUSHMAN had made the required foreign contact reports to the responsible program security manager.

9) Record reviews disclosed the following pertinent information:

- a) Review of BUSHMAN's personnel and security folders disclosed, that with the exception of some classified security procedure and classified information mishandling incidents, no remarkable pertinent information or history of misconduct was associated with BUSHMAN.
- b) Review of [redacted] personnel and security folders disclosed a history of allegations of misconduct, violations of security and classified information handling procedures, and suspicious contacts with foreign nationals.
 - i) In 1985, the Pentagon Foreign Affairs Division reported a "concern" about information [redacted] had released. [redacted] released expositions to foreign citizens without an export license concerning Soviet armament inventory and capabilities that included information on US and its allies weapon systems.
 - ii) In 1986, [redacted] was suspected of forging travel receipts and inflating his travel claims during the period of July 1985 to August 1986 a cumulative \$11,808.00.
 - iii) In 1991, [redacted] was in contact with [redacted] Branch Manger, MiKoyan Design Bureau, 6 Leningrad Shoye, PO Box 125171, Moscow, Russia; [redacted] Passport [redacted] Alien Reg [redacted] SSN [redacted] Baltimore, MD, 21210; and others. [redacted] was suspected of inappropriately releasing information.

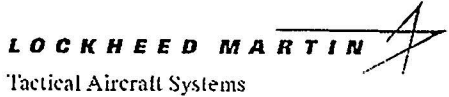

A clearer, more accurate version or translation of his given title and name might read something like [Redacted] Meaning Doctor (Ph.D.) [Redacted] (Special Position or Award) of Ing. (Electrical Engineer) [Redacted] (Last Name) of the [Redacted] [Institute Group of] Einstein, CR (Czech Republic).

[Redacted] has sent us another fax in which he identifies and explains formula and indicates that he is part of a team or group doing gravity wave research. Our special program section is very interested in receiving [Redacted] data, but are (supposedly) holding any contact with him in abeyance until our office and the Legal Department give them clearance to proceed. They are very interested in evaluating the science behind the assertions being made. Our department and the Legal Dept. have serious legal, political, and public relations concerns. 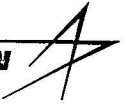

SUBJECT said he knew [redacted] and that he had approached her to assist him with a book he had written. SUBJECT said he approached her "just because I needed someone to edit the material." SUBJECT said he did not encourage her to join him in a joint business endeavor, but he did encourage her to capitalize on her talent and go into business for herself saying: "Happiness is a positive cash flow." SUBJECT said he considered [redacted] friend and encouraged her to capitalize on her talent and develop it into a profitable enterprise. SUBJECT said he did not believe that she took him to be a business partner.

SUBJECT said [redacted] had asked him to use his "pen name" as part of her business name. [redacted] said she wanted to use a masculine pseudonym because she perceived there was a "glass ceiling" and many would not accept a woman as an editor. SUBJECT said he [redacted] that he did not mind her borrowing his pen name.

SUBJECT said he had only used the pseudonym "Richard Daniel" as a pen name when he registered his copyrights of the two books he intends to publish at some time in the future. SUBJECT said he is a technical writer and the books still "require a lot of work before they are ready to be published." SUBJECT noted he had copies of the copyright registrations "stuck to his wall in his office" along with his patents that had been accepted and registered. SUBJECT provided a copy of the copyright registrations. (Copies of the copyright registrations are appended as Exhibits 1 and 2.) SUBJECT said that aside of the copyright registrations he had not used his pen name in any fashion.

SUBJECT asked if using a pen name could get him into trouble. SUBJECT was informed that ordinarily, in-and-of-itself, using a pseudonym to publish a book was not believed to be illegal. It was noted to SUBJECT that the only requirement immediately apparent pertaining to his use of a pen name would have been his need to notify the Defense Security Service of his pseudonym when completing his questionnaires for his security clearance. SUBJECT said he did not remember ever entering the pseudonym on his security questionnaires, explaining it had not occurred to him to do so. SUBJECT said it had not occurred to him to do so because he had never actually used the name Richard Daniel in any fashion but identifying the it as his pen name when he registered the copyrights for the books he intends to publish at some time in the future.

SUBJECT said that the two books still require a lot of work, with one of them needing at least another 77 pages of writing to be added. SUBJECT said that once the books begin to take a form where they are nearing readiness for publication, he must have them reviewed by the Company's and the Government's special program offices. SUBJECT said the books are a long way off from being ready and he may not have the time to finish them until after he retires. SUBJECT said he had not worked on them much since the early 90's because he has not had the time, and reiterated that he might not have the time he needs to finish them until after he retires.

SUBJECT said he may have mentioned his plans to publish a book to someone in the Company's special programs office sometime during the period of 1991 to 1996, but he said he never formally requested permission to publish the books because they had never been readied to the point that he could consider publishing them.

Details: (U) (S) On 02/17/2000, SAs [redacted] and [redacted] interviewed Lockheed Martin Tactical Aircraft Systems (LM) employee [redacted] regarding his knowledge of captioned matter. [redacted] has been employed by LM since 1978. [redacted] was advised of the identities of the SAs and the nature of the interview. He provided the following information: [redacted]

(U) (S) Around 09/1999, [redacted] observed a "crackpot" facsimile copy posted on the bulletin board in his work area at the LM facility in Fort Worth, Tx. Previous investigation revealed [redacted] is a Senior Specialist in LM's Business Development department. [redacted] stated he took the fax copy from a [redacted] and eventually showed it to fellow LM employee Boyd Bushman who appeared very interested in it. The fax dealt with [redacted] apparently revolutionary ideas about anti-gravity theories and the movement of large objects without regard to their mass.

[redacted] subsequently called the telephone number listed on the fax and spoke to someone who identified himself as [redacted] or identified the name of the business as [redacted] was unsure of who was identified as the speaker's English was not very clear. The conversation lasted four or five minutes according to [redacted] who also stated [redacted] comprehension of English seemed good. This was the only direct contact [redacted] has had with [redacted]

(U) (S) [redacted] stated he thought [redacted] or [redacted] had left a package at LM's Prague office on several occasions wanting LM personnel to review his material in the hope of entering into some type of joint venture with LM. The meeting was never held and the entire matter was held in abeyance pending further review by LM legal counsel. (U) (S) The FBI's national security responsibilities were explained to Bushman and he expressed an understanding of same. Bushman provided a DOB of 07/20/36 and a SSAN of 527-44-3323. Bushman stated he has been employed at LM since April, 1986. His LM title is Senior Scientist.

(U) (S) Bushman advised [redacted] (aka [redacted]) first came to his attention about three months ago when a LM "marketeer" by the name of [redacted] told Bushman about someone who knew of new methods to modify flight. Bushman then spoke with [redacted] over the

telephone for approximately five to seven minutes in an effort to check [redacted] out and ascertain if he knew "science languages" and thus was a legitimate scientist. Bushman stated that as a result of his conversation with [redacted] he believed [redacted] had some interesting ideas which Bushman wanted to explore further. Bushman wanted to establish a three-way non-disclosure agreement between LM, [redacted] was identified as the [redacted] a U.S. based publication. Bushman advised he has never met [redacted] but only knew of him through his publication. Bushman stated he thought [redacted] were working on similar projects but in "different directions" and by combining the knowledge of all three parties, a mutually beneficial work product might be achieved.

(U) (S) When the matter was directed to the LM Legal Department, Bushman was told to cease any further contact with [redacted] Bushman stated he did so and has had no further contact with [redacted] since the lone telephone call. Bushman expressed frustration with LM for not being able to pursue the matter further.

(U) (S) Bushman also advised [redacted] spoke very broken English and possibly needed further scientific input to complete his studies, which Bushman pointed out he did not give [redacted] also sent "two or three" facsimiles which Bushman said contained information pertaining to his studies. Bushman does not know where [redacted] resides, only that he thought it was in some "Slavic country".

(U) (S) Bushman advised he planned to meet with Zakl and [redacted] in Holland to discuss their mutual interests before the plan got scuttled by the LM Legal Department. Bushman stated it was his impression [redacted] wanted to come to the U.S. to further discuss his ideas. Bushman also expressed dismay over the fact that [redacted] had apparently sent a videotape of an actual example of his work to a LM office located in "Budapest or somewhere" but that it had been ordered returned unopened to [redacted] Bushman opined that [redacted] is probably working alone since any other European country would not have any interest in him. Bushman also advised he had "contacts" at LM who allegedly "checked out" [redacted] and said he was alright. Bushman did not elaborate on how [redacted] was checked out by his contacts.

Bushman, who had a telephonic contact with [redacted] in September, 1999, listed captioned subject's name as "[redacted]".
