1. I had several talks with Casey in London during my last trip and discussed with him, as you know, whether he would be interested to go to Germany as Chief of SI. He stated very emphatically that he would not be interested in such a post, mainly because he had no special knowledge either of Germany or of the German language. He stated, on the other hand, that he would much prefer, at the conclusion of his ETO duties, to return to the United States.

2. If you agree I hope that you will try to persuade him to return here to SI headquarters and become chief of the Division of Intelligence Direction or (as it is called in the German mission) the Steering Division, which will be composed at the outset of a scientific unit headed by Dix, a labor unit headed by Shaw (alternatively Blankenhorn), a unit dealing with safe haven matters so far as the responsibilities of the Branch are concerned, and a unit dealing with religious matters insofar as they affect world affairs. Included also is the new MO unit under SI administration headed by Stacy Lloyd with the assistance of Miss Halle.

The purpose of this unit is to try to achieve within the Branch something that you and I have discussed many times,

the direction of intelligence according to subject matter
irrespective of geographic lines.

I do not need to restate the great importance of this
part of our work. I believe that it is practically indispensable
to our best work and that the time has come to set it up.

3. Casey would work directly with me and be responsible
only to me within the Branch. I would myself give the best of
my time and thought to assist him. I further feel that this
particular assignment is exactly down Bill's alley, because of his
peacetime experience of managing a publication which in some
respects represents, in its field, exactly the type of enterprise
which I have in mind for OSS through this Branch.

4. If Bill does not want to commit himself to this
for the indefinite future, I would sincerely hope that he would
be willing to undertake it from the time of his return until the

6. Even at the risk of waiting a little longer for Casey's return I hope that you will approve the idea which we discussed on Sunday, namely that as soon as his ETO responsibilities are finished he should go straight to Sweden during the time that Tikander is still there and survey the situation on the premises (not in an ETO capacity) but as representing you and me and then come straight back to Washington with a concrete plan for future operations in Scandinavia, using either Sweden or Norway as a base. I think the short trip and survey might attract him and I also think that Bill has a special genius for this type of assignment. More than all else I am concerned that in Washington we need to have very specific recommendations from a man who has had almost unique training to make them.

b. Detailed narrative of the services for which this award is recommended:

The Office of Strategic Services in the European Theater of Operations, was ordered to secure by clandestine means military, naval, political and economic intelligence concerning the enemy. In order to accomplish this mission a Secret Intelligence Branch was set up within the Office of Strategic Services, ETO, whose duty it was to infiltrate specially trained agents into neutral countries and enemy-controlled territory, and thereby to secure reports on the enemy's strategic plans, tactical movements, and war potential.

Lt. CASEY was appointed Chief of the Secret Intelligence Branch on 1 December 1944. It was a crucial point in the development of espionage against the enemy. Throughout the previous summer and autumn the limited resources and personnel of the Branch had been directed towards operations against the enemy in France. Now it was apparent that the war would be carried into the heart of the German homeland, and that the Branch would be called upon to provide a far more detailed coverage of Germany itself than had originally been contemplated. Moreover, the requirements of the armies for strategic and detailed tactical military intelligence had to be coordinated with the needs of other intelligence consumers for information on political and economic matters, and it was necessary that all the resources at the disposal of the Branch be mobilized and redirected toward the new target.

With unsurpassed energy, imagination, and skill Lt. CASEY set about the complex task which confronted him. New personnel were obtained, special training courses were organized for agents who had previously been earmarked for other duties, and techniques never before believed practical were tested and successfully put into operation.

With characteristic foresight, Lt. CASEY realized from the start that the methods used to infiltrate agents into France and the Low Countries could not be employed against Germany, a country in which there was neither an organized underground nor a friendly population. In operations against Germany it was vital that agent teams be parachuted exactly on their pinpoints, and it was desirable that these drops be effected during the moonless period of the month. In order to realize this objective Lt. CASEY organized within the Branch an Air Operations Section which, after much experimentation with different types of aeroplanes and locator devices, finally succeeded in perfecting a method by which a successful drop could be made even under the most adverse conditions.

Lt. CASEY was well aware, however, that there was far more to an intelligence operation than mere mechanical perfection and ingenuity in parachuting an agent. The agent had to be armed with a

knowledge and information of conditions in Germany so detailed that he could merge himself into the population and escape detection while he went about the completion of his mission. Lt. CASEY accordingly developed a special reserach staff which was responsible first to provide agents with a "cover" story i.e. an ostensible explanation of his identity and occupation that would stand up under the closest Gestape scrutiny, and secondly to provide the agents with complete data on such details as travel restrictions, ration regulations, and other living conditions that would enable a stranger to exist in Germany without suspicion.

Realizing that the usefulness of any agent, however carefully trained, briefed, and dropped depended on the value of the intelligence he produced, Lt. CASEY turned his attention with equal foresight to the problem of providing his operatives with proper intelligence targets and objectives. With a mounting demand for all types of intelligence from a great variety of consumers it became apparent that the machinery then in use for briefing agents was unsuited to the requirements of the new situation. With tireless devotion to duty Lt. CASEY assembled and soon had at work a staff of expert analysts whose duty it was to analyse and coordinate the requirements of the numerous agencies serviced by the Office of Strategic Services, and to pass on to staff members charged with the handling of agents information as to exactly what was needed and in what priority.

Lt. CASEY's work was not confined purely to the active supervision of the operational side of the Branch's activities but also encompassed the broad and fruitful field of liaison with the British, French and other Allied intelligence services. With rare tact and understanding, close and happy relations were maintained by him with these services. Joint operations were mounted, and there was a mutual exchange of valuable information, all of which redounded greatly to the benefit of the American Armed Forces.

So successful was Lt. CASEY in these many and varied activities that from 1 December 1944 until the cessation of hostilities, more than a hundred agent teams were successfully infiltrated into such areas as Berlin, Hamburg, Kiel, Frankfurt, Stuttgart, Regensburg, Munich and Slovakia. The intelligence produced by these teams was of a high order and of invaluable aid to the commanders of the Allied Military Forces.

The substantial successes achieved by these secret missions can be directly attributed to the high quality of leadership and executive ability shown by Lt. CASEY. The accomplishment of his duties was far above that normally expected, and his perseverance in the face of apparently insurmountable obstacles, and untiring devotion to duty reflect great credit upon himself and the United States Government.

While rendering the services for which this award is recommended, Lt. CASEY was not wounded.

c. The accomplishment of the service for which the award is recommended extended from 1 December 1944 to 8 May 1945 and has been completed. On 5 January 1945 Lt. CASEY was placed on inactive status. The service was performed at Headquarters and Headquarters Detachment, Office of Strategic Services, London, England.

4. Proposed Citation: For the LEGION OF MERIT

Lt. WILLIAM J. CASEY, USNR (inactive), for especially meritorious achievement and devotion to duty.

During the period 1 December 1944 and 8 May 1945 while serving with the Office of Strategic Services, European Theater of Operations, Lt. CASEY rendered extremely valuable services which contributed greatly to the success of special activities carried on by the Office of Strategic Services in direct support of the Allied Armed Forces in the European Theater of Operations. Lt. CASEY's complete devotion to duty, his remarkable skill and foresight, and the great executive ability he displayed in the fulfillment of the duties assigned to him were in every way outstanding. The actions of Lt. CASEY reflect great credit upon himself and the United States Government.

5. In order to support this recommendation it has been necessary to divulge in the preceding paragraphs information classified as SECRET. However, the proposed citation has been made sufficiently general to permit publication of it separately with the classification RESTRICTED.



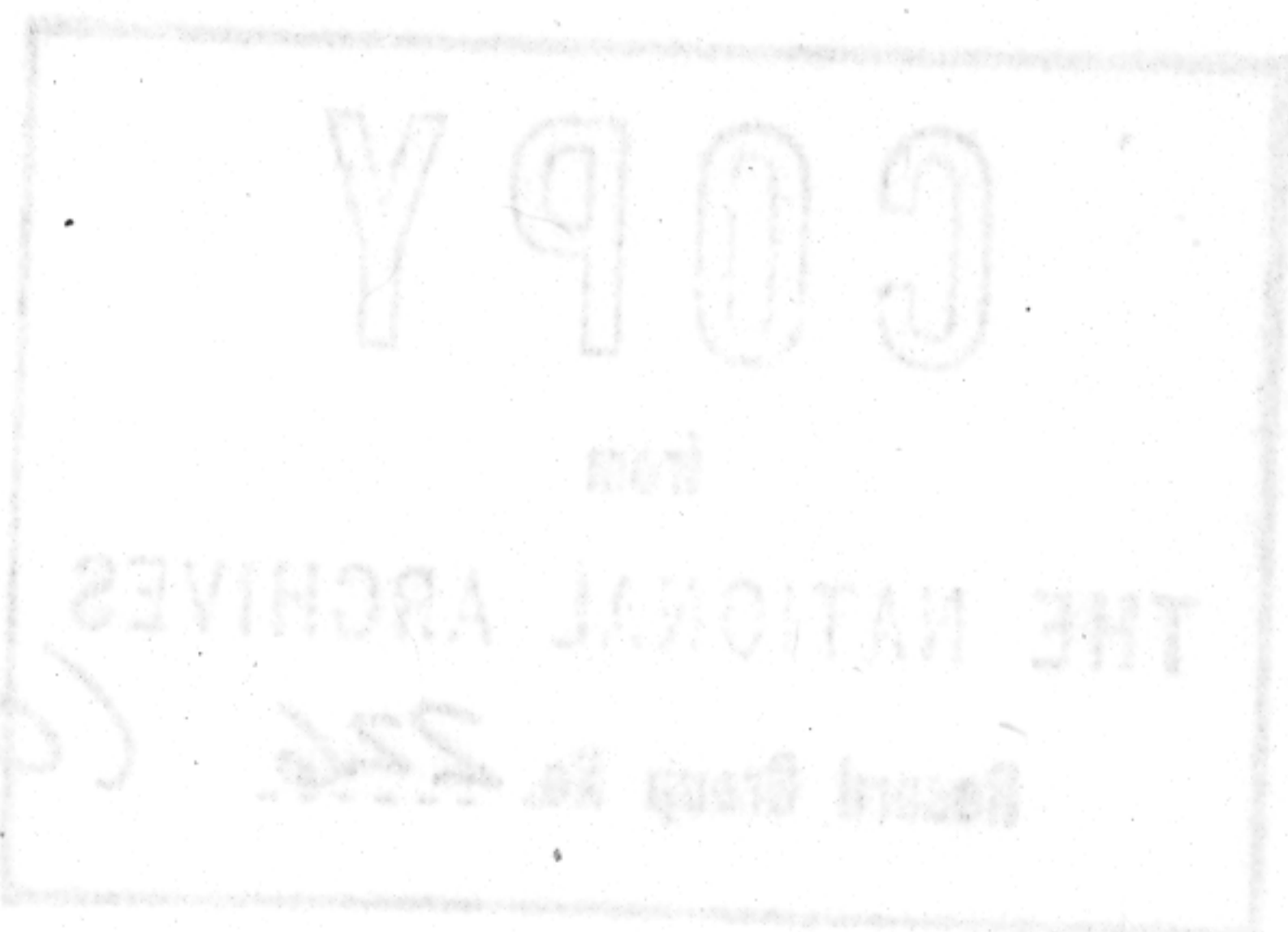

1. It is requested that inquiries be made to ascertain present status of recommendations for:
