Dear Mr. Greenewald:

This letter is a response to your Freedom of Information request for a copy of the FOIA Log for the Defense Information Systems Agency for 2016.

There were seventy pages responsive to your request. Portions of those pages have been redacted pursuant to 5 U.S.C. §552 b(6).

Due to the national emergency declared by the President in the aftermath of the terrorist attacks of September 11, 2001, the Department of Defense (DoD) has reviewed its policy regarding the release of names and identifying information of personnel not assigned to units protected from release by statute (10 USC § 130b). As a result of this review, it has been determined that release of lists of names of personnel would constitute a clearly unwarranted invasion of the personal privacy of those individuals. Accordingly, the information you requested is exempt from release pursuant to 5 USC § 552 b(6).

For any further assistance and to discuss any aspect of your request, you have the right to contact the Defense Information Systems Agency FOIA Public Liaison at 301-225-4116. Additionally, you have the right to contact the Office of Government Information Services (OGIS) to inquire about the FOIA mediation services they offer. If you are not satisfied with this response, you have the right to appeal to the General Counsel, Defense Information Systems Agency, P.O. Box 549, Ft. Meade, MD 20755 or by facsimile at 301-225-5010. Your appeal must be postmarked or electronically transmitted within 90 days of the date of this response. Both the letter and the envelope as well as your electronic transmission, should be clearly marked "Freedom of Information Act Appeal."
