MEMORANDUM OF AGREEMENT

**B** The [redacted] a non-profit corporation chartered by the [redacted], agrees to act as financial agent for [redacted], hereafter known as Sponsor, in connection with certain mutually agreed upon research grants under the following conditions:

**B** 1. A Special Bank Account will be maintained by [redacted] in which the principal sums involved in the above mentioned research grants will be lodged prior to final disbursement to the Sponsor's designated grantee. Photostatic copies of all bank statements and cancelled checks on this account will be furnished to the Sponsor as they become available.

**B** 2. [redacted] agrees that the contents of this Special Bank Account are at all times the property of the Sponsor; however, in order for [redacted] to live up to its legal obligations under the laws and regulations of the [redacted] relating to the conduct of non-profit foundations, manipulations on and the general handling of this bank account must in every case conform to the legally established practices of [redacted]

**B** 3. The [redacted] will make every reasonable effort to protect the interests and identity of the Sponsor of these research grants by handling them as much as possible in the same fashion as normal [redacted] grants; however, [redacted] cannot assume any liability beyond reasonable care and attention in this respect.

**B** 4. [redacted] further agrees to provide the Sponsor with copies of correspondence relating to the research grants for which it is acting as agent. When such correspondence consists of accountings for funds disbursed by the grantee, reports of work done, or other statements of fact [redacted] assumes no responsibility for the completeness or accuracy thereof. In addition, [redacted] will assume no responsibility for the reliability, financial or otherwise, of any grantee selected by the Sponsor. Finally, [redacted] agrees to use its offices as far as is possible to locate personnel and facilities of interest to the Sponsor in the conduct of its research program.

**B** 5. If, for any reason, funds which have been disbursed under this agreement by [redacted] are later returned to [redacted] such funds will be held in the above mentioned Sponsor's bank account for final disposition according

**B** to the Sponsor's specific instructions; except that any such instructions must be, in the opinion of ~~the Sponsor~~, in keeping with its usual manner of doing business and its legal responsibilities.

**B** 6. If, for any reason, a controversy should arise between the Sponsor and the final recipient of a grant as to disposition of funds, terms of agreement, etc., ~~the Sponsor~~ will limit its participation in such a disagreement to transmittal of appropriate requests and offers between the two parties. It will not undertake to mount or participate in any legal action or other coercive measures which the Sponsor may advocate.

**B** 7. In view of the costs related to the foregoing considerations, ~~the Sponsor~~ will require payment by the Sponsor of a fee amounting to 4% of the principal sum of each grant handled during the life of this agreement.

SUBJECT: MKULTRA Subproject 72

1. The purpose of Subproject No. 72 is to initiate research work on the neurophysiological and pharmacological effects of central nervous system antagonists and synergists.

under the auspices of [REDACTED]

2. The scope of [REDACTED] program will include the following:

A. To determine the neurophysiological and pharmacological action upon the CNS of unknown drugs assayed against known effects of standard drugs with CNS activity.

B. To develop a systematic method of testing and characterizing pharmacological agents both in terms of symptomatology produced and in terms of describing potency in producing given effects by means of standardized and valid statistical procedures.

C. Act as a pharmacological consultant on problems inherent to TSS/CD projects at the request of TSS/CD.

D. Review of overt American pharmacological literature on problems of specific interest to TSS/CD.

3. It is expected that [REDACTED] from the standpoint of TSS/CD interests, will be able to monitor, direct and actively participate in this project from the [REDACTED]

4. The cost of this program is estimated at a cost of \$41,382.00 for a period of one year. To this sum must be added \$1,655.28 representing a four percent service charge to the [REDACTED]
