1. On 22 and 23 June 1955, the undersigned visited the physical site of Project [REDACTED] for the purpose of determining what action and accountings would be necessary to close the activities which categorized this operation as a project subject to 9.4 of the

2. The undersigned outlined a small accounting system to be used for the continuation of the research work, regarding receipts and expenditures. A method was also devised whereby the unexpended 1954 allotment grants made to [REDACTED] will be fully accounted for as part of the final accountings under the Administrative Plan. Arrangements were also made to return on 30 June 1955, any unexpended petty cash funds on hand of [REDACTED]
