Comment:

This particular operation was mentioned in general terms to the writer by the second approximately thirty days ago on an informal basis but no significant details were given at this time.

While the technique that a set of the varies are considering for use in this case is not known to the writer, the writer believes the approach will be made through the standard narco-hypnosis technique. Re-conditioning and re-orienting an individual in such a matter, in the opinion of the writer, cannot be accomplished easily and will require a great deal of time and the \pm fact that an interpreter is necessary in the case complicates it considerably more. It is also believed that with our present \pm knowledge, we would have no absolute guarantee that the subject in this case would maintain a positive friendly attitude toward us even though there is apparently a successful response to the treatment. The writer did not suggest to that perhaps a total amnesia could be created by a series of electro shocks, but merely indicated that amnesia under drugx treatments were not certain.
