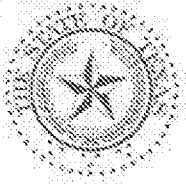

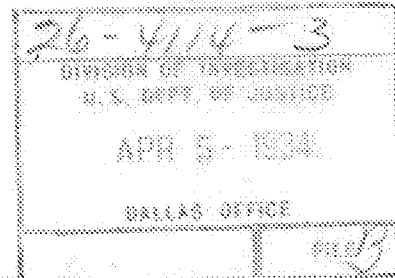

The following are a list of findings that we have
at hand:

- Monday April 2, 1934. 9:30 A.M. Raymond Hamilton and woman companion sighted near Alford on Highway No. 2, between Alford and Sunset out run two Patrolmen Roush and Bouldin and disappeared near Sunset. At this time the Patrolmen could not learn whether the Automobile came through Sunset or not. Later they learned that an automobile of this description picked up a hitch hiker in the streets of Sunset.
- Monday April 2nd. Ford sedan A15-939 found abandoned in Sunset. Car belongs to Joe Chamblis, Wichita Falls. This automobile was reported lost by Chamblis about 2:30 P.M. who said the automobile disappeared the night before about 10:00 P.M. Report that Chamblis picked up the automobile at Sunset about 3:00 A.M. April 3rd and drove south and returned to Sunset the same day but several hours later or about 10:00 A.M.
- Monday April 2nd. Between 8:45 A.M. and 9:15 A.M. a man and a woman driving a Ford V8 Sedan or Coach took mail from the box of Harry V. Gill, M.P.D. #2, Sunset, Texas. Kept the daily papers and threw away the other personal mail about one-half mile from the mail box and north. The road that they were traveling was the Alford and Forestburg road. We believe this car is the one driven by Barrows. Mr. and Mrs. Gill witnessed the theft of the mail from a distance of about 100 yards. Among the things that was not kept by the Barrows was a government pension check.
- Monday April 2nd. 4:00 P.M. Two persons identified by pictures as Bonnie Parker and Clyde Barrow bought Gas and Coca-Cola at a Texas Company Service Station on Highway No. 2 between Henrietta and Kinggold. Left station headed in the direction of Henrietta but do not know how far they traveled in that direction.

We have investigated this information and believe it is all correct. Please hand this to Dallas Police and Department of Justice.

From Jefferson City, Mo., State Highway Patrol:

"Advise you that we are concentrating our men in the Southwestern part of Mo. and along the Western border from Joplin to Kansas City. The Kansas State Highway Patrol are cooperating with us on the Kansas side. We have not had much adequate information from this area. Our last report was that a car answering the description of the one in the shooting at Commerce was seen at 2 o'clock this afternoon near Bartlett, Kansas. This is down around Coffeyville, Kans. We had a report about 1:30 that a car answering the description of the one hunted was seen at Minden Minea; that is just across the line in Mo. about 25 miles North of Joplin; but the Sheriff of that county investigated that report and says that he believes that it is just another myth. We are doing everything in our power to catch those birds. Any suggestion from your office will be received with an open mind and willing heart. Have you heard anything later on the murder."

Telephone message from A. W. Miller, Highway patrol, at Sheriff's Office, Charleville, Texas:

Mr. Miller said he is working territory between Texarkana and Paris, Texas, watching Red River crossings with J. W. Chapman (Highway Patrol) under instructions from Captain Hamms.

Mr. Miller said the Red River is $\frac{2}{3}$ up its bank, and since Thursday last, crossing has been impossible and will be impossible for 3 or 4 days more. The ferry at Texarkana and all ferries that vicinity have ceased operating because of heavy rains. The only possible crossing would be Texarkana and that not likely.

The bridge 25 miles east of Charleville is washed out, however they report they have kept watch there.

Miller reports that Dudley Castleman of Detroit, Texas (who is brother of the Castleman who served term with Clyde) claims to know Clyde Barrows personally, and said he (Dudley Castleman) saw Clyde at Detroit last Wednesday 4-4-34 headed East.

Miller requested that above message be given Captain Hamner.

Miller says the roads, except main highways are still very muddy in vicinity of Clarksville, in fact everywhere between Paris and Texarkana.

Mr. D. Brantley telephoned from Oklahoma City, Okla. that he and his men, with assistance from the Police, have checked all clues and have, in short, lost trace of Clyde Barrow and Bonnie Parker.

That he has kept close watch at Chetopa, Kan. and Coffeyville, Kan. He had the place of one Ab Clark, uncle of Jim Clark, three-
turner and former subject I.O. #1192, ~~was~~ possible hide-out for Clyde
and Bonnie. Ab Clark lives near Chetopa, Kan. No clues were found.

That James G. Allen, Chetopa, Kan. mail carrier, had reported having seen couple resembling Clyde Barrow and Bonnie Parker at 10:30 a. m. 4/6/34, about one and one-half miles East of Ab Clark's home, travelling in a muddy V-8 Ford Sedan.

That Clyde and Bonnie were reported seen at 11:30 a.m. at a Filling Station near Mound Valley, Kansas.

That Clyde and Bonnie were reported seen about 1:30 p.m. near Weir, Kansas, East of Mound Valley, going toward Pittsburg in an Easterly direction.

That Mr. and Mrs. J. E. Varbel, residence 2131 North West 39th Street, Oklahoma City, Okla. reported that they were in a Cafe in West Oklahoma City, last night 4/5/34 about 8:45 p.m. and noticed a couple come in and order 6 sandwiches, proposing to eat two and carry the rest with them. Varbel reported they mentioned friends in Joplin, Missouri. The woman glanced at headlines of newspaper and the couple left the Cafe without eating and carrying food with them. Mention was made of a Tourist Camp near Hutchinson, Kansas.

Varbel gave following description of suspicious couple:

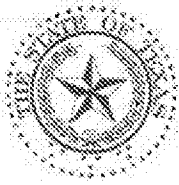

On April 8, 1934, while in Waxahachie we were informed that Clyde Barrow's relatives on the Trinity river in the edge of Kaufman County have about 200 rounds of ammunition waiting for Clyde Barrow should he ever be able to come by and get it. We were also informed from this source at this time that Barrow spent part of the night in the woods near this place after killing Wheeler and Murphy. An afternoon or extra newspaper from Dallas was found there bearing the story of the killing. The information was that Hamilton met the Barrows here as it was designated between them as meeting place #2 in case #1 should become hot. The information is that Hamilton and Barrow leave messages at this place for one another.

We got under cover information that Barrow left the state near Waxahachie and upon arriving there we found that this information checked with that in possession of the Dept. of Justice agents.

As much time and effort is being devoted to this case we are asking that you allow Walling and I to devote all of our time to this particular lead for a time. If you desire we will report the information that we obtain here each day. It seems best that this matter be given no publicity to any one as only a small number of officers will be needed to handle the situation in case it works out.

Upon information from an informant here in Paris, I am in receipt of information the roads Clyde Barrow uses in approaching Dallas from this vicinity.

When Clyde Barrow robbed the filling station in Hugo, Oklahoma, on or about February the 15th which was about three days after he liberated Raymond Hamilton from the Penitentiary, he robbed this station in Hugo and went East to Idabel, Oklahoma and then across the Bryarly Early Ferry crossing to Springhill, then to Faught and into the edge of Paris on the old Pine Mill Road missing town and going to Hoxton, Ledonia, Wolfe City and then into Rockwall, all on country roads and lateral lanes.

I can take care of the patrolling of these roads.

I am also in receipt of information when he comes into Texas through Denison, he goes from Denison to Sells, then to Whitewright, Celeste and Leonard into McKinney and Rockwall.

I am giving you this information so that the Patrolmen in Sherman can watch this road.

I am also in receipt of information that Clyde Barrow stays three or four days at a time in Sapulpa, Oklahoma, which is about 20 miles from Tulsa. Upon one occasion I have been informed that he stayed at a boarding or rooming house in Sapulpa, operated by a woman named Mrs. Cline. I could be mistaken on this name.

This memorandum covers period from April 7th to April 11th. During this period Agent was engaged in guarding the toll bridges across the Red River at Fulton and Index, Arkansas, with Special Agent Birch of the Oklahoma City office and officers of the Texas Highway Patrol. A 24 hour watch was maintained for Barrow and his Party. Nothing irregular occurred.

April 10th, following telephonic instructions from S. R. C. Blake - Agent with Sam Hillbourn, Highway Officer interviewed George C. Bailey at Arnic, Oklahoma. Bailey is a special deputy sheriff operating sawmill at Bokhara, Okla. and residing at Foreman, Arkansas. He stated while driving from McCallister the preceding day he saw a Pontiac Coach or Sedan about one mile East of Willerton, Okla. stopped at a house known as a roadside house of prostitution. The car was being loaded with groceries and had clothes. It contained three men when finally driven off. Bailey believes it was Barrow's gang. Place is noted as Criminal hangout and girls working.

Bailey described the men - one 6' tall wgt about 200 lbs. hair thin, other 2 medium height, about 145 lbs. all bare-headed and dark. He tried to follow their car but lost it. Bailey is not impressive and his books do not foster much credence in his story.

John Dwyer - Ex Communist, now in jail at Marshall, Texas was interviewed. He stated that on Wednesday before the Sunday the Highway officers were killed at Dopevine, he was in Longview, Texas. Early that night he dropped into a restaurant on E. Tyler street across from LaPage Motor Co. (Chevrolet) and there saw Henry Methum whom he had known in the Texas Pen. They drank a cup of coffee and talked; then went out in front and Clyde + Bonnie drove up in a 1932 V8 Coupe - black - with Texas license. They spoke to him and Bonnie asked Methum if he were ready. Methum got in. Dwyer told Clyde he would like to talk to him and Clyde said "I'm in a hurry now but I'll be back in about

ten days". They drove down West Tyler Street and turned off like they were going toward Shreveport. Jory says he got no information from Methwin indicating where they were going, and has no idea where they are now or whom they will contact. He states he knows of a hangout near Carlboro, Oklahoma but has never been there and can give no directions; also at 430 E. 5th Street Oak Cliff where Clyde use to buy liquor from a bootlegger named Sam Clark. He does not believe Clark would give any information.

The following information was given to Field Inspector Mayr, of the State Highway Patrol, in the Sheriff's Office at Waco on night of April seventh by Bailey Tynes, 1631 S. 30th Street, Waco, who is a cousin of Clyde Barrow:

D. Brown - Clyde's cousin - lives about 15 miles southeast of Hockley.

Frank Brown - brother to D. Brown - also a cousin of Clyde - lives on Nettie Lee's place close to his brother D.

It appears that there is a back road leading from Logansport to D. Brown's place that does not pass through any town or village. Both D and Frank Brown are described as very dangerous characters and will go to limit in shooting at sight.

Another cousin by the name of Jim McElroy lives on next farm or close to D and Frank Brown.

Bonnie also has an aunt, Mrs. Browning, who is in this same neighborhood or close to Martinville.


Clyde has an uncle by the name of Walt Walker, who is an ex-convict and considered to be very dangerous, who runs a filling station 1 mile east of Conroe.

Three miles south of Hockley in Dallas County is another cousin of Clyde's by the name of Charles Walker.

At McGregor, Texas, is an aunt of Clyde's, a Mrs. Whiteside, who is a sister to the Walkers.

Also Clyde has an uncle who lives between Mt. Calm and Hubbard City by the name of F. Lambert.

I have also been reliably informed that Clyde has an uncle living at Carlsbad, New Mexico. I do not know this party's name but he is well-known to the Sheriff at Carlsbad. Information regarding the Carlsbad uncle has been given to the New Mexico Highway Patrol and they have assured me that this place will be watched by them.

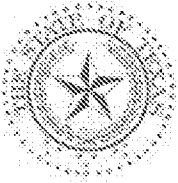
On arrival Tyler tried to check on woman called Bertha, as asked for by Capt. Hamm, but unable to learn anything.



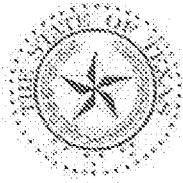

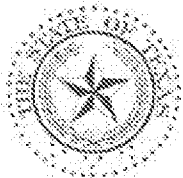

I gathered this information from G. C. Stevens, a very close friend of Mr. Henry and Mrs. Tunie Barrow who live at West Dallas and run a Filling Station on Maple Wood Road. He says Frank Barrow lives in Navarro County, this is Clyde Uncle. He was in the house of Mr. and Mrs. Henry Barrow when Clyde robbed the Grand Prairie Bank. Mrs. Tunie Barrow made the statement that she had to get to Uncle Frank's place in Navarro County, as that was where Clyde would hide. She made preparations to leave despite the fact that her husband's warning not to go and did leave.

Clyde has a cousin in Tyler named Bertha Graham, who operates Meggy's Beauty Shop. She is a daughter of Frank Barrow.

He also has a relative in Centre named Mrs. Tucker who runs some sort of Joint. This Mr. G. C. Stevens states that Barrow spent three nights there some time back.

Mr. Blake of the Department of Justice is familiar with this information to some extent and knows that Mr. G. C. Stevens has agreed to go and live with Barrow's people for a small compensation, a suit of clothes and etc. I gathered this information Thursday Night and Sp.m. and Friday morning at 7:30. Mr. Stevens stated that he would go with me at anytime to Dallas, if called upon to do so.

On Thursday, April 5th, Patrolman Gibbons and I investigated a report that Clyde Barrow bought gas from a Filling Station here in Paris Wednesday, April 4th.

This Filling Station operator would not report this to local officers. The Filling Station operator, J. P. Leavy and Doc Brannon, who operates this Station across the Frisco Tracks on Bonham Street going west out of Paris, said that this car came into the Station from the east and came being a V-8 Ford, black in body color with yellow wheels with Ohio License Plate and the windshield had mud all over it except where the windshield wiper cleaned it off. The man in the car gave the operator orders to check the oil and fill the gas tank and "Be in a hurry about it". Mr. Leavy reached on the inside of the windshield and started cleaning the windshield and almost got into trouble. In leaning inside the car he noticed an automatic pistol between the seats.

I showed the latest pictures of Barrow and Bonnie Parker to these two men and they were positive of the identity. The car after leaving the Station headed east on Highway #5 towards Clarksville. Since I have been in conference with Patrolman A. W. Miller, he stated that one Victor Casselman who is an ex-convict came to Sheriff Ross Sudley of Clarksville and told him that Barrow had passed through Detroit, Texas, about 4:00 P.M. April 4th. This couple left the Station in Paris about 3:30 P.M. Victor Casselman served a term in the Penitentiary with Clyde Barrow. This checks with reports that Barrow robbed and kidnapped the Filling Station operator in DeKalb on the same date. Patrolman

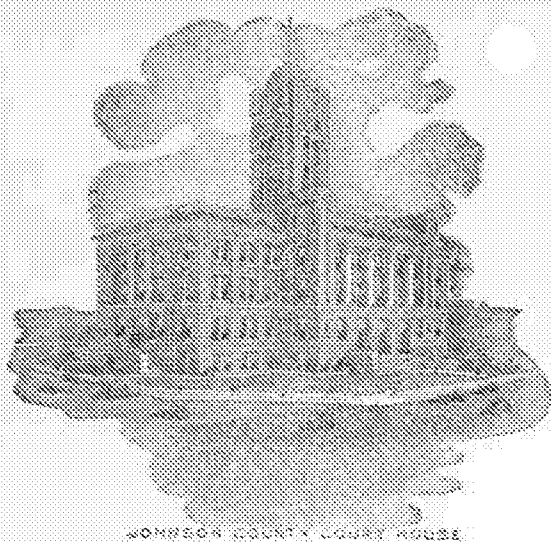

In regard to report of car stolen Shreveport on April 10 1934. This car was reported by the City Police of Shreveport to the City Police of Texarkana at seven o'clock P.M. and the report from Atlanta came in to the city police at Texarkana at eight o'clock. L.P. McDonald took the call from Shreveport and Ray Yocom took the one from Atlanta. The car reported from Shreveport was a black V8 Ford sedan 4 doors Mtr. # 804065 404065 La. lic. No. 233-716 and was reported as stolen about 6.15 P.M.

The report from Atlanta was that Clyde and Bonnie stopped and bought gas and had their oil checked but that they put their own oil in. They were driving a black four door V8 Ford sedan and seemed very nervous, these people were very positive that this was Clyde and Bonnie and it seemed that it was good dope as this car was reported stolen from Shreveport just about long enough to be in Atlanta. This car in Atlanta was supposed to have a 1934 Ark license on it number unknown. On these reports Herbert Weeks Albert Chilcote and myself went to Sulphur river, the City police and the sheriffs department were supposed to cover the road. We had just got to the river and Herbert went a station to telephons when a car of this description came up and started to stop but saw our car and drove on but was still driving slow. We called Herbert and he came out and drove out on the road about 400 yds. behind the car, they let us stay about this distance for about a mile and then they run off toward Texarkana, they drove much to fast to be overtaken in a 31 Chev. When we arrived in Texarkana we had not seen any of the City police or any of the sherriffs department from the time that we left the river. There is several roads that they could have turned off and have missed Texarkana and we could not get any trace of them.

At three A.M. Walter Huffman deputy sheriff from Marshall called me from Marshall and said that a car answering this description came in to Marshall and stopped at two different places and headed out North toward Texarkana but that he did not think that it came this way but that it doubled back.

Every one in this country thinks that they see Clyde and Bonnie on every corner and we are trying our best to check all of it. It is some job as most of the officers are scared that they will see them.

It has been reported to us that Clyde has a uncle between here and New Boston and we are checking on that and will let you know if we learn anything.

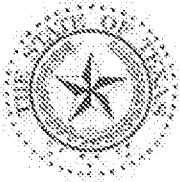

The writer was advised by Fred Hickman, Captain, State Highway patrol, Wichita Falls, that his men and the police department have been keeping close surveillance on Joe Chambliss father of Mary Chambliss, the latter being with Raymond Hamilton, with a view of locating Mary Chambliss, Raymond Hamilton and Clyde Barrow and Bonnie Parker. During the day Joe Chambliss stays at the home of Beula Preter located in the rear of No. 409 Scott Street, Wichita Falls, and after dark Chambliss drives his car to his wife's farm on Petrola Road just beyond the city limits of Wichita Falls, Texas. It was decided to attempt interview Chambliss.

In company with Captain E. E. Wyatt, Special Agent for the Fort Worth and Denver City Ry, who appears to have the best contacts at Wichita Falls, the writer proceeded to the premises occupied by Beula Preter, located in the rear of 409 Scott Street, and there found Joe Chambliss.

Upon interview by the writer Joe Chambliss denied that he was directly or indirectly in communication with Raymond Hamilton since the latter's escape from the Eastham farm, that he did not know that his daughter Mary Chambliss was with Raymond Hamilton until he received this information from Denver Seale, Investigator for the Dallas District Attorney's office and State Rangers. He stated that the last time he saw his daughter Mary was when she called at his wife's farm about the end of March, that at that time she was accompanied by her husband, Barney Pitts, that Mary and Pitts came to the place in a taxi and remained about 15 minutes. When they left they did not say where they were going. At the time Mary picked up some clothes she had at the place. No mention was made of Raymond Hamilton, Clyde Barrow or Bonnie Parker.

Joe Chambliss stated that he is 44 years of age, married his wife Elmira Morris about 26 years ago at Albany, Stevens County, Texas, that they have six boys and three girls; viz Odell Chambliss 26, now confined in Huntsville on a sentence of 33 years, Arnold Chambliss 21, confined in Huntsville on a sentence of 5 years, T. P. Chambliss, 20, employed on a farm at Wichita Falls, Joe Chambliss 18, Artie Chambliss 10, Marmon Lee Chambliss, 4; Nona, W. Clary V. Mary 10. He stated that Mary Chambliss worked in the Indian Chief Cafe at Wichita Falls, at which place she became acquainted with Gene Adair, and married him at Wichita Falls, that after Gene was sentenced to the penitentiary Mary secured a divorce and married her present husband Barney Pitts, who is a bootlegger. Joe Chambliss stated that he was also a bootlegger, having been twice convicted in Federal court for possession of whiskey. Before coming to Wichita Falls, Joe Chambliss stated that he leased and operated the Rex Hotel atampa, Texas, that while Mary his daughter and Winnie Wolfe, a friend of the family lived at his home, that he left Tampa about 3 months ago for Wichita Falls, after operating the Rex Hotel at Tampa for about three years.

Joe Chambliss stated that on March 28, 1934 he purchased from Louis Broeder a Ford Sedan, model A, bearing 1934 Texas license plates A15939, that he paid \$95, cash for the car, which money he obtained from the sale of an old Buick Pontiac car, and the winnings in a poker and dice game. He denied receiving any money directly or indirectly from Raymond Hamilton or Clyde Barrow.

On Sunday April 1, 1934, the day the two State Highway officers were killed near Grapevine, Texas, Joe Chambliss stated that he was drinking and parked his car on seventh Street, Wichita Falls, that the car was stolen about 10 P.M. that night. The records of the Wichita Falls police dept show that he only reported the theft of the car at 2.30 P.M. the next day, April 2, 1934, the report reading that car stolen 10P.M. The sheriff's office received a report from Beula Prater, the woman with whom Joe Chambliss is now living at 6.30 p.m., April 2nd, at which time Deputy sheriff White advised that the car was found at Sunset, Texas. Chambliss stated that he was still under the influence of liquor and had Beula Prater hire a four three taxi cab, that he and Beula drove to Sunset and arrived there about 3 a.m. April 3rd. After getting the car from the police, they continued in it, Beula driving until they reached the home of Tillie Hudson, a sister of Beula Prater, located East of Decatur, and remained there until the next day when they returned to Wichita Falls. Captain Rickman advised that this has been checked and found correct.

Joe Chambliss stated that Beula Prater is divorced from her husband Hugh Prater, a farmer who lived at Bowie, Texas, six miles East on the Hecox road.

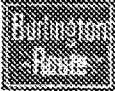
Glen Bridges, brother of Beula Prater lives with his wife Anastacia Bridges in the same house at 409 Scott Street (rear). He is a brother of Emanuel Bridges, who is a pimp according to Joe Chambliss. Emanuel Bridges was convicted of the Ryan case at Amarillo, Texas years ago and sentenced to serve 5 years at Leavenworth. Otis Bridges, the wife of Emanuel Bridges, who now lives at 212 1/2 Main Street, Fort Worth, Texas was convicted of mail robbery in 1927 or 1928 according to Joe Chambliss and sentenced to serve 18 months at the Federal women's prison, Alderson, W. Va.

named Betty Bridges

On January 30, 1934, Emanuel Bridges and the prostitute, ^{he is living with} were arrested at Wichita Falls, Texas at the American Hotel for disturbing the peace. After release, they went to visit Mrs. Inez Tate, a sister of Emanuel Bridges, who resides with her husband at Amarillo, Texas.

Joe Chambliss stated that when his son Orell Chambliss got in trouble, he promised and agreed to have him surrender to Frank Jordan, constable at Pampa, Texas, that he would good his promise. He stated that he now realizes that his daughter Mary is in the company of Hamilton, a desperado, and was advised by Danyor Seales that she and Hamilton are associating with Clyde Barrow and Bonnie Parker, that sooner or later they all will be killed by the officers, and rather than have this happen to his daughter, he stated that he shortly expects to hear from Mary, who usually communicates with him when she is away from home, that he will arrange to see her and persuade her to leave Hamilton and if necessary report to the Division office at Dallas, Texas. In this connection Joe Chambliss requested the address of the Dallas Division office. The writer furnished him with the same, and the telephone number, and Chambliss promised that as soon as Mary was contacted by him, he would immediately notify the Dallas Division office. He stated that he will do everything possible to try and induce her to surrender Hamilton, and if it can be done to spot Clyde Barrow and Bonnie Parker, as he now realizes that Mary is responsible for getting the "heat" on him, his wife and possibly relatives.

Captain W. E. Wyatt, Special Agent Fort Worth & Denver City Railway company furnished the following information:

He stated that one Roy Gordon, who lives at Decatur, Texas, whom he considers a confidential informant, advised that a woman named Stone who also goes by the name of Browning owns a farm about three miles East of Alvord, Texas on the old State Highway. The house is located about ~~two~~ three-quarters of a mile north of the highway. This woman formerly operated a rooming house at Wichita Falls, Texas. She is about 40 years of age, good looking woman. Gordon states that he is acquainted with two girls, one named Ruth Ward, whose maiden name is Ruth Mc Whorter, and the other one Nellie Leman. The latter girl ran around with Glen Honeysucker, before he was killed in New Mexico. These girls now reside at 3717 Live-oak Street, Dallas, Texas.

About the 15th or 16th of February, the above named girls attended a dance at the house of Mrs. Stone, alias Browning, located three miles east of Alvord, Texas. They told Roy Gordon that Bonnie Parker stayed with them in Dallas, Texas at times, and they stated that Bonnie told them that she and Clyde Barrow stayed on the above mentioned farm, about ten days before the delivery of Raymond Hamilton et al from the Eastham Farm, Texas. They furthermore told Gordon that the Chevrolet Sedan that they came in ~~from~~ from Dallas was a stolen car. Roy Gordon stated that he saw some carpenters tools in the back seat of the car.

According to Roy Gordon, old lady Stone or Browning at the present time two men living on her place named J. L. Finlon and W. L. Doyle. District Attorney, Wise County, Texas stated that these men's reputations are very bad.

Captain Wyatt advised the writer that he talked to the District Attorney at Decatur, Texas about the place. He stated that Mrs. Stone had a new frame house built on the place in 1931. This house has a solid concrete basement. In 1935 Mrs. Stone built another house about 200 to 300 yards from the other one.

Captain Wyatt stated that he considers the information furnished by the informant to be reliable, and suggests that if the two women named above are contacted through Roy Gordon, who is very friendly with them, it might result in locating Bonnie Parker and Clyde Barrow.

At about 7:00 PM on April 17, 1934, a Mr. D. Spector, young contractor of Orange, Texas, who is now engaged in razing the Plaza Hotel Building in Port Arthur, Texas, passed a sedan automobile on the Orange-Port Arthur Highway four or five hundred yards East of the Naches River Ferry. Mr. Spector could not describe the car except to state that it was a dark-looking sedan and occupied by a small-sized man and a small-sized woman. He could give no further description. After passing instant car, which apparently had just been ferried across the Naches River near this place, he found a ladies suitcase, which is described as a wheary-made bag - airplane luggage. This was labeled on the inside of said bag.

Mr. Spector advised that he took this bag on to Orange, Texas, with him that night, examined the contents and discovered certain wearing apparel in the bag and a ladies purse which had the name of Audra Hamilton printed therein; that he returned the instant bag to Chief of Police H.F. Baker, Port Arthur, Texas, at 2: PM, on April 18, 1934, whereupon Chief Baker immediately communicated with the Dallas Division Office and with the writer, who was then in Beaumont.

The writer proceeded to Port Arthur, Texas, and examined the bag and its contents, which are as follows:

1 black ladies leather purse, size 21 inches long, 17 inches wide, 8 $\frac{1}{2}$ inches deep, trimmed with one black and one white celluloid dogs on the top. 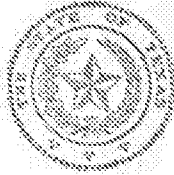

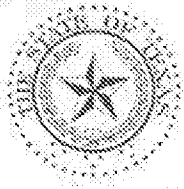

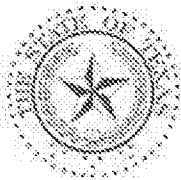

A few days ago, the man who was showing Froese all over Ellis Co. was here, said he was enroute to Shreveport. Was mad with everyone, said if he had a little money could find Barrow, said that the Dept. of Justice at Dallas was passing up the best bet that they had. That there was a man who worked in the Pressing and Tailor Shop opposite the Post Office, Dallas, who was Barrows best contact man; that the D. J. boys patronized this shop, and that this man could make contact with Barrow. I forwarded you this info verbally by John Gregory. Doesn't sound right but am letting you have it.

On Sat. Saturday, one T. D. Dunlap, Overton, Texas, was, his story, hijacked on No. 37, between Tyler and Swan; said he pulled up by a parked 1933 Chev. green, Okla Lic., with two tail lights, offered help. That in car was a man and woman; that man, who he says was Clyde Barrow, jumped out, beat him up and took about \$20.00 from him. He telephoned in and the road was watched for this car in bound to Tyler, also phoned Arp and Gladewater on same. Think story the Dink, probably woman trouble but unable to locate any such green automobile.

A few days ago, Dep. U. S. Marshall took one Joe Hall, Violation Parole, 3 yrs Leavenworth to Ft. Worth, where he is at present. This Hall says he was raised with Barrow, knew him in West Dallas, and that given 30 days time, could locate him. This Hall turned himself up, is a doper and wants to go to Leavenworth for treatment. Says that if he could go up there for a year, and not the three, could be cured, and that if he is promised those two years off, will go to West Dallas for the D. J. or any other Law Enforcement Agency and put Barrow on the spot. That he doesn't want any information about him to get out and that his part must not get out. The Deputy Marshall, Stanley, Tyler, says that this fellow turned himself in, and that he believes that he believes that he knows Barrow as well as he says he does and thinks that this Hall is on the square about putting Barrow on the spot.

Am working the roads about Tyler, especially the road to Gladewater.

SAILLEY TYNES, confidential informant, has reported after having gone to Henry Barrow's home and filling station on Sunday night, April 22, 1934, where he has remained until the present time, that Mrs. Barrow has been to Corsicana, Texas, twice since Saturday, April 14, 1934, for the purpose of trying to contact Clyde Barrow, but has failed.

That Mrs. Maggie Ferris, Raymond Hamilton's sister whose purse and baby's clothes were recovered near Orange, Texas, and referred to by Special Agent Arterberry in a memorandum, was at the Barrow Filling Station on April 23, 1934, and informed Henry Barrow, Clyde Barrow's father, that she returned home Saturday night, April 21, and was immediately arrested by the members of the Sheriff's Department in Dallas, and that she had told the officers she had been off trying to meet Raymond Hamilton but had not been able to contact him; that old man Barrow said, "Damn it, don't be telling them that - they will be trying to follow us." Old man Barrow stated to Mrs. Barrow, in informant's presence, "We had better break away from that Hamilton bunch as Raymond is going to turn up and squeal."

There is an old man by the name of Edmonds or Emmons, who is evidently a relay for communications between Clyde Barrow and his parents. On the afternoon of April 23 he came by the filling station and stated: "I am going over to town and see if there is any news." One of the relatives, Charlie Walker, who has heretofore been reported to live at Rouse, Texas, now resides in Grapeland, Houston County, Texas.

Mrs. Cunie Barrow and her sister, Mrs. Bell Briggs, are planning a trip to Coarse, Texas, one day this week.

Informant further stated an oil truck from East Texas delivered gasoline to the Barrow Filling Station while he was there and that this truck bears Texas Commercial License #47571. (The reference on this license number is being checked through the State Highway Department). He also stated a V-8 Ford Coupe - he thinks it was a Ford - bearing Texas license 231-377, driven by a "fat lady" came by the Barrow Filling Station on the afternoon of April 23, 1934, and stated she would be back some time in the afternoon as soon as she could hear how Steve Davis, (Raymond and Floyd Hamilton's step-father) and Floyd Hamilton, (Raymond's brother) came out in their habeas corpus hearing at Austin, Texas. This license is also being checked.

On April 24, 1934, informant reported that on the night of April 23, 1934, Henry Barrow got drunk and said he had been trying to get in touch with Clyde Barrow for two weeks, without success, and that he and Mrs. Barrow were worried sick over not being able to hear from Clyde, and that was why he was drinking so much whiskey; that he had sent two boys on Sunday, April 22, 1934, to Kilgore, Texas to try and contact Clyde Barrow, and these boys were to return immediately if they were unsuccessful but they have not returned to date.

Henry Barrow also said that Clyde Barrow has friends at San Augustine, Texas; that Clyde made these friends several years ago when he rented a car in Dallas to take his girl, Ebbie Williams, to see her folks in San Augustine County; that Clyde did not bring the car back at the proper time and a complaint was filed against him and he was arrested; that old man Barrow stated Clyde and Ebbie would have married but her folks objected; that Ebbie is now employed as a stenographer in one of Dallas' larger stores; that Mr. Barrow also said that Clyde may be down there in San Augustine County with those people and is afraid to come out while all the officers were watching for him so closely.

Informant further stated that on the night of April 23, 1934, Mr. Barrow said Maggie (Maggie Ferris, Raymond Hamilton's sister) said she and Mary (Mary O'Dare, alias Mary Chambliss, alias Mary Pitts) had been all last week away from Dallas trying to get in touch with Raymond but Raymond had failed to meet them at the appointed place; that Maggie stated Raymond has become a hop head and is using narcotics to excess.

Informant further stated that about midnight, April 23, 1934, someone knocked on the station door and Mrs. Barrow got up; that her niece, a daughter of Bell Briggs, was at the door and said to Mrs. Barrow, "My God, Aunt Cummie, Rose (Ambrose Linthicum) has killed Jake Johnson"; that Mrs. Barrow said "Where is he?" That the girl said "Here, in the car." That Mrs. Barrow said, "Bring him on in"; that Ambrose came in and Mrs. Barrow put her arms around him and said "What have you done?" That Ambrose replied, "I killed that damn Jake Johnson - I cut the (blank) all to pieces. Clark called Johnson out and I hid by the door in the dark and when Johnson came out I cut him all to pieces." That Ambrose was about drunk; that after Ambrose got in the house with Clark they went into another room and the Barrows began calling hospitals in Dallas by telephone inquiring as to whether Jake Johnson had been brought in and whether or not he was dead or merely injured; that they eventually learned by these telephone calls that Johnson had been cut and 14 stitches had been used in putting him together, at the Emergency Hospital.

Clark and Ambrose spent the night at the Barrow Station and residence and were still there at 11: AM, April 24, 1934, when the informant left; that Ambrose stated he had tried to kill Johnson because he had been down to the City Hall stealing on Clyde, and that he hoped he had killed him; that if he hadn't done so he would the next time he saw him.

(Bailey Tynes was paid \$23.50, covering 5 days employment @ \$4.00 per day, and \$3.50 for a round trip ticket from Waco to Dallas, Texas.)

The writer interviewed Informant "B" who stated that since Friday last, April 20th, Old man Barrow leaves his premises about 11 o'clock each day in a Model T Ford coupe driven by a young man about 18 years of age, the car goes West on Eagle Ford Road and does not return for about an hour and one half to two hours. Old man Barrow also meets a tough looking man over 30 years of age, Black hair, about 5 feet 11 inches tall, weighing about 170 lbs, three or four times a day, that this tough looking man takes the bus after talking to old man Barrow.

Informant B also states that old lady Barrow nearly every day during different intervals takes the bus to town and remains a short while returning to the service station. Informant B advises that he has a room which gives him a clear view of the Barrow place, and usually during the day hangs out in the small cafe. He has noticed that the police and sheriff's office cars are very active, that they circle the Barrow place 3 and 4 our times a days. On Sunday, he noticed Bill Decker and three other deputy sheriffs speed to the place at about 45 miles an hour and cut down to about 10 miles per hour when they cruise around and pick up persons for questioning. He states the police do likewise, that Detective Goss and his tall partner are frequently in the vicinity, that due to this activity things around the Barrow place are tight, as the sheriff and police cars are readily noticed.

Informant B suggests that inasmuch as persons are being picked up for questioning, that he likewise be picked up by police officers who are known in the vicinity of the Barrows, in order that he might not be suspected of hanging around with special privileges.

Captain W. E. Wyatt, Special Agent for the Ft. Worth Office Denver 47 informed the writer that he received information on several different occasions from W. J. Morrison, a railroad man living at 1628 Collins Street, Wichita Falls, Texas that his wife Lillian Morrison in the past ~~two or three~~ years has been receiving telephone calls from Clyde Barrow, when the latter was passing through or stopping at Wichita Falls, Texas, making inquiry for Mrs. Morrison's sister, a former sweetheart of Clyde Barrow.

Mrs. Morrison's sister, whose name is Grace Donegan was located by Captain Wickman of the State Highway Patrol, and in his presence interviewed by the writer at 406 Travis Street, Wichita Falls, Texas.

Grace Donegan stated she is 27 years of age, that her mother Mrs. Virginia Alexander and father, C. C. Alexander reside at 1109 Third Street, Wichita Falls, that in 1926 she married Mackell Donegan and separated from him in 1928. At the request of her cousin, Ruby Anderson she went to Dallas, Texas after separating from her husband and lived with her cousin on William Street, that shortly after her arrival she obtained employment with the Brown Cracker Candy Company, that one day while she and her cousin were in Kate's Sandwich shop corner Avenue, Dallas, she made the acquaintance of Clyde Barrow, who at the time was employed across the street from the sandwich shop with the United Glass Company. She stated she kept company with Clyde Barrow for about eight months, and during that time visited with his mother and father and family who lived in a small shack on old Eagle Ford Road, that subsequently the family moved to the premises where the Star service station is located, there being one gasoline pump outside with a shed, the small wooden building containing three rooms, that she met Jack Barrow, L. C. Barrow, Buck Barrow (deceased) and also visited Clyde's sister Mrs. Artie Winkler, a beauty parlor operator, who had the shop in her home. She stated that ~~xxxxxxx~~ one time she stayed at old lady Barrow's place for about a month, made trips with Mrs. Artie Winkler, Mrs. Henry Barrow, Clyde's mother to relatives of Mrs. Barrow located at Kaufman, Texas. At the time she made the acquaintance of Clyde, she stated that he had an old Buick touring car, which he claimed to have traded in for a brand new Ford coupe which they used in making trips with him from Dallas, Texas to the home of her parents at Wichita Falls, Texas. She also stated that one Frank Alms, a freckled face boy is an intimate friend of Clyde's and can be found almost anytime hanging around the Barrow filling station. Also that Clyde, in addition to his sister Mrs. Artie Winkler, has two other sisters, viz Marie, about 18 years old, and Nell about 27, the latter being a beauty operator, who at one time worked at the Red Hat Beauty shop, Dallas.

Wichita Falls, Texas

after going with Clyde for about 8 months, she came back to Wichita Falls at the request of her mother, and at the insistence of her husband joined him in San Angelo, Texas, that while there she became ill and before going to the hospital for an operation was treated by a doctor who was responsible for her becoming a ~~maxx~~ morphine addict. While at San Angelo, Texas, she stated that Clyde Barrow learned of her whereabouts from her sister Mrs. Morrison at Wichita Falls, Texas and called on her persuading her to leave with him, which she refused to do. She finally returned with her husband to Wichita Falls, in 1932 and since that time, Clyde Barrow when passing through or stopping at Wichita Falls, would call up her sister Mrs. Morrison on the latter's telephone No. 81229 giving a fictitious name making inquiry as to where one Grace Donegan could be located, and the information invariably would be furnished to Clyde. Grace Donegan stated that the last time she talked to Clyde Barrow was about a year ago, when she and her husband for a while lived on a farm, 10 miles north of Henrietta, Texas, ~~that~~ the farm being owned by Jim Mc Carry. At the time Clyde was accompanied in a sedan car by ~~two~~ another man whom she describes as about 6 feet tall, and weighing about 170 lbs, that at the time she noticed the back seat of the car loaded with guns and ammunition. Clyde tried to get her to leave her husband and go with him, but she refused to do so. She claims that she does not know Bonnie Barker, Raymond Hamilton, Mary Chambliss or Eloye Hamilton, that shortly before the two highway patrolmen were killed at Grapevine, Texas, she noticed Clyde Barrow with another person in a Ford Coach near her home, that she did not know whether ~~max~~ the other party was a man or a woman, because it was just after getting dark.

According to Grace Donegan, the Barrows formerly lived at Ennis, Texas, and she and Clyde made a number of trips to Ennis to see some of his friends there. She also stated that whenever she goes to Dallas, she calls in to see old lady Barrow who is fond of her that whenever she goes there she is received with open arms, and Mrs. Barrow usually cries whenever they meet. The last time she visited Mrs. Barrow was about a year ago. At the time she inquired for Clyde, but Mrs. Barrow did not make an immediate answer because some folks came into the place. Prior to that visit, Mrs. Barrow told her that Clyde was in Missouri.

Grace Donegan insists that she can contact Clyde Barrow, who she claims is "crazy" about her, that to do so, all she has to do is to make a trip to Dallas, call on old lady Barrow, and stay with her for a while, that contacts are usually made through others and the family and Mrs. Barrow meet Clyde away from the station on the road.

Chief of Police Dick Morris advised me that Grace Donegan is well known to him, that she is classed as a dope head, but has never been arrested as such, that Grace Donegan at one time was considered a "classy prostitute" who has never been known to solicit men on the streets, but has lived with men at Wichita Falls, that one of the lawyers at Wichita Falls, who was disbarred, and a number of criminals and underworld characters have been known to also live with her. Her husband ~~has~~ the reputation of being a "dope head". Mary Donegan has no criminal record, although arrested several times for disturbing the peace. There is no photo or fingerprints of her.

At the present time Grace Donagan is confined to her bed on account of illness but states that she will probably be up and around again in the next few days. She further stated that she has a number of photographs of herself and Clyde Barrow, in a cedar chest that is now stored in her mother's home. She admitted being on morphine for a time, but stated that she has not taken any for some time. Chief Morris stated that Grace when not on morphine goes out on parties and get "liquored up" that the last time he was obliged to have her placed in the hospital. However, he believes that she might be used to advantage as an informant in locating Clyde Barrow.

Undoubtedly Grace Donagan appears to have been close to Clyde Barrow, his family and relatives, and might be used to good advantage as a confidential informant in this case if arrangements can be made to pay her for her services.

MEMORANDUM TO S.A.C. BLAKE:

Re: CLYDE BARRON, w.a.; et al.
Fedl. Motor Vehicle Theft Act.

At about 2:40 P.M., April 25, 1934, the First National Bank at Lewisville, Texas - some 25 miles North of Dallas - was held up and robbed of some \$514.00. Within ten minutes after the robbery the information was broadcast by the Dallas Police Department Radio. Just at the beginning of the first broadcast, Capt. E.V. Bunch of the Detective Division, Dallas Police Department, called the Dallas Division Office and stated that the bank had been robbed by one man who was small in stature, eyes close together, blond hair, roughly dressed. The description fitted that of Raymond Hamilton, who was assisted in escaping from the Eastham Prison Farm on January 10, 1934, by Subjects Clyde Barrow and Bonnie Parker.

The broadcast disclosed, also, that the car used in the robbery of the Lewisville Bank had been driven by a second man, but no description of him was obtainable.

Capt. Bunch stated that a police squad was then leaving the station to go to the scene of the robbery, and that all State and County Officers in Denton County were on the highways; that the robbers had headed toward Lake Dallas, which is North of Lewisville, on the Dallas-Gainesville Highway. As this highway runs through the City of Denton, which is the county seat of Denton County, in which Lewisville, Texas is located, Special Agent in Charge F.J. Blake and this Agent proceeded East on the Greenville Road out of Dallas in Division Plymouth Sedan, equipped with a short wave radio, and after proceeding a few miles Northeast of Dallas on the Greenville Highway, a broadcast was received which indicated that subject Hamilton had turned West, and Agents proceeded to cut across to the Sherman Highway.

During this drive the information was broadcast that the robber had been definitely identified from photograph, as Raymond

Hamilton, and knowing that Mary O'Dare - his woman companion - and he had been trying to get in touch with each other and that her home is in Wichita Falls, Texas, Agents proceeded to Greer and traveled over the Northwest Highway. However, a broadcast was subsequently received that Hamilton and his companion were seen traveling on a country road toward Van Alstyne, Texas. Agents then cut across to the Denton Road with the hopes of cutting him off at Gainesville, Texas, in case he eluded the officers further East, as some 20 miles North of Dallas heavy rains had fallen and it was almost impossible for anyone to drive on the country roads.

Shortly after Agents' arrival at Gainesville, it was learned that Hamilton had been stopped at Howe, Texas, some nine miles South of the City of Sherman, Texas.

Agents proceeded to Sherman, and during the night interviewed Hamilton in his cell in the Grayson County Jail at Sherman, and he declined to make any statement which would involve Clyde Barrow or to give any information which would possibly assist in the location of Clyde Barrow and Bonnie Parker.

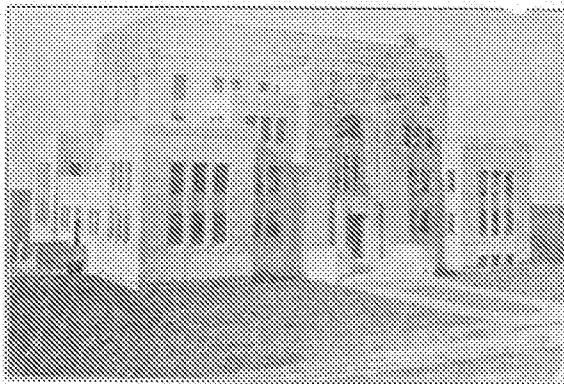

MEMORANDUM TO S.A.C. BLAKE:

Complying with your request to interview Chief of Police Gus Cothran of Paris, Texas, who are advised that a strange woman had been residing at the Gibraltar Hotel in Paris, Texas, who might in all probability be impersonating a Federal Narcotic Agent.

Chief of Police Gus Cothran advised the writer that the manager of the Gibraltar Hotel had discussed a guest with him who gave her name as Billie Hampton, registering from Dallas, Texas; that she acted rather strangely about the hotel; that one day this woman would be a decided blond and on another occasion she would be a decided brunette. Information was had at the Gibraltar Hotel at Paris that Billie Hampton, who appeared to be between 30 and 35 years of age, 5' 8", 155 pounds, dark eyes, heavy build, registered at the said hotel on the evening of April 5, 1934, and was assigned to room 309; that when she registered it was noted that her hair was decidedly blond; that she checked out on the morning of the 6th and it was noted that her hair was exceedingly dark; that she left town advising that she was going to Whitesboro, Texas; that she returned on April 7, 1934, and again registered, and was assigned to room 309, and when she would pay her bill she would demand a receipt for her room rent; that this woman returned again to Paris, Texas on April 12, 1934, and was assigned to room 610; that it was again noted when she arrived that she was a decided blond, and when she checked out the day following it was noted that her hair was very black and that she was wearing dark-colored glasses.

Charles Shelton, Manager of the Gibraltar Hotel, Paris, Texas, advised the writer that he attempted to engage this person in conversation but that he could elicit no information as to her business in Paris; that she spent a large portion of her time sitting in the lobby of the hotel reading a newspaper or a magazine, and at no time was it noted that she had any company or associates.

No information could be had with reference to this person's activities, and Chief Cothran advised that when he called the Dallas Division Office with reference to same, he thought possibly she might be a contact woman for Raymond Hamilton or Clyde Barrow. Also, that he had thought she probably might be a narcotic undercover agent of some sort, but in either event he thought the Dallas Office should have the information.

An anonymous telephone call was received May 4 from a woman who refused to give her name or address, but stated that Bonnie Parker was in a family way and would be probably found in the maternity home for unfortunate girls which is being advertised daily in the Wichita Falls morning newspaper. It appeared more like a joke to me. However, I recall that Jimmy Lambert told me that Bonnie Parker is now pregnant, so I contacted Captain Fred Hickman. He likewise told me that the Bureau informed him that Bonnie Parker was some six or seven months pregnant, and inasmuch as Barrow's activities had apparently ceased for the past month, there might be something to it. We got a morning edition of the Wichita Falls Times and found the following advertisement, "MATERNITY HOME for unfortunate girls. Room and board reasonable. Post Office Box 608, Wichita Falls, Texas." Postmaster O. P. Marielle informed me that Box 608 in the new post office was rented June 1933 by one Mary Holme, giving her address as 906 Bayler Street, Wichita Falls, that the records reveal that she previously had box 40 at the old post office. The references on the application are Dr. Welford and Judge R. E. Taylor. He stated that Dr. E. W. Welford is City Health Physician, and bears a pretty good reputation that R. E. Taylor is a member of the law firm of Taylor, Lane and Taylor, Waggoner Building, Wichita Falls, and is United States Attorney for the Northern District of Texas under section. Postmaster Marielle stated that Taylor's reputation is as murderers, bank robbers, holdups etc., and also had appeared as a defendant in a number of sensational blackmail cases at Wichita Falls, Texas.

Through interviews with Captain Fred Hickman, Dick Morris, Chief of Police and G. Robertson, Chief of Detectives, the writer was advised that R. E. Taylor, who lives at Henrietta, Texas has two daughters Mildred and Roberts, both of whom bear shady reputations and have a questionable apartment No. 1, located at 1102 Grace Street, Wichita Falls, Texas, where underworld characters are entertained and cool off. Captain Hickman states that the apartment is now under surveillance of his men because of the associations of the Taylor girls with Roy Cozart of Muskogee, Texas, and J. L. (Pat) Pipes, King and racketeer who has been arrested numerous times at Wichita Falls and served several county jail sentences, also it is known that when Pipes is wanted, he will disappear, and has been known to have been located in the Taylor girls apartment pending arrangements for bail etc. Cozart was suspected with Fred Rogers in the Kretzschmar bank job, and according to Captain Hickman is a close friend of Mary O'Dare. J. L. (Pat) Pipes lives at the American Hotel, where Mary O'Dare can also be usually found or contacted.

Chief of Detectives Robertson states that Mary Holme is a product of Henrietta, Texas where she was a prostitute, and brought to Henrietta by R. E. Taylor, who used her in blackmail cases, that he Robertson knows her well, and states that she will do anything for money. The house she is now living in, according to Robertson is a large one with about ten or more rooms, and is used by Mary Holme principally for abortion cases, that Doctor John E. Vicks, who has been known to treat underworld characters performs the abortions for \$85.00. Chief of Detectives Robertson further stated that there is no law in Texas against operating a home such as Mrs. Mary Holme advertises as "Maternity Home for unfortunate girls" and with Judge R. E. Taylor as her attorney a number of persons in Wichita Falls have been blackmailed by them. At one time Johnnie Groggs, notorious Wichita Falls racketeer, ex convict and "king-pin bootlegger" lived with Mary Holme. Robertson

states that the introduction was through Judge E. E. Taylor, that Mary Malone provided to Mary Ann, and after getting practically all of his money directly and through attempted blackmail, Jeanette Skaggs finally left Mary Malone, and is now running a place on Henrietta Road, Wichita Falls, Texas.

Postmaster Maricle informed me that sometime ago a committee called on him to see what could be done to get rid of Mary Malone. Chief of Police Morris stated that he has watched the place from time to time, and satisfied himself that liquor was not being sold there, and the "blind advertisement" appearing in the morning paper as referred to above was something new to him. He states however, that he is satisfied that with Mary Malone's connection with E. E. Taylor, they would not hesitate to shield Bonnie Parker or any other criminal.

Captain Fred Wickman and Chief Morris stated that 906 Taylor Street would be watched and discreet inquiries made concerning it with a view of capturing Bonnie Parker, should she go there, or perhaps be there at the present time, and Clyde Barrow. In this connection, it is suggested that Mary O'Dare, who is now at Dallas be discreetly interviewed to determine from her whether she has definite knowledge that Bonnie Parker is now in a family way.

He said that today his landlord, friend of Mr. Barrow, Clyde's father, named Brewer, had returned from Shawnee, Oklahoma, saying that he had left his daughter there in a hospital suffering from Typhoid Fever. Hayes says that he doubts that Brewer has been to Shawnee at all. That Brewer told him formerly upon leaving Dallas to see this daughter that he was going to Tulsa to see his daughter who was suffering from an acute appendicitis.

Immediately upon reaching Dallas Brewer requested Hayes today to make a short trip with him. Hayes says that he accompanied Brewer, and that Brewer carried with him a package about 3 feet long and 2 feet deep and 2 feet wide, wrapped in a pair of blankets. Brewer drove his 1929 model Chevrolet sedan. They went first to the filling station of old man Barrow, where Hayes says that Brewer stopped for a few minutes to talk privately with the old Barrow. That Brewer got some water - no more than a pint - for his radiator, and gave Hayes this as his reason for going to the Barrow filling station. Hayes says that he could not hear anything that Brewer said to the older Barrow, nor could he hear Barrow. The two - Hayes and Brewer - then proceeded to a red brick house out the Lemmon Ave. Pike, located about three-quarters of a mile past the Northwest Highway, (right side road,) where Brewer pulled up in the driveway of said house which is the only house in that vicinity, and which is surrounded by a bunch of white-looking wild flowers, and parked there for 6 minutes. Upon arriving there Brewer pulled out his watch and said "She isn't due here until 6:00 PM, and it is now 12 minutes until then." Hayes said that the party that Brewer was looking for was a woman, who appeared at about 5:50 PM, driving a model-A Ford, (Hayes did not know number of license), in company with two other women. Brewer then got out of the car (his Chevrolet) and took the package into the house, where he stayed for a few minutes, talking in such a manner that Hayes did not overhear anything. Hayes could give no further description of the woman Brewer took this package for other than that she is about 35 years old, and that she is said to work at the Mercantile National Bank, Dallas, Texas.

Hayes says that Brewer told this woman that his daughter was sick with Typhoid Fever at Shawnee, Oklahoma, and that he told her that he had only one daughter, whereas Brewer had told Hayes prior to this time that he had a daughter about an hour's distance from the Brewer home in West Dallas, and frequently left the house supposedly to see this daughter.

Hayes says that it is his opinion that Brewer is lying about his daughter's being sick in Shawnee, and that he has possibly been trying to contact Clyde Barrow. Hayes reports that he has not gained Brewer's full confidence, but is able to watch him pretty closely without being suspected.

Hayes says that the elder Brewer claims to have a son in Denton, Texas, who also is supposed to have made the trip to Oklahoma to see Brewer's sick daughter. That Brewer told Hayes his son left Denton with some friends in a V-8 Ford Coupe to make the trip to Oklahoma to see the sick girl.

Hayes says that he will report to you regularly.

The writer made inquiry for Gene Wagner through the Postmaster, Mr. A. H. Richardson, Electra, Texas, but the latter did not seem to know Gene Wagner except to say that he might be the son of Mack Wagner, who operates a barber shop on Bryant Street, and considered a very fine citizen.

I contacted Mack Wagner, who stated that his son was at home, No. 103 N. DuBar Street, Electra, Texas.

At the above named address, the writer located Gene Wagner, who admitted writing letters to the Division at Washington and to the Dallas Division Office offering his services in locating Clyde Barrow and Raymond Hamilton.

In this connection, Gene Wagner stated that he is an ex-convict, that he was sentenced to two years for burglary from Sweetwater, Texas and served his sentence on Mathias farm No. 2, commencing November 2, 1922 and ending September 7, 1924, that he also received a sentence of 45 years for highway robbery from Chickasha, Oklahoma, and served in the Granite Reformatory under No. 4990 from 1925 being discharged on April 1, 1930, that he has been associated in his criminal activities with Elmer Larcuse and S. B. Fish, both now serving time at Jefferson City, Mo., that he has engaged in numerous hi-jacking and high-way robbery jobs, all of which are now outlawed, that on April 1, 1930 he was paroled from the Reformatory at Granite, Okla. and in the event he violated such parole he would be obliged to do the balance of 20 years, unexpired sentence, that for the sake of his aged parents he decided to go straight, and notwithstanding the fact that he is known as "Blackie" air-tight, and has numerous contacts, principally at Dallas, Texas with ex-convicts and "tugs", he desired to be of some assistance to the Government, hoping that by reason thereof, he will eventually be able to secure a full pardon instead of his present parole.

Gene Wagner stated that he has had connections with Albert Head, Dewey Head, George Burnett, Dunlay, Ray Henderson, Jack Wells, Jack Cooper and "Blackie" Wilson, all of Dallas, that he knows Matt and George Rives, Ray Terrell, the latter three now being in the penitentiary, that he is also well acquainted with hideouts of criminals in Arkansas, Oklahoma and Texas, inasmuch as his activities have been principally confined to these three states. He also states that he knows Valney Davis and Alvin Karpis, that they have been known to contact at Moffitt Oklahoma through an Indian named Red Cloud Fleetwood, and cool off at a place located at Van Buren, Arkansas, that Pretty Boy Floyd formerly worked at Electra for old man Henry Haynes, and married a niece of Tom Templeton, formerly of Electra, Wagner believes that Floyd, like Ray Terrell and Blackie Thompson would cool off at Signal Hill, Texas located near Berger, Texas, where numerous outlaws and criminals have in the past gone in hiding.

He further stated that Elar and Wolf at Fort Worth, Texas is known as one of the best places to dispose of and secure arms and ammunition, that he has disposed of a number of revolvers and pistols together with watches at that place, that no record is made of the same, and when it becomes necessary to purchase machine guns etc. all that is necessary to say is "I am not wanting to sign my name"

and they will understand that they can do business. Gene Wagner states that his introduction to Eiler and Wolf was through Clyde Barrow, who took him to Fort Worth and arranged for the same through another, that this was in 1933 or 1934, when Clyde was nothing but a "punk kid" and petty larceny burglar.

Gene Wagner states that through his connections at Dallas, particularly West Dallas, he feels absolutely confident that he can place "Clyde Barrow" on the spot within thirty days, and besides turn up some good underworld information re jobs etc and assist in locating fugitives and hideouts.

From my talk and observation of Gene Wagner, he impresses me very much. He is about thirty years of age, undoubtedly has had plenty of experience in his particular line, appears to have numerous underworld contacts and sources of information, and besides is a rather intelligent type of criminal.

It is suggested that you interview him some place at Dallas, as I am inclined to believe he has the makings of a good confidential informant for the Dallas Division office.

Gene Wagner stated that he does not believe that anyone at Alcatraz knows of his unfortunate life of crime, that for the sake of his parents who are highly regarded at Alcatraz he requested that as the matter be treated strictly confidential. I have therefore refrained from making any inquiries concerning him or his parents, except to ask the postmaster if there was any such person as Gene Wagner residing at Alcatraz, Texas, in order to get a line on them he might be, before interviewing him.

Floyd -

On April 16th was at Ft Smith, Ark., and his wife is in hospital there. He was reported to have visited her. His hair is died yellow and is wearing shell rim glasses. Ansell Woodard of Muldrow, Oklahoma, is reported to be assisting Barrow in communicating with his wife, etc. Floyd's hide out is reported to be in the hills east of Muldrow, Oklahoma.

Barrow -

Is reported to have a hide out on the Leon River in Hamilton County near Jonesboro. Joe Morgan, who has served a term in State penitentiary and is supposed to be a farmer in Erath County is helping Barrow. Morgan is supposed to have a farm and house in that vicinity that citizens say is haunted and that is used as a hide out for Barrow and those assisting him. My informer states that you will have no difficulty in locating this place as all citizens around there know of the place. A man by the name of Stone in Erath County is assisting Barrow. One by the name of Raymond Woods, one mile from Hemo, Texas, is also helping him and one by the name of Hankins at or near Walnut Springs, Texas, is a part of his crowd.

(The man giving this information stated that he was a former Federal Agent and asked if I knew whether the Department of Justice had any information concerning the activities of some local officer in assisting Barrow. When he learned that I did not he would not give any information. Said if he received any further information that might assist he would report it either to this office or the D J office in Dallas.

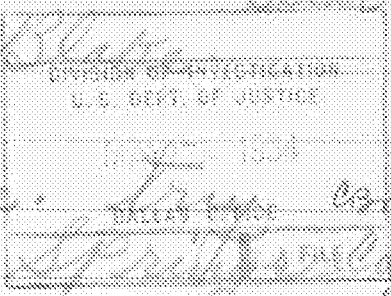

Henry Hayes reported to this office in person. Hayes said that he spent last night (Saturday) with one Mullins, owner of the Varsity Riding Stables (Hayes first said Vista Stables) located at 2728 Milton Ave., Dallas.

Hayes said that Mullins told him that about two months ago three men, respectively, Lake, Williams, and Lee, and a woman living with Lake as his wife, rented from him (Mullins) his stables, horses, and whole outfit, and set up a bootleg outfit there.

That shortly after the above arrangement Clyde Barrow and Bonnie Parker came out to the stables and stayed there (all this was about two months ago, says Hayes), for several days. Mullins told Hayes that Clyde gave Mullins \$50.00 (two twenties and a ten dollar bill) and told him that if he mentioned seeing Clyde or Bonnie, he would kill him. Mullins also told Hayes that Clyde held Mullins at the stables and would not let him leave. Mullins told Hayes that he (Mullins) promised to give Clyde five hundred dollars (\$500.00) to retrace the agreement on renting the stables, and to leave immediately. Mullins told Hayes that the woman known as Mrs. Lake acted as a go-between, and took money from Mullins to Clyde Barrow. Mullins stated to Hayes that he was nearly crazy from fear of Clyde.

Hayes further reported that Mullins told him that the woman known as Mrs. Lake, was out to the Varsity Stables Friday in a V-8 Coach, and was to collect another payment of the \$500.00 tomorrow (Monday) 5/7/34, from Mullins at 10:00 AM, at some office building, the name of which was not known to Hayes. Hayes said that Mullins said that the money would go from the woman to Clyde Barrow.

Hayes further stated that he had an appointment with Mullins tomorrow morning at 7:00 AM, in which Mullins was supposed to give him all the details of the arrangement between Mullins and the woman known as Mrs. Lake as to place of delivering the remainder of the \$500.00 which Mullins had promised to Clyde, Lake, Williams, Lee.

Hayes said that he would report the outcome of the meeting between him (Hayes) and Mullins to take place at 7:00 in the morning, to you immediately.

Mr. P.H. McCray, one of the owners of the United Glass & Mirror Company, located at 2614 Swiss Avenue, Dallas, Texas, stated that CLYDE BARROW worked for him when he was just a boy and that Clyde does not call him on the phone every time he is in this vicinity, but has on two recent occasions, called him by 'phone; that Clyde called him one evening when he was supposed to be surrounded in Louisiana - about two or three weeks ago - as nearly as he could recall; that Barrow did not say who was calling but he recognized his voice and that at that time Clyde asked, "Pat, has a boy by the name of Ray been by there?" That in the neighborhood of the same time, he believes just after that other call, Clyde called him by long distance from, as he understood the operator, Johnson City, Missouri, and asked, "Pat, has that boy Ray been by there?"

Mr. McCray stated that on both occasions he informed Barrow that no one by the name of Ray had been by to see him; that he tried to contact City Detectives Dean Cass and Bob Abbott when he received this second call but they were not in. Subsequent to that time he has talked to these two detectives about this matter and has promised them if he ever hears from Clyde Barrow again he will immediately notify either them or Capt. Bunch; that at the request of Detectives Cass and Abbott he called on Mrs. Omie Barrow last Friday a week ago, in the evening - April 27, 1934 - and in talking with her asked her if she had heard recently from Clyde, and she stated she had not and probably she would not hear from him again for about two or three months; that Mrs. Barrow has confidence in him (McCray), and he informed her that should she ever care to communicate with Clyde through him, not to hesitate to do so. She stated she would call on him if she ever required his good offices.

He further stated he went by to see Mrs. Barrow Saturday evening - May 5 - but she was not in, and Clyde's father, Henry Barrow, said Mrs. Barrow had gone to Nacogdoches, Texas, to visit

her sister but would be back Sunday, that is, she hoped to be back Sunday as she feared something might happen around Dallas concerning Clyde and she wanted to be here; that she had gone down with some friend who was also going toward Nacogoches to visit, and the friend stated he might not be back before Monday, May 7, 1934.

Mr. McCrey is fearful that it might become public that he is endeavoring to get information as to the whereabouts of Clyde Barrow, and upon being assured that there was no danger of this confidential information being divulged to anyone, he took the Dallas Office 'phone number and S.A.C. Blake's name, and stated that should he again hear from Barrow by 'phone or otherwise, he will immediately notify the Dallas Division Office.

* * * * *

On May 4, 1934, Agent interviewed RAYMOND HAMILTON at the County Jail in Dallas, and Raymond stated that if he ever had an opportunity, he would kill Clyde Barrow; that he, of course, knows how Barrow could be contacted but he would not divulge this information to any officer - even to save himself from the electric chair; that after he and Clyde separated at Terre Haute, Indiana, he met Clyde on the highway about a week before Easter Sunday, April 1, 1934, at a lunch stand at Decatur, Texas; that Clyde asked him at that time when they were going to join up again and he told Clyde that they were never going to join again.

It appears from other information at hand that Barrow goes through Decatur very often in his ramblings about the country and that he meets his friends and relatives between Rhome and Paradise, Texas on country highways quite often. When a meeting between him and his relatives has been arranged and Clyde arrives at Rhome in advance of the others he drives out to the school West of the town and turns to the left. This is high ground and from this point of vantage he can see every car which turns off of the highway at Rhome to come West toward the school around one side of which runs the road which leads to Boyd and Paradise, Texas.

It will also be noted in Agent Dowd's memorandum of April 19, 1934 (Serial 50), that Joe Chambliss and Beulah Preter, about April 2, 1934, drove in a taxi cab to Sunset, Texas from Wichita Falls, Texas, where they picked up Joe's car and then drove to Beulah's sister's home, Tillie Hudson, East of the town of Decatur, Texas.

Raymond Hamilton denied that he was implicated in the burglary of the National Guard Armory in Dallas, Texas, but stated that he believed he knew who the persons were who did burglarize the Armory; that he has understood that the firing pins had been removed from the automatic rifles which were stolen, and if that is the case, the rifles would then be useless to the person who has them and that he is endeavoring to get in touch with such persons and have them put the rifles where they may be recovered, but that he would not disclose the identity of the persons he suspects.

NOTE: It is Agent's opinion that he has divulged his suspicions to some member of the Sheriff's Department at Dallas.

He further stated that he still has four of the automatic pistols which were stolen when he and Clyde Barrow and others burglarized the Ranger, Texas, Armory, and that he has sent word to the person who has the four pistols, to put them at some place where he can notify an Agent from the Dallas Division Office they may be recovered.

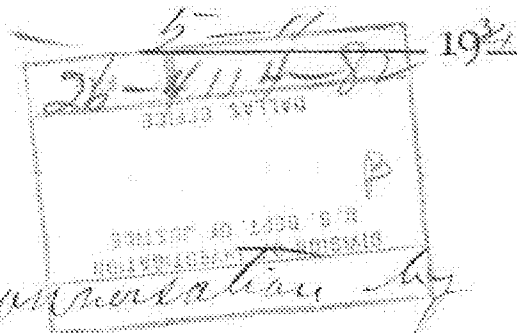

Informant states that about 6.30 PM Saturday evening May 12th, Bonnie's brother, _____ Parker, age about 23 yrs, came to the Barrow home and introduced me to him. He remained until 9 PM and held secret conversations with Mrs. Barrow, ~~_____~~ Informant learned from young Parker that he had just arrived from Gladwater on the bus. Mrs. Barrow told Parker the laws were hot after him, and he decided to wait until after dark before leaving. On leaving Henry Barrow gave Park a ten dollar bill, expense money

After young Parker left, Mrs. Barrow called informant into the kitchen She stated that she would not confide in any of her people, but that since he had shown so much interest in coming down and having implicit faith in him, she was going to tell him that she was going to see Clyde and Bonnie this week one one night down in Navarro County at Jim's. (Barrow has an Uncle Jim living out from Corsicana) She stated that she wanted me to see Frank Hardy of Waco (Clyde's hang-out at Waco and former Prisoner with Clyde at the Pen) and tell him to be at her home by Monday if possible, She did not say why she wanted ~~_____~~ to see Hardy about.

Mrs. Barrow told informant Joe Hills and her daughter, Maria, were going to take her down to see Clyde. Joe Hills drives a Chevrolet Coach about 1922 Model, bluish-green color. Joe Hills Description; Age about 20 years; Ht. 5 ft 7 or 8' Wgt. 150 or 160 lbs. Hair Black, eyes Dark; Comp. Med. Generally dresses in Blue pants and white shirt, does not wear a hat. Maria Barrow; Description Age 16, Ht. 5ft 2 in. Wgt. 115 Or 120 lbs; Blt. chunky; Hair Red (bob) eyes blue Comp. Buddy; Wears blue dress also has a yellow suit with a brown jacket also yellow hat.

Informant was unable to secure license number on the Hills car.

Mrs. Barrow stated she made a trip ^{with Joe Hills} to Naogdoches on May 5th did not say who took her, and went to Martineville to her Sister, Mrs. Jim Muckroye and stated she had seen Clyde, she would not admit where this contact took place, but from her conversation he decided she contacted Clyde at Dee Brown's farm about 3 1/2 miles west of Martineville. She said Bonnie was well and hearty and as sweet as she ever was, that Clyde has a new suit and Bonnie is nicely dressed and have plenty of money. Mrs. Barrow would not admit that Clyde had given her any money, but Henry Barrow had a large roll of money on his person last night and this morning, and gave Mrs. Barrow a roll of money to take care for him.

Mrs. Barrow stated to informant that if he ever goes to Glenn Rose to go out to a tourist park on the high way west of Glenn Rose and that he would know it since the different camp houses bore the names of States and a little creek runs through the town and past the camp. Said to get in contact with a stocky man, red headed and red face who stays around the camp, and to tell him that informant was Clyde's cousin and if he refused to believe it to have him phone her at her expense and that he would take care of him and that he was a good friend of hers and Clyde and Bonnie who had stopped at the camp. She said some farmer had reported seeing Clyde and Bonnie and that they drove into the camp and this man at the camp changed license plates for them and hid them in the park.

Informant stated that about noon yesterday May 12th, Al Meddows was at the Barrow filling station and they were talking about machine guns and Informant told him he would like to get a machine gun. After Henry Barrow told him Informant was O.K. he stated Clyde does not have a machine gun and inquired why he wanted one, said Clyde had automatic rifles and stated he had three and that he and Roy Pannell own them together and that they were Government property and were not supposed to own them and that he had the numbers removed from the guns, that he would sell one of the guns for \$20. Two guns for \$60. and deliver them to his home. Said they had them wrapped in quilts and were buried in the ground. He did not state where he got these guns. He stated there were no clips for the guns or ammunition. Roy Pannell was present during the conversation above. He wanted to deliver these guns to the Informant last night (Saturday) Informant told them he would first have to arrange for the money and put them off; that they preferred Informant to come for the guns and that they would accompany him to Waco with the guns but that no definite arrangements had been made.

Informant inquired of Henry Barrow after the above individuals left, about the guns and asked him if they were any good, that Barrow stated yes that Clyde and a bunch of them had robbed the Armory hall at Banger and that Clyde has one of the guns

Memorandum submitted by Special Agent E. J. Doug

Reference letter from SAC Blake dated April 18, 1934,
addressed to the writer re Mrs. Jack Boone, recently of Amarillo, Texas.

I interviewed Chief of Police Mc Dowell and Clark Cain,
Chief of Detectives, both of whom conferred sometime ago with Mrs. Jack Boone,
who gave them to understand that she possibly might be able to secure information
at Pampa, Texas through a certain contact with whom, nothing definite being obtained
from her. After the conference, Clark Cain stated that he wrote to the Dallas
Division office regarding the matter. Since then, he states that Mrs. Jack Boone
left Amarillo with her baby, and stated that she was going to visit her mother
at Howell, New Mexico.

The writer recalls locating sometime ago Mrs. Jack Boone
in company with Mr. Jack Stewart at Pampa, Texas in connection with a violation
of the National Motor Vehicle Theft Act. Their husbands were convicted of hi-jacking
at Dalahoon, Texas, and enroute to Pampa, Texas, they stopped off and called on a
finance company stating that if a reward and expenses was paid to them, they would
locate a certain stolen automobile in New Mexico. We have a file on the matter
in the Dallas Division office.

I was not at all impressed with Mrs. Jack Boone or Mrs.
Jack Stewart at the time, and do not believe they have or can secure any information
in whereabouts of Clyde Barron or Jennie Parker. It seems that Mrs. Jack Boone
told Clark Mc Dowell and Clark Cain at Amarillo, Texas that they heard of a certain
contact with at Pampa, Texas.

It is well known at Pampa, Texas, that the contact man for
Clyde Barron and Raymond Hamilton, was old man Joe Chamberlain, father of Mary O'Boon
Chamberlain, whom old man Chamberlain operated the notorious REX Hotel at Pampa over
a year or two ago, and at which time his son (Bill) Chamberlain was arrested at
Pampa by Constable Frank Jordan. The latter is a wide-awake officer, who has
numerous contacts at Pampa, and when I saw him sometime ago he told me that since
old man Joe Chamberlain left Pampa, neither Clyde Barron or Raymond Hamilton have not
been known to visit Pampa or contact anyone there.

MEMORANDUM TO S.A.C. BLAKE.

Re: CLYDE BARROW, FUGITIVE, et al,
K.M.V.F.A.

In response to a telephone call from Mr. H.E. Spafford, attorney-at-law, 818 Kirby Building, the writer interviewed him at his office on May 21, 1934. Mr. Spafford advised that he wanted the interview kept strictly confidential; that his information with reference to this matter was obtained from a client, named Bert Forehand, who now resides on a farm near Ferris, Texas; that Mr. Forehand was, in his opinion, on Saturday, May 19, 1934, attending to some legal matters and during his visit someone mentioned the name of Clyde Barrow and Bonnie Parker, whereupon Mr. Forehand remarked that they could be apprehended if the officers in his part of the country were not afraid of them; that Mr. Forehand further advised him that Mrs. E.E. (Mary) Sparkman, is his mother-in-law, and resides on a farm located between Ferris, and Ennis, Texas; that his father-in-law, E.E. Sparkman, died about two years ago and that Mr. Forehand also looked after her legal matters.

That several years ago the Barrow family resided on the Sparkman Farm located between Ferris and Ennis, Texas, and that the Forehands, Sparkmans and Barrows were well acquainted with each other; that Mr. Forehand advised him that it was a well known fact in his community, that not many weeks ago Clyde Barrow brought Bonnie Parker to Ennis, Texas for medical treatment, but that he had been unable to secure the name of the doctor with whom they visited; that it was a well known fact in Ennis, Texas that Bonnie Parker was at the present time in a pregnant condition and that since this visit this doctor in Ennis had on several occasions recently left Ennis, Texas by automobile for some unknown destination and that it was the consensus of opinion that this doctor was calling on Bonnie Parker and rendering her medical aid.

Mr. Spafford advised further that he rather insisted on Mr. Forehand that he tell him the name of this physician who was treating Bonnie Parker, but that he declared he did not know his name at this time but that an investigator could find out at Ennis, Texas.

Mr. Spafford further advised that he asked Mr. Forehand directly, to give him the source of his information relative to Bonnie Parker's delicate condition and her being treated by the Ennis physician, but Mr. Forehand only told him that it was a well known fact in Ennis and that if he cared to know more of the details he could find out in Ennis for himself; that he was deathly afraid of the Barrows, and that he firmly believed that should any member of the Barrow Family suspect that he (Forehand), an old acquaintance, was giving this information, that same would be fatal to him and his entire family.

Mr. Spafford further stated that he had known Mr. Forehand for a number of years; that he was at one time in the drug business in Dallas, Texas and was now trying to operate a farm at Ferris, Texas but that like all other farmers at the present time was having financial difficulties in making it a go but that he considered Mr. Forehand a truthful and honorable farmer and that since this information came from Mr. Forehand he felt as a citizen who stood for law enforcement, that the above information should be given to the Division of Investigation for their attention.
