1. You will recall from the special briefing you received in closed session during the Annual Management Meeting concerning subject case that the speaker from CI Staff asked that no notes be taken. He had also requested that no communication be sent to the field describing his interests because of the sensitivity of the subject matter. He had hoped by this briefing to augment the flow of information on certain subjects but we have observed since this meeting that the reverse situation has been the case. There appears to be some confusion on the part of the Field Chiefs as to the manner in which information of this nature should be submitted. Thus we would like to remind you that there are now five categories of groups which are of interest. They are the black militants, radical student and youth groups, radical antiwar groups, radical underground press and draft evasion/deserter support movements and groups.

3. CI's interest is primarily to ascertain the details, if any, of any foreign involvement/support/guidance/training/funding or exploitation of the above groups and movements, particularly through coverage of the foreign travel, contacts and activities of the Americans involved.

4. With respect to your relationship concerning the above with the local office of the FBI, the following ground rules should be observed:

a. Operational leads which are exploitable abroad and/or which may involve travel or contacts abroad should be sent to Headquarters only. Any necessary coordination with the FBI will take place through Headquarters liaison.

b. All other information on these subjects may be passed to the FBI locally at your discretion. Please continue to send information copies to Headquarters, however, responsive to this case.

5. In all cases, please indicate whether the source is also reporting to the FBI and, if not, whether the information may be passed to the Bureau with the source's identity.

6. It will obviously be necessary for you to brief selected members of your Office, especially the [REDACTED] and [REDACTED] who have accounts with a potential to report in these fields, in order that they will know how to forward such information should it be brought to their attention. Staff employees only should be briefed. Please advise headquarters as to the identity of those individuals whom you plan to brief.


