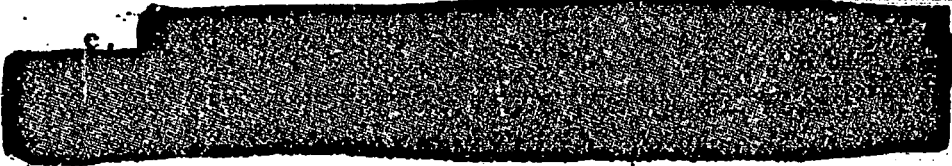

c. Teletype 001, dated 30 May 1971, entitled "Black Panther Party (BPP), Cleaver Faction, Racial Matters." Requests information concerning movements and whereabouts of the following Black Panthers: Eldridge CLEAVER, Kathleen CLEAVER, [REDACTED]

d. Washington, D.C., memorandum, dated 8 May 1972, entitled "Extremist Photograph Album, Extremist Matters." Requests information on a continuing basis concerning foreign travel of individuals who are included in the Extremist Photograph Album. (As of December 1972 the album covers about 925 persons.)

3. Travel to North Vietnam, North Korea, China, Cuba:

a. Washington, D.C., memorandum, dated 14 July 1972, entitled "Travel Control Legislation (NI)." Requests continued receipt on quarterly basis of travel listings of U.S. citizens traveling to North Vietnam, North Korea and the People's Republic of China.

b. Washington, D.C., memorandum, dated 19 March 1973, entitled "Travel of United States Citizens to the People's Republic of China (CI-2)." Advised that this office may limit our reporting of United States citizens traveling to the People's Republic of China essentially to persons and groups associated with organizations in which the FBI has separately expressed a specific interest in receiving foreign intelligence information or on which they may express such an interest in the future.

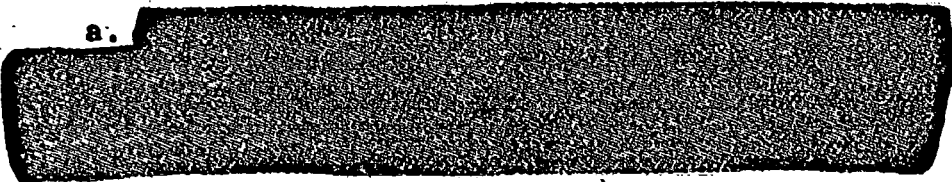

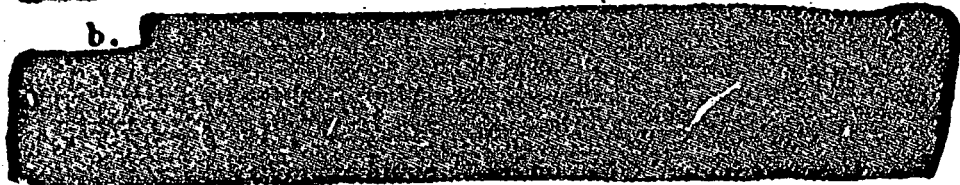

**5. Pro-Chinese Communist Organizations:**

a. Washington, D.C., memorandum, dated 1 February 1973, entitled "The Communist League." Requests any information relating to the activities of the Communist League (CL) abroad, including hostile contacts and activities which relate to the CL, especially in reference to Communist China and pro-Chinese Communist Marxist-Leninist parties of other nations.

b. Washington, D.C., memorandum, dated 1 February 1973, entitled "I Wor Kuen." Requests any information concerning hostile contacts and activities abroad which relate to the I Wor Kuen (IWK), especially where Communist nations are involved.

c. Washington, D.C., memorandum, dated 1 February 1973, entitled "October League." Requests information relating to the activities of the October League (OL) abroad, including hostile contacts and activities which relate to the OL, especially in reference to Communist China and pro-Chicom Marxist-Leninist parties of other nations.

d. Washington, D.C., memorandum, dated 1 February 1973, entitled "Revolutionary Union." Requests any information concerning hostile contacts and activities abroad which relate to the Revolutionary Union (RU), especially where Communist nations are involved.

6. Puerto Rican Groups:

\* a. Puerto Rican Revolutionary Workers Organization - Washington, D.C., memorandum, dated 29 January 1973, entitled "Puerto Rican Revolutionary Workers Organization." Requests any information concerning hostile contacts abroad relating to the Puerto Rican Revolutionary Workers Organization (PRRWO), especially involvement with Cubans or Chinese Communists.

\* b. Puerto Rican Socialist Party - Washington, D.C., memorandum, dated 29 January 1973, entitled "Puerto Rican Socialist Party." Requests information concerning hostile contacts and activities abroad which relate to the Puerto Rican Socialist Party.

7. Chicanos:

\* a. Chicano Extremists - Washington, D.C., memorandum, dated 28 January 1972, entitled "Request for Evaluation of Information (NL)." Requests reports concerning contacts abroad between Mexican leftists and individuals associated with guerrilla groups in Mexico.

b. Mexican-American Militancy - Washington, D.C., memorandum, dated 19 June 1973, entitled "Mexican-American Militancy." Requests any information concerning contacts, exploitation, support or encouragement by Cuba, North Korea, North Vietnam, Communist China, the Soviet Union, Latin American extremists or Arab fedayeen organizations of militant Mexican-American organizations or individuals, with particular attention given to any information bearing on statutory violations of U.S. laws over which the FBI has jurisdiction.

8. Venceremos Brigade:

a. Washington, D.C., memorandum, dated 22 January 1973, entitled "Venceremos Brigade." Requests any information on foreign travel of former Venceremos Brigade (VB) participants and their

hostile contacts and activities abroad, especially involvement with Cubans, Chinese Communists, Soviets, North Vietnamese, North Koreans and representatives of the Provisional Revolutionary Government of South Vietnam.

9. Institute for Policy Studies:

\* a. Washington, D.C., memorandum, dated 26 January 1973, entitled "Institute for Policy Studies (IPS)." Requests information concerning hostile contacts and activities of persons connected with IPS, especially with the Cubans, Chinese Communists, Soviets, North Vietnamese, North Koreans and representatives of the Provisional Revolutionary Government of South Vietnam or any foreign revolutionary organizations.

b. Washington, D.C., memorandum, dated 15 December 1972, entitled "Institute for Policy Studies." Requests any information concerning the establishment of a European Center of the Institute for Policy Studies.

10. Miscellany:

\* a. Deserter Support - Washington, D.C., memorandum, dated 17 January 1973, entitled "Up From Exile, Stockholm, Sweden." Requests information on the involvement of any foreign countries or foreign subversive organizations and their influence on American deserter-draft resister groups and individuals.

\* b. Vietnam Veterans Against the War - Washington, D.C., memorandum, dated 23 January 1973, entitled "Vietnam Veterans Against the War (VVAV)." Requests information on foreign travel of VVAV members and their contacts with representatives

of hostile nations or representatives of foreign revolutionary organizations. Also requests information concerning tactical or guerrilla training afforded by VVAW to foreign revolutionary organizations and concerning funding of VVAW by hostile countries or foreign revolutionary organizations.

\* c. Peoples Coalition for Peace and Justice - Washington, D.C., memorandum, dated 23 January 1973, entitled "Peoples Coalition for Peace and Justice (PCPJ)." Requests information concerning travel abroad by PCPJ members, during which contact is made with representatives of hostile countries. Also requests reporting on the travel of PCPJ delegations to South Vietnam, as well as details of activities and contacts of delegation members in South Vietnam. Additionally requested is information concerning funding of the PCPJ by representatives of hostile nations or foreign revolutionary organizations.

\* d. Progressive Labor Party - Washington, D.C., memorandum, dated 1 February 1973, entitled "Progressive Labor Party." Requests any information concerning the activities of the Progressive Labor Party (PLP) abroad, including hostile contacts and activities which relate to the PLP, especially, in reference to Communist China and pro-Chicom Marxist-Leninist parties of other nations,

e. Jewish Defense League - Washington, D.C., memorandum, dated 1 February 1973, entitled "Jewish Defense League." Requests any information concerning the activities of the Jewish Defense League (JDL) abroad, including hostile contacts with elements promoting anti-Soviet and anti-Arab causes.

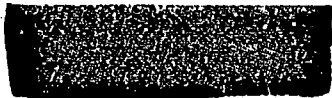

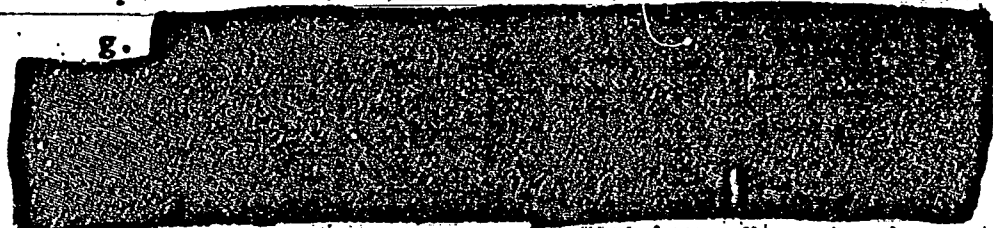
