OPERATION RESISTANCE

I. ORGANIZATION

1. A Special Unit shall be organized within the Special Activities Division to assure maximum support to Operation RESISTANCE.

2. [REDACTED] shall be assigned to this Unit by elements of the Office of Security to provide expert review and analysis of materials concerning the following general areas functioning in the D.C. and other areas:

- (a) Black Power, Maoist and Trotskyite and left-deviationist organizations and personalities
- (b) Communist Party, USA. and Communist-front organizations and personalities; popular front or united front movements strongly infiltrated or dominated by the CPUSA
- (c) The New Left, pacifist and extremist organizations not included in (a) and (b), above.

3. The aforementioned categories shall be flexible and subject to change or amendment as determined by the Chiefs, SRS and DDS/ICS.

4. SR & CD shall provide [REDACTED] to assure proper integration of acquired research materials and full exploitation of SR&CD holdings.

5. Additional [REDACTED] shall be assigned as required by the Director of Security.



II. MISSION

1. The Special Unit shall serve as an internal review, analysis and target unit to provide the Chief, Security Research Staff with such adequate and timely information as is deemed necessary to protect the physical integrity of the Agency, its domestic installations and its domestic activities in order that he may provide the Director of Security current reports.

2. The Special Unit shall consist of experienced security officers qualified to review and analyze on a continuing basis information from local and federal agencies, the media and other sources; to provide concise summaries of such information on a current basis; and to prepare estimates of potential threats to Agency installations and domestic activities in support of Operation MERRIMACK.

III OPERATIONS

Input - Input for the Special Unit shall consist of reports and materials on domestic movements and personalities offering a potential for disrupting the domestic activities of the Agency and threatening the physical integrity of its domestic installations. Such source materials should include, but not be limited to, reports of the Federal Bureau of Investigation, the Department of Defense and its subordinate commands, appropriate federal agencies, local and state police authorities, media and special sources.

Processing - It shall be the responsibility of the Special Unit to collect, review and analyze the input materials concerning the target activities and personalities; to schedule and receive additional requirements in the absence of sufficient information in desired areas; to develop an adequate data base for continuing exploitation.

Output - The Special Unit will prepare current and adequate reports and analysis of input materials for the use of the

Chief, Security Research Staff in order to provide the Director of Security, the Deputy Directorates and Staffs current estimates of potential threats to the domestic activities and physical integrity of the Agency; will insure prompt integration of input data into Security indices and records.

There will be three categories of reports:
