E. SESSION SUMMARY:

The target personality whose <sup>first</sup> name initially surfaced as John, is a middle-aged male who has or had a family. The name "De Vito" may be associated with the family or with this case.

Target personality is a sort of "middle-man" involved in illegal contraband activities. On the one hand he works for "higher-up" employers while maintaining a net of employees that he uses.

He is a sort of a "swell individual" and planner of activities.

Some agency, possibly the FBI, has set up or is desirous of setting up a white-collar crime investigation against him.

It is anticipated that he will "pass money to banks in Ohio, possibly Cleveland. He is believed to be withholding "company money."

He is currently located in California; however, he moves up and down the coast. He has contacts in Oregon and in the state of Washington. He is involved with a subsidiary company (and passes himself off as a business man).

He is an American of hispanic and possibly oriental ethnic origin.

The concept of an "itinerary" possibly associated with expressions "LENTEL" (phonetic) ~~in Ohio~~, surfaced as being related to Ohio.

The expressions "Blue Duck" / "Bleaches" surfaced phonetically but their significance could not be determined.

The name "Fowler" phonetically surfaced during this session.

The "Italians" were perceived as being involved in his activities.

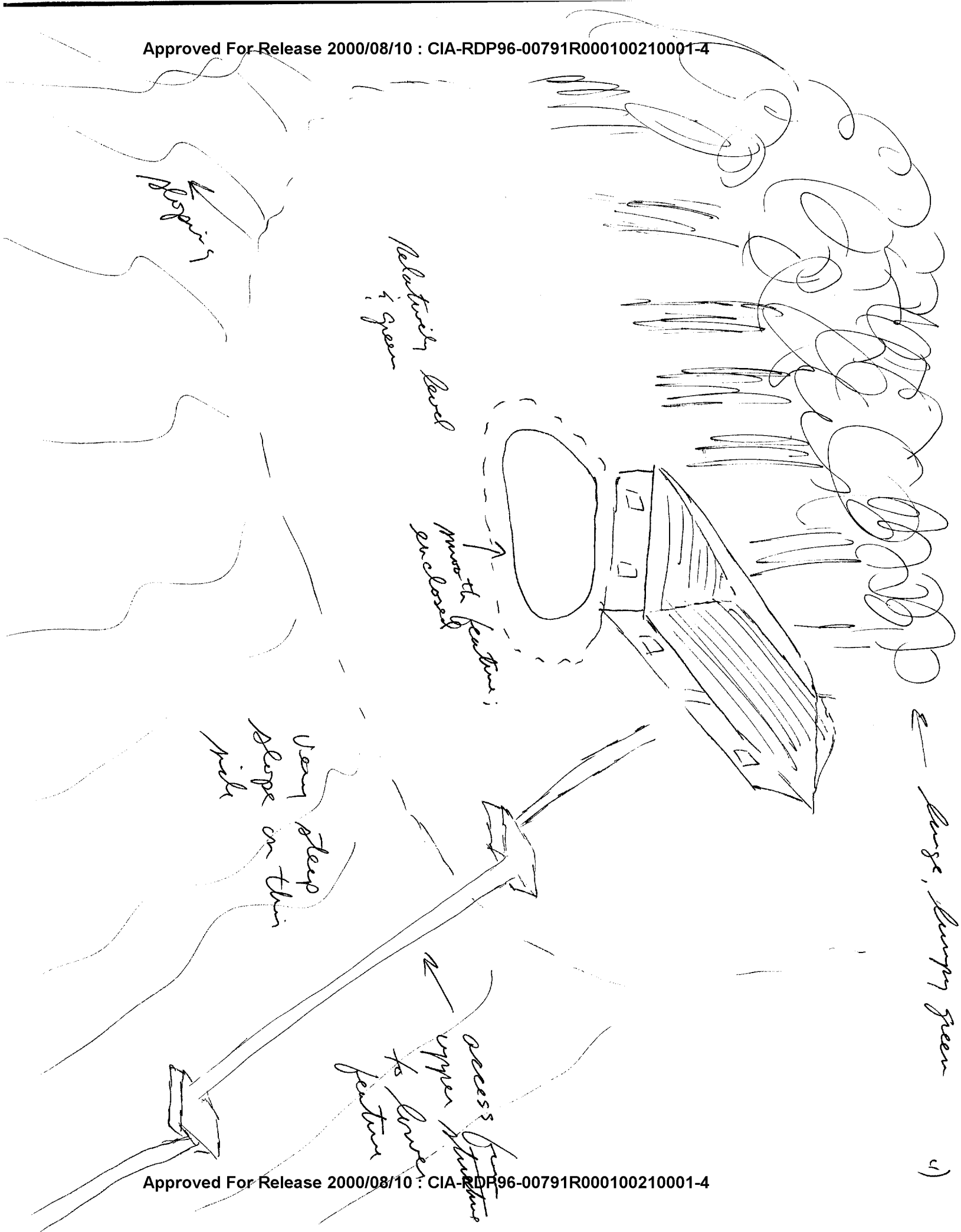

E. SESSION SUMMARY:

Impression that target is in hiding, within an isolated location. He is associated with a structure which sits on a flattened hill or ledge with thick vegetation (trees) along one side. This is a level, green area on 3 sides; a smooth feature enclosed by a barrier or parameter of manmade origin. This sits on one end of the large structure. A thin, long and angular feature allows access from the structure down to another manmade feature. This latter feature sits either near, or within, dark blue water.

Target has use of location, but someone else may own it, or also uses it. Target is hiding from more than one group or organization (factions). Impression that he never returned to vessel after leaving, it somewhere <sup>along west coast</sup> in Central America. Impression that the stuff was picked up, but target became aware of interest in the operation. Vessel with cargo is currently "in holding" somewhere else.

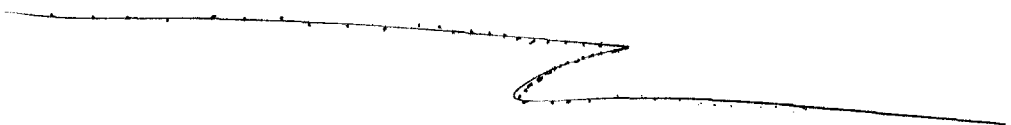


PT - jet base: handbook for flight
