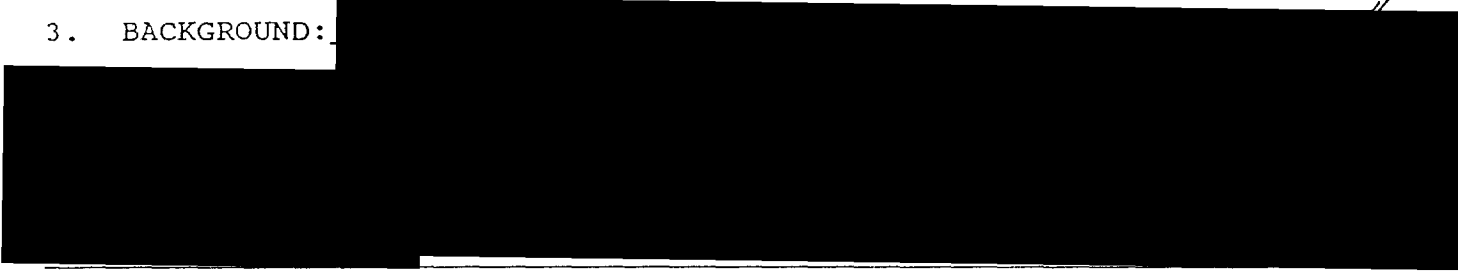

The target personality is a highly intelligent man with a dark complexion; he resides in Mexico City (currently). He is seen as a shrewd, intelligent business man and admired in his community. However, he can be lethal and dangerous; he is believed to be affiliated with a (drug) cartel. He is making a lot of money. There is a strong impression that he is being surveilled. In answer to the query, yes he is undoubtedly involved in narcotics trafficking.

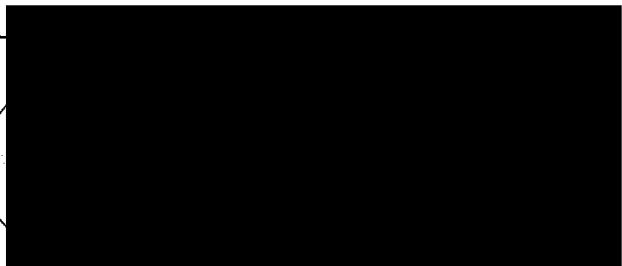

E. SESSION SUMMARY:

I could not perceive any current narrow activity w/ either personality or target vessel. I did perceive several attributes or features associated with the vessel (see diagrams).

The personality has had some specialized training that dealt with rigid discipline; reminiscent of ex military. The vessel has been used for research or exploration off shore. The personality has a vivid imagination; looks at things as though "looking at a crystal glass" (?). The concept of "disfigurement" is real related to him - family, crew, etc.

The vessel has a sense of being a sailing ship with 4 large sails. However, overhead it it appears to have a ~~flag~~ feature reminiscent of a "super structure" ala freighter (see page two of notes). Twice, an association with animals was perceived; the second time dealt with turtle like animals.

There is not ~~because~~ wood shipping with water. This "wood" is reminiscent of a "figure head" → (over)
