E. SESSION SUMMARY:

Session #1: see diagrams pages 1, 4 & 5 of fixture & objects.

Immediate impression is that vessel is smuggling animal parts, or products from animal parts. The items are smooth, sleek, fast and water oriented. Objects reminiscent of wooden poles or "fules" are used in their activity. Kept seeing the concept of "~~the~~" "eyes". Some items have a soft pouch or pouch. A soft container, ~~and~~ ~~base~~, not like a box or a crate, is used to store these "pouches". This concept of containers was recurring.

Session #2: concept of "floating traps" (see page 1). A bearded man with reddish or light brown hair - this is out of character with rest of crew. There is a man pulling on something, which is resisting. The activity involves the use of lights. Concept of under water; gently circulating movement of water (abyssinian = gentle). Can see sand from bottom being lifted up & redeposited. There are objects reminiscent of air tanks. There is a movement reminiscent of a marine tube worm while feeding, i.e. sucking in, filtering, then expelling.

There is a hollow tube with a square-shaped feature on one end (see page 5). This "square" feature is used to grasp hold of. This tube is its actum is reminiscent of the sand for under water excavation or exploration.

Activity has to do with some sort of work either conducted under water, or closely associated with water. The activity is associated with the ~~same~~ concepts of "ripping up", "tearing apart" - these actions result in a lot of cloudiness or murkiness. Objects are moving rapidly underwater.

Concept of "capture" or "taking". End result is costly.

Vessel is currently involved with illegal activity of interest.

The crew is very suspicious. One particular individual who wears a turban or khafia is especially suspicious - always looking over his shoulder. He has a particularly good ability <sup>(sense)</sup> in spotting people / activities which are interested in vessel's activity.

Objects or material is are placed within a hold - this particular hold contains a liquid ~~to~~ into which a number of things are put into.

The nature of the activity is capture & collection. It is brutal! There is a real array of different types of ~~to~~ living things; some are dead, some are only parts.

There is another illegal aspect to this target which is more significant. Small, hard objects are involved. I sense that ~~living things~~ ~~to~~ living things are put into a liquid to kill them ~~to~~ & / or to process them. (Processing of material is for resale; entire process is illegal.)

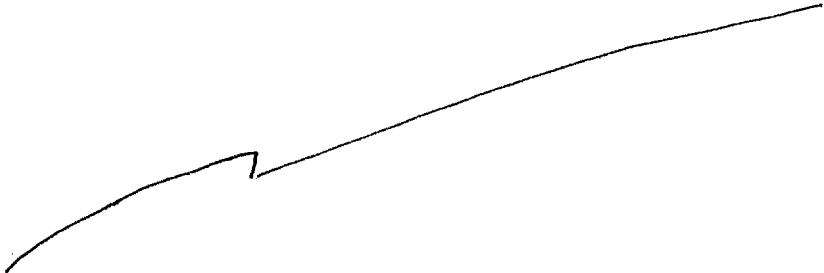
