WHEN THE SUBJECT MADE NEN GRAPHY (THOUGHT-GRAPHY) ON THE FACE PLATE OF VIDICON TUBE IN T. V. DURING THE INTERVAL WHICH THE PSI SPOTS ARE DISPLAYING FROM APPEARANCE TO DISAPPEARANCE.
